As this will be a formal meeting of the Council's Planning Committee there will not be an open session for members of the public to address the Committee. If you would like to speak at the meeting you must submit a request to do so as a deputation. As this is a special meeting of the Committee the usual deputation rules have been extended to allow deputations a maximum of 30 minutes. If we receive requests for more than one deputation(either for or against the recommendation) these will need to be combined, with the deputees agreeing how they wish to allocate the time provided. The Planning Committee will be held in the Olivier Theatre at Nightingale Academy. This venue has a maximum seating capacity of 200. However, arrangements have been made to provide an overflow facility in the assembly hall directly opposite the theatre, which will have a live video/audio link of the meeting. The hall also has a seating capacity of 200. Both venues are fully accessible for those with mobility difficulties.
