1. EXECUTIVE SUMMARY

- 1.1** The purpose of this report is to inform Members of the current position regarding the Council's 2008 to 2013 capital programme taking into account the latest monitoring information on the progress of schemes. It also reports the current position in respect of the prudential indicators approved by Council on the 27th February 2008.
- 1.2** The report shows that overall expenditure is projected to be £416.6m compared with the programme reported after the first quarter of £392.7m, an increase of £23.9m. The increase largely refers to the approval to new capital projects since the July report and the effect of additional earmarked resources notified to the Council (see section 4). The report also provides details of physical progress and service implications for major schemes in the programme (see Appendix B).
- 1.3** The report provides information on the capital resources available including the latest asset disposals position.
- 1.4** The revised capital expenditure forecast impacts on a number of the prudential indicator estimates over the period of the programme and these are reported in Section 8. There are no changes recommended to the indicators at this stage. As a matter of good financial management, the indicators for 2009/10 onwards will be reviewed as part of the 2009/10 budget and review of the medium term financial plan.
- 1.5** Finally the report advises that the Council is continuing to operate within its treasury management indicators.

2. RECOMMENDATIONS

It is recommended that Cabinet:

2.1 Notes:

- (i) the outcome of the second quarter's capital monitoring and review exercise for the current year; and
- (ii) the position regarding the Council's prudential indicators and that no revisions to the indicators are required at this stage although the indicators for 2009/10 onwards will need to be reviewed as part of the 2009/10 budget process and review of the medium term financial plan.

2.2 Confirms the addition to the capital programme of further earmarked resources totalling £3.6m;

2.3 Agrees that new capital projects totalling £19.6m included in the updated capital programme are reported to full Council.

3. BACKGROUND

3.1 The Council's capital programme is reviewed and monitored monthly and monitoring reports are submitted to Cabinet quarterly. This is the second quarterly report for 2008/09. The Prudential Code for Capital Finance requires that the forward-looking prudential indicators, set by the authority, be regularly monitored during the year; these are included in section 7 of the report. The position in relation to borrowing and investments is monitored on a regular basis in accordance with best practice.

4. ADDITIONS TO THE EXISTING CAPITAL PROGRAMME

4.1 Following a detailed review of the programme, a number of changes to the total level and profiling of planned expenditure have been identified. In particular, this refers to the inclusion in the programme of new schemes approved since the first quarter monitor; these are set out below:

- 4.2** Each of the above schemes involves expenditure that is in excess of £0.5m and therefore need to be reported to the next meeting of full Council for inclusion in the capital programme. The ongoing revenue implications of these schemes are being addressed through the 2009/10 budget process and review of the medium term financial plan.
- 4.3** In addition, the Council has been notified of further earmarked capital funding of £3,608k. This refers to the following specific capital spending areas:

- 4.4** Approval to individual projects to be funded from the above earmarked resources will be subject to the Council's normal reporting arrangements.

5. SUMMARY OF TOTAL MOVEMENT IN THE CAPITAL PROGRAMME

- 5.1** Table 3 below summarises the overall movement in the capital programme. This reflects the additional schemes and resources noted above and the re-profiling of expenditure provisions taking into account progress in scheme delivery.

5.2 Further details of the total movement for each departmental programme are provided below.

Note 1: Earmarked Resources refer to specific grants and contributions provided by central government and other external bodies, earmarked capital receipts, specific revenue contributions from service departments and specific earmarked reserves.

Note 2: General Resources refer to capital receipts (not earmarked to specific purposes), borrowing and the use the General Fund Capital Reserve)

5.3 Education, Children's Services and Leisure (Increase in expenditure £13,836k)

This variance reflects the recognition in the capital programme of the following additional items:

- Cabinet approval on 10th September to the acquisition of a site for a new academy in eastern Enfield (£9,000k) and improvements to the Millfield Complex (£2,560k);
- Expenditure provision to be funded from additional grant receipts for City Learning Centres (£300k) and under the Fair Play Pathfinder capital programme (£2,146k) – part of the latter allocation will provide to additional funding for the Florence Hayes Centre with the remainder subject to further consideration;
- Increased cost of Chace School improvements (£275k) to be funded from a contribution from the school's resources;
- Transfer of funding from ESS (£200k) toward the additional cost of the Florence Hayes Centre;
- The inclusion of capitalised IT projects largely funded from the IT Investment fund (£759k)

The revised ECSL programme also reflects the transfer of resources to revenue from the School Condition programme to contribute to the Building Schools for the Future development costs (£966k) and to release revenue funding for the installation and hire of a temporary kitchen for Cuckoo Hall primary school (£337k). A capital bid to replace the School Condition programme funding is being considered as part of the current budget process.

In addition, it is proposed to transfer funding under the Short Break Pathfinder programme to provide additional resources for the refurbishment of the Formont Centre (£145k) – this scheme forms part of the Health and Adult Social Care programme.

5.4 Environment & Street Scene (Increase in expenditure £5,906k)

This variance reflects the recognition in the capital programme of the following additional items:

- Cabinet approval on 8th October to the investment in waste services and the expansion of recycling services on estates (£4,861k);
- Expenditure provision for TfL schemes as a result of additional allocation of funding (£353k);
- Expenditure provision for Automated Number Plate Recognition (ANPR) schemes as a result of funding being provided by the Metropolitan Police (£303k);

- The transfer to the PSE programme of the scheme for street scene improvements to Southgate Circus (£150k);
- The recognition within the ESS capital programme of capitalised IT projects funded from the Investment Fund (£469k) – this refers to Project Chariot.

5.5 Finance & Corporate Resources (Increase in capital expenditure £999k)

The department's capital programme includes capitalised projects that are largely funded from the IT Investment Fund. The movement since July reflects the inclusion of the IT costs identified within the New Ways of Working project (£1,287k).

In addition some projects have been removed from the programme and are being re-considered and re-prioritised by the ICT Board as part of the 2009/10 budget process.

5.6 Health and Adult Social Care (Increase in capital expenditure £765k)

The monitor reflects provision for expenditure funded from additional capital grant allocations that have been notified to the Council. These refer to:

- Social Care IT Infrastructure (£261k);
- Disabled Facilities Grant (£236k); and
- Drug Intervention Measures (£9k).

Provision for the refurbishment of the Formont Centre has been increased by £145k funded from the grant resources within the ECSL programme as part of the Short Break Pathfinders programme. It should be noted that further resources are estimated to be required to progress this project which are subject to consideration as part of the 2009/10 budget and review of the medium term financial plan process.

The monitor also now includes expenditure on approved capital projects within the IT Work Plan (£111k); these projects are funded from the IT Investment Fund.

5.7 Place Shaping & Enterprise incorporating the HRA (Increase in capital expenditure £2,393k)

This variance reflects the recognition in the capital programme of the following additional items:

- Cabinet approval on 8th October to the QE2 Stadium restoration project (£1,200);
- Cabinet approval on 11th September to the New Ways of Working project (£667k) – this refers to the requirement for furniture and premises adaptation works

largely in respect of the Civic Centre to secure the release of existing leased in accommodation – this expenditure is being funded from earmarked reserves;

- Resources in the form of currently held earmarked HRA capital receipts to fund Community Hall improvements (£1,000k) – proposals to utilise this funding are currently being developed;
- Provision for expenditure on conservation projects to be funded from a further allocation of resources from English Heritage (£75k);
- The transfer from the ESS capital programme of the Southgate Circus scheme (£150k);
- Craig Park improvements to be funded from insurance receipts (£158k)

The above increases in expenditure provisions are offset by the following items:

- Savings in project costs identified in the fitting out of Thomas Hardy House (52k) and in the adaptations to the Edmonton Centre to establish the headquarters of Enfield Homes (£190k) - these refers to additional elements of the schemes outside the main construction contracts which are still subject to final settlement;
- The transfer of provision to the ECSL capital programme to support the Florence Hayes Centre development (£200k);
- The transfer of funding within the planned R & M programme to fund the cost of removals in connection with the New Ways of Working project (£190k);
- Provision for regeneration projects within the industrial estates largely funded from external sources no longer required £219k.

The current capital programme includes provisions in respect of the former Property Strategy proposals; these include the re-provision of Carterhatch and Bury Lodge Depots and associated schemes, the review of the non-schools property portfolio and area reviews including Ponders End, Palmers Green and Southgate, Edmonton Green and Angel, and Southgate and Winchmore Hill. The intention for all these proposals was that they would be funded entirely from capital receipts identified as part of the schemes.

At present, the depot re-provision schemes are currently being reviewed in the context of the Council's place shaping programme. As a consequence, the capital programme provisions for the current year for these schemes and the related capital receipts targets have been re-profiled into 2009/10 pending the outcome of this work.

6. PHYSICAL PROGRESS AND SERVICE IMPLICATIONS

- 6.1** As well as the financial aspects of a scheme it is important to look at the effects that any delays or changes have on the completion of schemes and the service implications of any changes to completion dates. Appendix B shows the progress

on major schemes and is flagged with Red (risk of not achieving objective), Amber (possible difficulties) and Green (on target) ratings for both finance and physical progress to highlight any areas of concern.

7. GENERAL FUND CAPITAL RESOURCES

- 7.1 Table 4 below sets out the availability of general resources to fund the General Fund capital programme.

- 7.2 The key issues to note in connection with the above are:

- As highlighted in the budget report to Council in February, there are risks around the achievement of capital receipts targets. The scope for realizing straightforward asset sales is now much reduced. In the current economic circumstances with falling land and property values, it will be necessary to take a longer term view on the timing of disposals to achieve a satisfactory level of receipts. A further detailed report on the disposal programme is due to be considered at the Cabinet meeting in January. The Property Strategy Receipts refer to the target receipts anticipated to be generated from the Depot re-provision programme and the Property Strategy reviews referred to in para 5.7. above. These targets will be reviewed in the context of the Council's place shaping programme.
- Similarly the level of expected usable Right to Buy receipts is much reduced from previous years. The above resources assumes the sale of 20 dwellings per annum over the life of the programme.

- 7.3 The level of borrowing included in the table above reflects the additional requirement needed to fund the new capital projects described in para 4.1. This is also reflected in the prudential indicators set out in section 8 below. While the Council is continuing to operate within the targets for these indicators in the current year, it will be necessary to review them for subsequent years in the context of the additional scheme approvals and the further capital bids being considered as part of the budget process.

8. PRUDENTIAL INDICATORS

8.1 Capital Expenditure Indicators

The latest forecasts of General Fund and HRA capital expenditure, compared to the prudential indicators, are set out in Tables 4 and 5 below.

8.3 Prudential Borrowing Indicators

- a) Authorised limit: The Council is prohibited from borrowing more than its authorised limit. The Council's authorised limit for 2008/09 is £465m, comprising borrowing of £435m and other long-term liabilities of £30m. Borrowing during the first quarter was well within the Council's authorised borrowing limit. The highest level of borrowing during the period was £242m. No new long or short term borrowing was undertaken during the quarter.
- b) Operational boundary: The operational boundary is based on the most likely level of borrowing for the year. The Council's operational boundary for 2008/09 is £325.5m, comprising borrowing of £307m and other long-term liabilities of £18.5m. Occasional breaches of the operational boundary are unlikely to be significant however a sustained or regular trend above the operational boundary would be

significant. During the past quarter the Council's gross borrowing was within the operational boundary.

- c) Net borrowing (i.e. long term borrowing less investments): In the medium term net borrowing should only be used for a capital purpose. Specifically net external borrowing in 2008/09 should not exceed the estimated Capital Financing Requirement for 20010/11; for Enfield this limit is £333.4m. During the last quarter net borrowing was within this estimate. The highest level of net borrowing was £60m in September 2008.

8.4 Treasury Management Indicators

The Council has set a number of treasury management prudential indicators for 2008/09 that place limits on variable and fixed interest rate exposure, maturity structures of borrowing and investments of 1 year or more. Table 8 below sets out these indicators. Throughout the past quarter treasury management activities have been carried out within these limits.

9. REASONS FOR RECOMMENDATIONS

To maintain a prudent view of capital resources available and allow time to review the best possible use of them in the light of Council objectives to finance future capital developments.

10. COMMENTS OF THE DIRECTOR OF FINANCE AND CORPORATE RESOURCES

10.1 Financial Implications

These are contained in the body of the report.

10.2 Legal Implications

Under the Local Government Act 2003 all Council's have a statutory duty to arrange for proper administration of its financial affairs and a fiduciary duty to taxpayers with regards to its use of and accounting for public monies. This report assists in the discharge of those duties.

10.3 Risk Management Implications

The key area of risk noted in the report refers to the delivery of capital receipts from the Asset Disposal Programme and from Right to Buy sales particularly in view of the current economic circumstances. A further report on the disposal programme is due to be considered by Cabinet in January.

11. PUTTING ENFIELD FIRST

- 11.1** The allocation of resources in the current capital programme reflects the Council's aims and objectives as set out in "Putting Enfield First".
- 11.2** The report contributes to objective (5b) – To increase the efficiency, value for money and quality of services through continuous improvement and performance management
