1 LICENSING HISTORY & CURRENT POSITION – THE KINGS HEAD – LN/201100360

- 1.1 This premises has held a premises licence historically.
- 1.2 On 4 May 2010, a new premises licence application which was not subject to any representations, was granted by officers in accordance with delegated powers, naming Urban Inns Ltd as the Premises Licence Holder (PLH).
- 1.3 On 25 August 2010, a transfer of premises licence application which was not subject to any representations, was granted by officers in accordance with delegated powers, naming Alpinecross Ltd as the Premises Licence Holder (PLH).
- 1.4 There have been a number of persons named as the Designated Premises Supervisor (DPS), and the current DPS since 22 October 2019 is Chelsea Dakin. This vary DPS application was not subject to any representations and was granted by officers in accordance with delegated powers.
- 1.5 There have been no review or prosecution action in relation to premises licence LN/201100360.
- 1.6 The Director of Alpinecross Ltd (company number 07210485) is Michael Fallon, he was appointed on 31 March 2010. The company is registered to 4th Floor 4 Tabernacle Street, London, United Kingdom, EC2A 4LU.

1.8 The premises licence is subject to more licensable activities, licence conditions and seasonal variations of timings, which can be seen in the copy of Part A of the premises licence, attached in Annex 1.

2 TEMPORARY EVENT NOTICE (TENs) HISTORY – THE KINGS HEAD:

- 2.1 The following information may be used as a benchmark in recent years for TENs at The Kings Head:
- In 2021, 5 TENs were applied for around the December period, which were not objected to.
- In 2019, 4 TENs were applied for around the December period, which were not objected to.
- In 2018, 4 TENs were applied for around the December period, which were not objected to.
- 2.2 On behalf of The Kings Head, 7 TENs have been applied for in 2022 in total.
- 2.3 In May 2022, a Late TEN was authorised for 3rd to 5th June 2022, extending the hours from 00:30 to 3am. This TEN was not subject to any representation. The applicant was Chelsea Dakin.
- 2.4 NB. A Late TEN is a notice submitted less than 10 working days but more than 5 working days before the day of the event).
- 2.5 On 23 November 2022, a Late TEN was submitted by Chelsea Dakin for 2nd to 4th December 2022, extending the hours from 1am to 3am. As the Police submitted an Objection Notice to this TEN, Chelsea Dakin was issued a Counter Notice and the TEN could not proceed.

3. TENS TO BE CONSIDERED BY THE LICENSING SUB-COMMITTEE – THE KINGS HEAD:

- 3.1 Each of the Responsible Authorities required to be consulted for TENs were consulted in respect of the application, namely the Police and Environmental Health.
- 3.2 On 29 November, a (standard) TEN was submitted by Chelsea Dakin for 18th to 20th December 2022. A Police Objection Notice was received in relation to this application. This TEN is later referred to as TEN2.
- 3.3 On 30 November 2022, a Late TEN was submitted by Chelsea Dakin for 9th to 12th December 2022, extending the hours from 1am to 3am. As a Police Objection Notice was received in relation to this TEN, Chelsea Dakin was issued a Counter Notice and the TEN could not proceed. This TEN is later referred to as TEN1.
- 3.4 On 30 November 2022, a (standard) TEN was submitted by Chelsea Dakin for 21st to 24th December 2022. A Police Objection Notice was received in relation to this application. This TEN is later referred to as TEN3.
- 3.5 On 30 November 20022, a (standard) TEN was submitted by Chelsea Dakin for 27th to 31st December 2022. A Police Objection Notice was received in relation to this application. This TEN is later referred to as TEN4.
- 3.6 On 1 December 2022, a Late TEN was submitted by Chelsea Dakin for 13th to 17th December 2022, extending the hours from 1am to 3am. No objections were received in relation to this TEN.
- 3.7 A copy of the TEN applications, namely TEN1 to TEN4 can be found in Annex 2.
- 3.8 A copy of the Police Objection Notices to TENs, TEN1 to TEN4 can be found in Annex
 3.
- 3.9 A copy of the Counter Notice for TEN1 can be found in Annex 4, as an example.
 - 3.10 The covering email advising Chelsea Dakin of the Police objections can be found in Annex 5.
 - 3.11 Chelsea Dakin responded, requesting the TEN applications be determined by the Licensing Sub-Committee. That response can be found in Annex 6.
- 3.12 Michael Fallon also contacted the Licensing Team, that email can be found in Annex 7 (applies to both premises).
- 3.13 For background purposes, Chelsea Dakin has confirmed that although Part 3 "relevant entertainment" section of the TENs applications has been completed, she does not seek "relevant entertainment" but had inserted information here in instead with regards to the proposed regulated entertainment.

- 3.14 Furthermore, Chelsea Dakin was not aware of the minimum of 24-hour requirement between separate TENs, see Paragraph 7.15 under Section 8 of the Statutory Guidance below. Therefore, the full TENs as per the dates sought in the applications exceed the limits and would need to be amended.
- 3.15 The table below sums up the dates and timing extensions sought by each TEN (The Kings Head), note as the hours are early hours of the evening, practically speaking they follow on from the opening the day before:

4. LICENSING HISTORY & CURRENT POSITION – BAR TAPS – LN/200501647

- 4.1 Premises Licence (LN/200501647) was issued to Michael Fallon on 19 November 2005, following a conversion under the former licensing regime. Michael Fallon remains the PLH to date.
- 4.2 There have been a number of persons named as the Designated Premises Supervisor (DPS), and the current DPS since 22 October 2019 is Lorna Coulston. This vary DPS application was not subject to any representations and was granted by officers in accordance with delegated powers.
- 4.3 On 23 February 2016 the Metropolitan Police Service applied for a Summary Review of Bar Taps Premises Licence under Section 534 of the Licensing Act 2003. The Police believed the premises to be associated with serious crime and disorder, namely an assault had taken place at 1.45am on the premises, earlier in February 2016.
- 4.4 The full Licensing report and minutes can be viewed on the council's website: <u>https://governance.enfield.gov.uk/ieListDocuments.aspx?Cld=217&Mld=9582&</u> <u>Ver=4</u>
- 4.5 The outcome of the final hearing (on 16 March 2016) was that the Licensing Sub-Committee agreed to amend and add conditions to the premises licence. A copy of that Decision Notice is now produced as Annex 8.
- 4.6 No further review applications have been submitted in relation to this premises licence since. No licensing prosecutions have been taken in relation to this premises.
- 4.7 The current premises licence (LN/200501647) permits the following opening and last sale of alcohol times:

5. TEMPORARY EVENT NOTICE (TENs) HISTORY – BAR TAPS:

- 5.1 The following information may be used as a benchmark in recent years for TENs at Bar Taps:
- In 2021, 6 TENs were applied for around the December period, which were not objected to.
- In 2019, 3 TENs were applied for around the December period, which were not objected to.
- In 2018, 6 TENs were applied for around the December period, which were not objected to.
- 5.2 On behalf of Bar Taps, 7 TENs have been applied for in 2022 in total.
- 5.3 In May 2022, a Late TEN was authorised for 3rd to 5th June 2022, extending the hours from 00:30 to 3am. This TEN was not subject to any representation. The applicant was Lorna Coulston.
- 5.4 On 23 November 2022, a Late TEN was submitted by Lorna Coulston for 2nd to 4th December 2022, extending the hours from 1am to 3am. A Police Objection Notice was received in relation to this TEN, Lorna Coulston was issued a Counter Notice and the TEN could not proceed.

6. TENS TO BE CONSIDERED BY THE LICENSING SUB-COMMITTEE – BAR TAPS:

- 6.1 Each of the Responsible Authorities required to be consulted for TENs were consulted in respect of the application, namely the Police and Environmental Health.
- 6.2 On 29 November, a Late TEN was submitted by Lorna Coulston for 9th to 12th December 2022. A Police Objection Notice was received in relation to this TEN, Lorna Coulston was issued a Counter Notice and the TEN could not proceed. This TEN is later referred to as TEN1.

- 6.3 On 30 November 2022, a Late TEN was submitted by Lorna Coulston for 13th to 17th December 2022. A Police Objection Notice was received in relation to this TEN, Lorna Coulston was issued a Counter Notice and the TEN could not proceed. This TEN is later referred to as TEN2.
- 6.4 On 30 November 2022, a (standard) TEN was submitted by Lorna Coulston for 18th to 20th December 2022. A Police Objection Notice was received in relation to this application. This TEN is later referred to as TEN3.
- 6.5 On 30 November 20022, a (standard) TEN was submitted by Lorna Coulston for 21st to 24th December 2022. A Police Objection Notice was received in relation to this application. This TEN is later referred to as TEN4.
- 6.6 On 30 November 2022, a (standard) TEN was submitted by Lorna Coulston for 27th to 31st December 2022. A Police Objection Notice was received in relation to this application. This TEN is later referred to as TEN5.
- 6.7 A copy of the TEN applications, namely TEN1 to TEN5 can be found in Annex 10.
- 6.8 A copy of the Police Objection Notices to TENs, TEN1 to TEN5 can be found in Annex 11.
- 6.9 A copy of the Counter Notice for TEN1 and TEN2 can be found in Annex 12, as an example.
- 6.10 The covering email advising Lorna Coulston of the Police objections can be found in Annex 13.
- 6.11 Lorna Coulston responded, requesting the TEN applications be determined by the Licensing Sub-Committee. That response can be found in Annex 14.
- 6.12 As mentioned above, Michael Fallon contacted the Licensing Team, that email can be found in Annex 7 (applies to both premises).
- 6.13 For background purposes, Lorna Coulston has confirmed that although Part 3 "relevant entertainment" section of the TENs applications has been completed, she does not seek "relevant entertainment" but had inserted information here in instead with regards to the proposed regulated entertainment.
 - 6.14 Furthermore, Lorna Coulston was not aware of the minimum of 24-hour requirement between separate TENs, see Paragraph 7.15 under Section 8 of the Statutory Guidance below. Therefore, the full TENs as per the dates sought in the applications exceed the limits and would need to be amended.

7. PROPOSED LICENCE CONDITIONS:

7.1 The conditions attached to both premises licences are set out in Annex 1 and 9. The Licensing Sub-Committee may decide not to give a counter notice under section 105 of the Act and instead may impose one or more conditions on the notice (TEN) in accordance with section 106A(2) of the Act.

8. RELEVANT LAW, GUIDANCE & POLICIES:

STATUTORY GUIDANCE:

7.2 The system of permitted temporary activities is intended as a light touch process, and as such, the carrying on of licensable activities does not have to be authorised by the licensing authority on an application. Instead, a person wishing to hold an event at which such activities are proposed to be carried on (the "premises user") gives notice to the licensing authority of the event (a "temporary event notice" or "TEN").

7.3 The TEN must be given to the licensing authority in the form prescribed in regulations made under the 2003 Act. The form requires the user to describe key aspects of the proposed event, including the general nature of the premises and the event, the licensable activities intended to be carried on at the proposed event, including whether they will include any relevant entertainment as defined in Schedule

3 to the Local Government (Miscellaneous Provisions) Act 1982 (i.e. displays of nudity designed to sexually stimulate any member of the audience including, but not limited to, lap dancing and pole dancing). Under the 2003 Act 'premises' can mean any place. Events authorised under a TEN will therefore not always be in a building with a formal address and can take place, for example, in public parks and plots within larger areas of land. In all cases, the premises user should provide a clear description of the area in which they propose to carry on licensable activities, including whether the premises are, for example, an open field or a beer tent. Local authorities and "relevant persons" (see below) may wish to make enquiries where appropriate to satisfy themselves of the exact location for where a TEN is being given.

7.4 Unless it is sent electronically, it must be sent to the relevant licensing authority, to the police and "local authority exercising environmental health functions" ("EHA") at least ten working days before the event. A premises user may also give a limited number of "late TENs" to the licensing authority less than 10 working days before the event to which they relate, although certain restrictions apply (see paragraphs 7.12-7.14). "Working day" under the 2003 Act means any day other than a Saturday, Sunday, Christmas Day, Good Friday or Bank Holiday. For limited purposes in relation to a TEN, the 2003 Act defines a "day" as a period of 24 hours beginning at midnight.

7.5 If a TEN is sent electronically via GOV.UK or the licensing authority's own facility, the licensing authority must notify the police and EHA as soon as possible and no later than the first working day after the TEN is given.

7.6 The police or EHA ("relevant persons" for the purposes of TENs) may intervene to prevent such an event taking place by sending an objection to the licensing authority, which the licensing authority must consider on the basis of the statutory licensing objectives and decide whether the event should go ahead. A relevant person may also intervene by agreeing a modification of the proposed arrangements directly with the TENs user (see paragraph 7.36). If a relevant person sends an objection, this may result in the licensing authority imposing conditions on a TEN but only where the venue at which the event is to be held has an existing premises licence or club premises certificate. When giving a TEN, the premises user should consider the promotion of the four licensing objectives. The licensing authority may only otherwise intervene if the statutory permitted limits on TENs would be exceeded (see paragraphs 7.15-7.22).

Standard and late temporary event notices

7.8 There are two types of TEN: a standard TEN and a late TEN. These are subject to different processes: a standard notice is given no later than ten working days before the event to which it relates; and a late notice is given not before nine and not later than five working days before the event.

Standard temporary event notices

7.9 "Ten working days" (and other periods of days which apply to other requirements in relation to TENs) exclude the day the notice is received and the first day of the event.

7.10 The police and EHA have a period of three working days from when they are given the notice to object to it on the basis of any of the four licensing objectives.

7.11 Although ten clear working days is the minimum possible notice that may be given, licensing authorities should publicise their preferences in terms of advance notice and encourage premises users to provide the earliest possible notice of events planned by them. Licensing authorities should also consider publicising a preferred maximum time in advance of an event by when TENs should ideally be given to them.

Limitations

7.15 A number of limitations are imposed on the use of TENs by the 2003 Act:
... • the minimum period between events authorised under separate TENs in relation to the same premises (not including withdrawn TENs) by the same premises user is 24 hours.

7.20 TENs may be given in respect of premises which already have a premises licence or club premises certificate to cover licensable activities not permitted by the existing authorisation.

7.22 There is nothing in the 2003 Act to prevent notification of multiple events at the same time, provided the first event is at least ten working days away (or five working days away in the case of a late TEN). For example, an individual personal licence holder wishing to exhibit and sell beer at a series of farmers' markets may wish to give several notices simultaneously. However, this would only be possible where the limits are not exceeded in the case of each notice. Where the events are due to take place in different licensing authority (and police) areas, the respective licensing authorities and relevant persons would each need to be notified accordingly.

Role of the licensing authority

7.25 The licensing authority must check that the limitations set down in Part 5 of the 2003 Act are being observed and intervene if they are not (see paragraph 7.15). For example, a TEN would be void unless there is a minimum of 24 hours between events notified by the same premises user, or an associate or someone who is in business with the relevant premises user in respect of the same premises. This is to prevent evasion of the seven-day (or 168 hour) limit on such events and the need to obtain a full premises licence or club premises certificate for more major or permanent events. In addition, for these purposes, a TEN is treated as being from the same premises user if it is given by an associate.

7.26 Where the application is not within the statutory parameters described earlier, the licensing authority will issue a counter notice to the premises user.

7.27 Where the TEN is in order, the relevant fee paid and the event falls within the prescribed limits, the licensing authority will record the notice in its register and send an acknowledgement to the premises user (which may be given electronically). The licensing authority must do so, no later than the end of the first working day following the day on which it was received (or by the end of the second working day if it was received on a non-working day), unless an objection notice is received beforehand from the police or EHA on the basis of any of the four licensing objectives (see paragraphs below).

7.28 If the licensing authority receives an objection notice from the police or EHA that is not withdrawn, it must (in the case of a standard TEN only) hold a hearing to consider the objection unless all parties agree that this is unnecessary. The licensing committee may decide to allow the licensable activities to go ahead as stated in the

notice. If the notice is in connection with licensable activities at licensed premises, the licensing authority may also impose one or more of the existing licence conditions on the TEN (insofar as such conditions are not inconsistent with the event) if it considers that this is appropriate for the promotion of the licensing objectives. If the authority decides to impose conditions, it must give notice to the premises user which includes a statement of conditions (a "notice (statement of conditions)") and provide a copy to each relevant party. Alternatively, it can decide that the event would undermine the licensing objectives and should not take place. In this case, the licensing authority must give a counter notice.

Police and environmental health intervention

7.32 The system of permitted temporary activities gives police and EHAs the opportunity to consider whether they should object to a TEN on the basis of any of the licensing objectives.

7.33 If the police or EHA believe that allowing the premises to be used in accordance with the TEN will undermine the licensing objectives, they must give the premises user and the licensing authority an objection notice. The objection notice must be given within the period of three working days following the day on which they received the TEN.

7.34 Where a standard TEN was given, the licensing authority must consider the objection at a hearing before a counter notice can be issued. At the hearing, the police, EHA and the premises user may make representations to the licensing authority. Following the hearing, the licensing authority may decide to impose conditions which already apply to an existing premises licence or club premises certificate at the venue or issue a counter notice to prevent the event going ahead. As noted above, there is no scope for hearings in respect of late TENs and if objections are raised by the police or EHA in relation to a late TEN, the notice will be invalid, and the event will not go ahead.

7.35 Such cases might arise because of concerns about the scale, location, timing of the event or concerns about public nuisance – even where the statutory limits on numbers are being observed. The premises user who signs the form is legally responsible for ensuring that the numbers present do not exceed the permitted limit at any one time. In cases where there is reason to doubt that the numbers will remain within the permitted limit the premises user should make clear what the nature of the event(s) is and how they will ensure that the permitted persons limit will not be exceeded. For example, where notices are being given for TENs simultaneously on adjacent plots of land it may be appropriate for door staff to be employed with counters. In each case it is important that licensing authorities and relevant persons can consider whether they believe that the premises user intends to exceed the 499-person limit or will be unable to control or know whether the limit will be exceeded. Where the planned activities are likely to breach the statutory limits or undermine the licensing objectives, it is likely to be appropriate for the police or EHA to raise objections.

Modification

7.37 As noted above, the police or EHA (as "relevant persons") may contact the premises user to discuss their objections and try to come to an agreement which will allow the proposed licensable activities to proceed. The TEN can be modified (for example, by changing the details of the parts of the premises that are to be used for

the event, the description of the nature of the intended activities or their duration). The other relevant person has to agree for the modification to be made. There is no scope under the 2003 Act for the modification of a late TEN.

Applying conditions to a TEN

7.38 The 2003 Act provides that only the licensing authority can impose conditions to a TEN from the existing conditions on the premises licence or club premises certificate at the venue. The licensing authority can only do so:

• if the police or the EHA have objected to the TEN;

• if that objection has not been withdrawn;

• if there is a licence or certificate in relation to at least a part of the premises in respect of which the TEN is given;

• and if the licensing authority considers it appropriate for the promotion of the licensing objectives to impose one or more conditions.

7.39 This decision is one for the licensing authority alone, regardless of the premises user's views or willingness to accept conditions. The conditions must be notified to the premises user on the form prescribed by regulations.

9. OPTIONS AVAILABLE TO THE LICENSING SUB-COMMITTEE

9.1 Having considered the TENs, the objection notice(s) received from responsible authorities and any further representations made by parties to the hearing:

a) The Sub-Committee must decide whether to give the premises user a 'counternotice' under section 105(2) of the 2003 Act, if they consider it appropriate for the promotion of a licensing objective to do so, setting out the full reasons for this decision;

b) If a counter-notice is not issued, then the Sub-Committee must resolve to take no action, and the deemed authorisation will permit the event to take place as proposed. Conditions may be added and amended dates of the TENs sought for these particular TENs (to allow a 24-hour gap between separate TENs).

- 9.2 Full reasons must be given in support of any decision made by the Licensing Sub-Committee.
- 9.3 The premises user will have a right of appeal to a magistrate's court against a decision to issue a counter-notice. The objecting responsible authorities will have a right of appeal to a magistrate's court against a decision not to issue a counternotice. Any appeal must be brought within 21 days of notification of the decision, but no later than 5 working days prior to the first day of the proposed event.

Annex 1 - Mandatory conditions

The Mandatory Conditions are attached and form part of the Operating Schedule of your licence/certificate. You must ensure that the operation of the licensed premises complies with the attached Mandatory Conditions as well as the Conditions in Annex 2 and Annex 3 (if applicable). Failure to do this can lead to prosecution or review of the licence.

Annex 2 - Conditions consistent with the Operating Schedule

1. Where the licence includes a condition that individuals are required to carry out any security activity at specified times at the premises each individual must be licensed by the Security Industry Authority.

2. There shall be no adult entertainment or services, activities or matters ancillary to the use of the premises that may give rise to concern in respect of children.

3. A digital CCTV system must be installed in the premises complying with the following criteria: (1) Cameras must be sited to observe the entrance and exit doors both inside and outside, the alcohol displays, and floor areas; (2) Cameras on the entrances must capture full frame shots of the heads and shoulders of all people entering the premises i.e. capable of identification; (3) Cameras viewing till areas must capture frames not less then 50% of screen; (4) Cameras overlooking floor areas should be wide angled to give an overview of the premises; (5) Be capable of visually confirming the nature of the crime committed; (6) Provide a linked record of the date, time, and place of any image; (7) Provide good quality images; (8) Operate under existing light levels within and outside the premises; (9) Have the recording device located in a secure area or locked cabinet; (10) Have a monitor to review images and recorded picture quality; (11) Be regularly maintained to ensure continuous quality of image capture and retention; (12) Have signage displayed in the customer area to advise that CCTV is in operation; (13) Digital images must be kept for 31 days; (14) Police and / or authorised officers of the council will have access to images at any reasonable time; (15) The equipment must have a suitable export method, e.g. CD/DVD writer so that the police can make an evidential copy of the data they require. This data should be in the native file format, to ensure that no image quality is lost when making the copy. If this format is non-standard (i.e. manufacturer proprietary) then the manufacturer should supply the replay software to ensure that the video on the CD can be replayed by the police on a standard computer. Copies must be made available to Police and / or authorised officers of the council on request.

4. Signs shall be prominently displayed on the exit doors advising customers that the premises is in a 'Drinking Control Area' and that alcohol should not be taken off the premises and consumed in the street. These notices shall be positioned at eye level and in a location where those leaving the premises can read them.

5. A monitored alarm system to EU 50131 must be installed at the premises.

6. A minimum of two door supervisors shall be employed on the premises on Fridays and Saturdays from 21:00 until the premises has closed. This number will rise to a minimum of three if the function room is being used during these times. At least one door supervisor shall remain directly outside the premises for 30 minutes after the premises have closed or until all customers have dispersed. The duties of these staff will include the supervision of persons entering and leaving the premises to ensure that this is achieved without causing a nuisance. All door supervisors (or marshals) shall be easily identifiable by wearing high visibility jackets or armbands.

7. Any door supervisor employed must be from an SIA approved contractor scheme.

8. A log must be kept and signed by each door supervisor each night they are employed at the premises indicating that they have been informed of, understand, and will implement the entry and search policy. This log must be made available to Police or Local Authority employees on request.

9. A log must be kept indicating the date and times door supervisors sign in and out for duty and must include clearly printed details of each door supervisor's name, SIA licence number, employer, and the duty they are employed to carry out on any particular night. This log must be made available to Police or Local Authority employees on request.

10. There shall be no entry or re-entry of patrons to the premises after 00:00 Monday - Sunday except for smokers.

11. All those hiring the premises shall be required to sign a hire agreement, which shall specify the terms of use of the premises.

12. A suitable method e.g. clicker counters, for determining the number of persons on the premises at any one time shall be employed to ensure that the maximum permitted number is not exceeded.

13. Toilets at the premises shall be checked for any sign of drug use on average of every hour between 19:00 and closing time on Thursday, Friday & Saturday. A record shall be kept of the times, dates and any issues discovered. These records shall be kept for six months. Records must be made available to an authorised officer of the Council or police upon request.

14. The Local Authority or similar proof of age scheme shall be operated and relevant material shall be displayed at the premises. Only passport, photographic driving licences or ID with the P.A.S.S. logo (Proof of Age Standards Scheme) may be accepted. 15. All staff shall receive induction and refresher training (at least every three months) relating to the sale of alcohol and the terms and conditions of this licence.

16. All training shall be documented and records kept for 12 months. These records shall be made available to the Police and/or Local Authority upon request.

17. A written record of refused sales must be kept on the premises and completed when necessary. It must be made available to Police and/or the Local Authority upon request, and shall be kept for at least one year from the date of the last entry.

18. Prominent, clear and legible notices shall be displayed at all public exits from the premises requesting customers respect the needs of local residents and leave the premises area quietly. These notices shall be positioned at eye level and in a location where those leaving the premises can read them.

19. All doors and windows shall be kept closed but not locked during regulated entertainment.


20. The management shall make subjective assessments of noise levels at the perimeter of the premises. These shall be undertaken at approximately hourly intervals, whilst regulated entertainment is provided to ensure that noise from the premises does not cause a disturbance to local residents. Records shall be kept of the times, dates and any issues discovered. These records shall be kept for six months. Records must be made available to the Police and/or an authorised officer of the Council, upon request. Where monitoring by staff identifies that noise from the premises is audible at the perimeter, measures shall be taken to reduce this i.e. turning volume down.

21. Children may only be permitted on the premises when accompanied by an adult. In so far as the ground floor Public House is concerned, children under the age of 14 years are not permitted on the premises after 21:00 and children aged 14 years and over are not permitted on the premises after 23:00.

Annex 1 – Mandatory Conditions

Mandatory conditions where the licence authorises the sale of alcohol (Note: Conditions 4, 5, and 7 relate to on-sales only)

These Mandatory Conditions form part of the Operating Schedule of your licence. You must ensure that the operation of the licensed premises complies with these Mandatory Conditions, as well as the Conditions stated in Annex 2 and Annex 3 (if applicable). Failure to do this can lead to prosecution or review of the licence.

1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.

2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.

3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.

4. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -

(a) a holographic mark, or

(b) an ultraviolet feature.

7. The responsible person must ensure that –

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -

(i) beer or cider: $\frac{1}{2}$ pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

8 (i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

(ii) For the purposes of the condition set out in paragraph 8(i) above -

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b) "permitted price" is the price found by applying the formula -

P = D+(DxV)

Where -

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Supply of alcohol under a Club Premises Certificate

The mandatory conditions 4 to 8 above will apply. If the club premises certificate authorises the supply of alcohol for consumption off the premises, the following three mandatory conditions must also be included:

1. The supply of alcohol for consumption off the premises must be made at a time when the premises are open for the purposes of supplying alcohol to members of the club for consumption on the premises.

Any alcohol supplied for consumption off the premises must be in a sealed container.
 Any alcohol supplied for consumption off the premises must be made to a member of the club in person.

Supply of alcohol from community premises

The following mandatory condition will replace the first three mandatory conditions above when an application is made for a premises licence by the management committee of community premises and the licensing authority also grants an application for this alternative licence condition to be included in the licence:

1. Every supply of alcohol under the premises licence must be made or authorised by the [management committee / management board / board of trustees].

9. Admission of children to the premises must be restricted in accordance with the film classification recommended by the British Board of Film Classification or recommended by this licensing authority as appropriate.

10. All persons guarding premises against unauthorised access or occupation or against outbreaks of disorder or against damage (door supervisors) must be licensed by the Security Industry Authority.

Regarding this late Ten application .We object to the later hours cessation for reasons stated previously(in recent late Ten applications) .Namely

PREVENTION OF CRIME AND DISORDER

For the reason that a search of the Police incident indices shows incidents of disorder and violence have occurred near the terminal time of the licensable activities from the premises and the premises have been identified as being a catalyst in that the suspects /perpetrators of this crime and disorder have been identified as visiting and or being present within the premises.

It is felt that the current terminal times for licensable activities is sufficient and extending these times will only lead to an increase in alcohol intoxication related incidents of a violent nature with patrons having extended drinking periods into the small hours of the morning .This has shown in the past to be a draw on Police resources having to respond to the disorder in the street with reports of assaults being prevalent.

From these incidents it can be shown that in a short period of time in or around the terminal time for licensable activities for these premises crime and disorder in the form of assaults and violence break out. It is also worthy of note that there are residential premises in and around this location and any extended hours would impact upon the quiet enjoyment of their premises into the small hours when they are sleeping.

It is felt by the Police that a request to further extend the terminal hours for licensable activity to 0300 hours (on their latest application for 9^{th} , 10^{th} , 11^{th} and 12^{th} December 2022) in light of the incidents would further act as a crime generator with this sort of alcohol fuelled violent behaviour leading to further crime and disorder .We therefore oppose this application.

I refer to your following Temporary Event Notices for the above premises:

The Metropolitan Police have submitted objections to all four of these TENs as they consider the applications undermine the licensing objectives, namely prevention of crime and disorder. The Police representations for each TEN are attached, and have the full reasons for their objections.

As TEN1 was a Late TEN, the Council has today issued you with a Counter Notice under the Licensing Act 2003 in relation to this, also attached.

As a result, licensable activities must not take place at The Kings Head during the following times and dates:

- 9th December 2022, between midnight and 1am;
- 10th December 2022, between 2am and 3am;
- 11th December 2022, between 2am and 3am;
- 12th December 2022, between midnight and 1am;

Under section 136 of the Licensing Act 2003, a person commits an offence if he carries on a licensable activity on or from any premises otherwise than under and in accordance with an authorisation; or if he knowingly allows a licensable activity to be so carried on. A person convicted of such an offence is liable to imprisonment for a term not exceeding six months or to a fine of any amount, or to both.

Please inform us by midday tomorrow (7 December 2022) if you wish to appeal the Police objections at a hearing before the Licensing Sub Committee, regarding TEN2, TEN3 and TEN4 (dates set out above).

Alternatively, you can withdraw these 3 x TEN applications and therefore a hearing would not be required. Please advise us also **by midday tomorrow (7 December 2022)** if you wish to withdraw.

I must emphasise that TEN2, TEN3 and TEN4 cannot proceed without a hearing. The licensing sub-committee may decide to allow the licensable activities to go ahead as stated in the TEN application. Application was made by the **METROPOLITAN POLICE SERVICE** for a summary review of the Premises Licence held by **MR MICHAEL FALLON** at the premises known as and situated at **BAR TAPS, 29 SILVER STREET, ENFIELD, EN1 3EF.**

The Licensing Sub-Committee **RESOLVED** it appropriate for the promotion of the licensing objectives **to modify the conditions of the licence; as follows:**

Conditions (in accordance with Annex 10 of the LSC Supplementary Report):

Conditions 1 to 11, which are not disputed,

(ii) Modifications:

Proposed conditions 18, 19, 21, 22, 23, 24, 26, 28, 29 and 30 agreed. Proposed Condition 20 – delete all text after "from 21:00 hours". Proposed Condition 25 – change 23:00 to 00:00. Proposed Condition 27 – change 20:00 to 21:00. Proposed Condition 31 – change 20:00 to 21:00.

(iii) Additional conditions:

Breathalysers shall be used to test customers to assist door supervisors in assessing whether customers shall be permitted entry. Customers with a red reading shall be refused entry.

Records shall be kept of the time and date for all breathalyser tests administered, and of any issues discovered. These records shall be kept for 12 months. Records must be made available to an authorised officer of the Council or Police, upon request.

A prominent, clear and legible notice shall be displayed at the entrance to the premises advising of the alcohol screening test.

Appeal:

Should the premises licence holder appeal this Decision, the interim steps as per the Decision Notice dated 1 March 2016 must be complied with until the appeal is heard.

<u>Reasons</u>:

The Chairman made the following statement:

"After reading all the submissions and listening to all parties concerned, with these amendments to the licence we are happy that the licensing objectives will be met. The LSC was persuaded by the representations of Bar Taps that some of the steps proposed by the Police would not prevent the unfortunate incidents the Police had relied on in their evidence. The LSC noted that some of the incidents occurred outside the premises and were beyond the control of Bar Taps. The LSC was not

persuaded that Bar Taps was a bad establishment from a licensing perspective and the evidence showed that Bar Taps had historically shown a willingness to work with the Police to ensure that the licensing objectives are being promoted. Bar Taps had been willing to co-operate with the Police by accepting some of the interim steps proposed by the Police such as reducing capacity during busy hours to 150 instead of 175. Further conditions have been added in respect of use of breathalysers at the venue, as proposed in the premises licence holder statements in Annex 9 of the report."

Annex 1 - Mandatory Conditions

The Mandatory Conditions are attached and form part of the Operating Schedule of your licence/certificate. You must ensure that the operation of the licensed premises complies with the attached Mandatory Conditions as well as the Conditions in Annex 2 and Annex 3 (if applicable). Failure to do this can lead to prosecution or review of the licence.

Annex 2 - Conditions consistent with the Operating Schedule

1. There shall be no adult entertainment or services, activities or matters ancillary to the use of the premises that may give rise to concern in respect of children.

2. Strobe lighting, lasers, explosives and fireworks shall not be used.

3. First aid kits and an accident book shall be kept behind the bar.

4. An effective counting system shall be employed to ensure the capacity limit is not exceeded.

5. At least 4 prominent, clear and legible notices shall be displayed throughout the premises, including the toilets warning customers that drug use will not be tolerated.

6. Toilets at the premises shall be checked for any sign of drug use on an average of two hours. A record shall be kept of the times, dates and any issues discovered. These records shall be kept for six months. Records must be made available to an authorised officer of the Council or police upon request.

7. A sign shall be prominently displayed on the exit doors asking customers not to take open drinks outside.

8. All off sales shall be in a sealed container.

9. Signs shall be prominently displayed on the exit doors advising customers that the premises is in a 'Drinking Control Area' and that alcohol should not be taken off the premises and consumed in the street. These notices shall be positioned at eye level and in a location where those leaving the premises can read them.

10. Prominent, clear and legible notices shall be displayed at all public exits from the premises requesting customers respect the needs of local residents and leave the premises area quietly. These notices shall be positioned at eye level and in a location where those leaving the premises can read them.

11. Rowdy drinkers shall not be allowed in the premises, if inside they will be asked to leave.

12. A minimum of two registered door supervisors shall be employed whilst there are more than 60 persons on the premises to supervise persons entering and leaving the premises at all times. Whilst live music is provided there shall be a minimum of one registered door supervisor.

13. A noise limiting device shall be installed and permanently maintained in good working order within the premises. The device shall control the volume of all amplified live and recorded music at the venue at all times and shall be set to ensure noise from the premises does cause a disturbance to local residents.

14. A written record of refused sales must be kept on the premises and completed when necessary. It must be made available to Police and/or the Local Authority upon request.

15. All staff shall receive induction and refresher training (at least every three months) relating to the sale of alcohol and the terms and conditions of this licence.

16. All training shall be documented and records kept for 12 months. These records shall be made available to the Police and/or Local Authority upon request.

Annex 3 - Conditions attached after a hearing by the Licensing Authority

17. Those under the age of 18 shall only be permitted in the premises up until 21:00 hours and only if accompanied by an adult.

18. All gaming machines shall be in sight of the bar.

19. All doors and windows will be kept closed but not locked during live and/or recorded music with the exception on access and egress.

20. The maximum number of persons permitted on the premises is 150.

21. A digital CCTV system must be installed in the premises complying with the following criteria:

(1) Cameras must be sited to observe the entrance and exit doors both inside and outside including the designated smoking section and all floor areas.

(2) Cameras on the entrances must capture full frame shots of the heads and shoulders of all people entering the premises i.e. capable of identification.

(3) Cameras overlooking floor areas should be wide angled to give an overview of the premises.

- (4) Provide a linked record of the date, time, and place of any image.
- (5) Provide good quality images.
- (6) Operate under existing light levels within and outside the premises.
- (7) Have the recording device located in a secure area or locked cabinet.
- (8) Have a monitor to review images and recorded picture quality.

(9) Be regularly maintained to ensure continuous quality of image capture and retention.

(10) Have signage displayed in the customer area to advise that CCTV is in operation.

(11) Digital images must be kept for 31 days.

(12) Police or authorised local authority employees will have access to images at any reasonable time.

(13) The equipment must have a suitable export method, e.g. CD/DVD writer so that the police can make an evidential copy of the data they require. This data should be in the native file format, to ensure that no image quality is lost when making the copy. If this format is non-standard (i.e. manufacturer proprietary) then the manufacturer should supply the replay software to ensure that the video on the CD can be replayed by the police on a standard computer. Immediate copies must be made available to Police or authorised local authority employees on request.

22. The management shall make subjective assessments of noise and light levels at the perimeter of the premises. These shall be undertaken at approximately two hourly intervals, whilst live and/or recorded music is provided to ensure that noise / light from the premises does not cause a disturbance to local residents. Where monitoring by staff identifies that noise/ light from the premises is audible / visible at the perimeter, measures shall be taken to reduce this i.e. turning volume / lights down.

23. There shall be no admission or re-admission of customers to the premises after 00:00 except by those who have been outside to smoke in the designated smoking area. After 00:00, on days when door supervisors are employed there shall be no more than ten smokers outside at any one time.

24. The Local Authority or similar proof of age scheme shall be operated and relevant material shall be displayed at the premises.

25. On Fridays and Saturdays and all days preceding bank holidays, at least two door supervisors shall be employed from 21:00 hours, rising to four door supervisors, including at least one female door supervisor, from 23:00 hours until 30 minutes after the premises has closed. The duties of these staff will include the monitoring of people entering and leaving the premises to ensure that patrons within the premises are suitably supervised to prevent crime & disorder and to ensure public safety within.

26. Door staff to conduct regular searches, at least one in five, of customers, including females, entering the venue.

27. Door staff shall be issued with and utilise search wands to assist with search procedures during prescribed times.

28. A personal licence holder to be on site from 21:00 hours until closing time on Thursday, Friday and Saturday nights and all evenings prior to bank holidays.


29. Breathalysers shall be used to test customers to assist door supervisors in assessing whether customers shall be permitted entry. Customers with a red reading shall be refused entry.

30. Records shall be kept of the time and date for all breathalyser tests administered, and of any issues discovered. These records shall be kept for 12 months. Records must be made available to an authorised officer of the Council or Police, upon request.

31. A prominent, clear and legible notice shall be displayed at the entrance to the premises advising of the alcohol screening test.

32. The premises shall offer a range of substantial table meals for sale each day.

Annex 1 – Mandatory Conditions

Mandatory conditions where the licence authorises the sale of alcohol (Note: Conditions 4, 5, and 7 relate to on-sales only)

These Mandatory Conditions form part of the Operating Schedule of your licence. You must ensure that the operation of the licensed premises complies with these Mandatory Conditions, as well as the Conditions stated in Annex 2 and Annex 3 (if applicable). Failure to do this can lead to prosecution or review of the licence.

1. No supply of alcohol may be made at a time when there is no designated premises supervisor in respect of this licence.

2. No supply of alcohol may be made at a time when the designated premises supervisor does not hold a personal licence or the personal licence is suspended.

3. Every supply of alcohol under this licence must be made or authorised by a person who holds a personal licence.

4. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to;

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

6. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -

(a) a holographic mark, or

(b) an ultraviolet feature.

7. The responsible person must ensure that –

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -

(i) beer or cider: $\frac{1}{2}$ pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A responsible person in relation to a licensed premises means the holder of the premise licence in respect of the premises, the designated premises supervisor (if any) or any individual aged 18 or over who is authorised by either the licence holder or designated premises supervisor. For premises with a club premises certificate, any member or officer of the club present on the premises in a capacity that which enables him to prevent the supply of alcohol.

8 (i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

(ii) For the purposes of the condition set out in paragraph 8(i) above -

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b) "permitted price" is the price found by applying the formula -

P = D+(DxV)

Where -

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

(iii). Where the permitted price given by Paragraph 8(ii)(b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

(iv). (1) Sub-paragraph 8(iv)(2) below applies where the permitted price given by Paragraph 8(ii)(b) above on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Supply of alcohol under a Club Premises Certificate

The mandatory conditions 4 to 8 above will apply. If the club premises certificate authorises the supply of alcohol for consumption off the premises, the following three mandatory conditions must also be included:

1. The supply of alcohol for consumption off the premises must be made at a time when the premises are open for the purposes of supplying alcohol to members of the club for consumption on the premises.

Any alcohol supplied for consumption off the premises must be in a sealed container.
 Any alcohol supplied for consumption off the premises must be made to a member of the club in person.

Supply of alcohol from community premises

The following mandatory condition will replace the first three mandatory conditions above when an application is made for a premises licence by the management committee of community premises and the licensing authority also grants an application for this alternative licence condition to be included in the licence:

1. Every supply of alcohol under the premises licence must be made or authorised by the [management committee / management board / board of trustees].

Mandatory condition when a premises licence or a club premises certificate authorises the exhibition of films

9. Admission of children to the premises must be restricted in accordance with the film classification recommended by the British Board of Film Classification or recommended by this licensing authority as appropriate.

Mandatory Condition relating to door supervision which only applies where a premises licence includes a condition that one or more individuals must be at the premises to carry out a security activity

I refer to your following Temporary Event Notices for the above premises:

- 4. TEN4: WK/222064101 Standard TEN for dates 21^{st,} 22^{nd,} 23^{rd,} 24^{th,} December 2022.
- 5. TEN5: WK/222064155 Standard TEN for dates 27th, 28th, 29th, 30th, 31st December 2022.

The Metropolitan Police have submitted objections to all five TENs as they consider the applications undermine the licensing objectives, namely prevention of crime and disorder. The Police representations for each TEN are attached, and have the full reasons for their objections.

As TEN1 and TEN2 were Late TENs, the Council has today issued you with a Counter Notice under the Licensing Act 2003 in relation to these, also attached.

As a result, licensable activities must not take place at Bar Taps during the following times and dates:

TEN1:

- 9th December 2022, between 1am and 2am;
- 10th December 2022, between 2am and 3am;
- 11th December 2022, between 2am and 3am;
- 12th December 2022, between midnight and 1am;

TEN2:

- 13th December 2022, between midnight and 1am;
- 14th December 2022, between midnight and 1am;
- 15th December 2022, between midnight and 1am;
- 16th December 2022, between 1am and 2am;
- 17th December 2022, between 2am and 3am.

Under section 136 of the Licensing Act 2003, a person commits an offence if he carries on a licensable activity on or from any premises otherwise than under and in accordance with an authorisation; or if he knowingly allows a licensable activity to be so carried on. A person convicted of such an offence is liable to imprisonment for a term not exceeding six months or to a fine of any amount, or to both.

Please inform us by midday tomorrow (7 December 2022) if you wish to appeal the Police objections at a hearing before the Licensing Sub Committee, regarding TEN3, TEN4 and TEN5 (dates set out above).

Alternatively, you can withdraw these 3 x TEN applications and therefore a hearing would not be

required. Please advise us also **by midday tomorrow (7 December 2022)** if you wish to withdraw.

I must emphasise that TEN3, TEN4 and TEN5 cannot proceed without a hearing. The licensing sub-committee may decide to allow the licensable activities to go ahead as stated in the TEN application. The licensing sub-committee may also impose one or more of the existing licence conditions on the TEN if it considers that this is appropriate for the promotion of the licensing objectives. Alternatively, the licensing sub-committee can decide that the event would undermine the licensing objectives and should not take place. In this case, the licensing sub-committee must give a Counter Notice.

If you do not withdraw the TENs and you do not attend a hearing, then the section 136 offences under the Licensing Act also applies in this instance should you proceed with the event i.e. the event would be unlicensed.

Further Advice:

You have requested timings which mean there is not a 24 hour gap between TEN1 and TEN2 (sought to seek to close at 1am on 12th December 2022 on TEN1 but start at midnight on 13th December 2022 on TEN2). The same issue applies between TEN2 and TEN3 (sought to seek to close at 3am on 17th December 2022 on TEN2 but start at 2am on 18th December 2022 on TEN3). It is a legal requirement that the minimum period between events authorised under separate TENs in relation to the same premises (not including withdrawn TENs) by the same premises user is 24 hours.

You have also applied for "relevant entertainment". This means entertainment, such as lap dancing, stripping or of a similar nature. Do you intend to provide "relevant entertainment" or did you believe this meant regulated entertainment? Regulated entertainment is deemed a licensable activity under the first box in Section 3 of the application form.
