**Name and address of premises:** The Hyde Arms, Public House, 137 Victoria Road, LONDON, N9 9BB

**Type of Application:** Review of Premises Licence

**Detailed below is information not previously included in the review application submitted on 29/01/2024:**

**Friday 26 January 2024** – Licensing Enforcement Officers (JF and DD) visited the premises at 22:50. The officers were able to enter the premises as appeared open. On entry, the officers noted what seemed to be a new illuminated advert on the frontage, advertising the premises as a coffee shop and restaurant. Four people were setting up the front area of the premises inside for an alleged first birthday party to be held the next day. Tables were being prepped with voile covered tablecloths and matching chairs with green and white voile bows, more in liking to what might be seen at a wedding. The officers met the manager, Mr Enias Thanasi. He believed the premises licence had already been revoked. No licensable activities were observed at the time of the visit, but alcohol such as spirits were seen displayed in the optics.

The officers undertook a licence inspection with Mr Enias Thanasi. He advised the street number of the address of the PLH (Mr Mansur Duzgun) was not correct. He also believed that Mr Duzgun was the DPS, but he had not seen him.

The following conditions were non-compliant:

Part B of the premises licence was not displayed.

Conditions 2,3 &4 - CCTV was not working and not connected. Mr Enias Thanasi stated he does not have the funds to get the CCTV into working order.

Condition 9 - No Think 25 Posters displayed. This is despite officers emailing the posters and other material to both Mr Duzgun and Mr Thanasi on 11 January 2024. Mr Thanasi advised officers he had forgotten to put all the posters up.

Condition 10 – No drug check records available, officers advised.

Condition 11 – No drug posters displayed despite being emailed a copy recently.

Condition 12 - No checks being carried out that night or previous records made. Note the noise complaint relating to loud music received on 19 January 2024, which was after the last inspection and advice. Records of music should have been undertaken on the night of 19 January 2024.

Conditions 13&14 – No leave quietly or drinking control zone posters displayed. Again, these have been provided.

Conditions 21&22 – Training of staff not carried out and no training records kept. Training material/training record template have been provided.

Condition 23 – No refusals book available. This has been provided.

Mr Thanasi was not happy and feels victimised that so many officer visits are being made whilst he is trying to improve community relations.

An inspection report was completed, signed by and copy issued to Mr Thanasi. A copy of that inspection report is produced as **Appendix 14**.

**In light of all the above information, we are still seeking full revocation of the premises licence.**
