Representation of Review of Licence - Noise Disturbance/ACCRO 6 Ashfield Parade Southgate London N14 5AB

xxxxx - Owner - xxxxx Ashfield Parade Southgate London N14 5AB

Unfortunately I have to report 3 events that took place:-

The 6th July, Thursday the premises had a party starting at 20.30 and ending late into the night.

The 8th July, Saturday the premises had a party starting at 21.00pm and finishing 2.30/3.00m n the morning

The 10th July, Monday the premises had a party starting 21.00pm and lasting late into the morning.

On all 3 occasions the music was so loud and the vibration permeated into my tenants xxxxx all night and into the early hours of the morning. Noise disturbance /pollution, noise spillage onto the streets, people speaking loudly, car disturbance the list goes on.

My understanding is that the premises acquired additional sound equipment, which was seen taken into the premises. How is this allowed to happen?

My understanding is that the council must be notified 7 days ahead of any party-taking place on weekdays. Were any applications made?

My tenant has become so fatigued after 9 months by this whole process of noise disturbance/pollution. xxxxx is unable to continue phoning the Noise Complaints team as on occasions xxxxx is held in queue phoning late at night early hours of the morning and due to the volume of complaints they are unable to attend. This leaves xxxxx feeling very isolated in dealing with this lawlessness. The sleep deprivation and xxxxx mental health have suffered so much and the noises disturbance continues and is getting worse.

xxxxx is unable to concentrate on xxxxx work, which is very demanding, and xxxxx accountancy exams, which are impending. This adds more stress to xxxxx already unacceptable situation of dealing every weekend and weekdays with no sleep and the lawlessness of the premises.

My tenant has suffered and feels let down by the council over the last 9 months and clearly this is an acceptable infringement on my tenant's right to peacefully enjoy xxxxx home.

How can the council allow the premises to continue acting with impunity affecting my tenant and the residents of Ashfield Parade for 9 months?

I understand a process has to be followed and evidence collected but this lasted with severe consequences to my tenant and xxxxx. Sleep deprivation, stress and fear for xxxxx and xxxxx safety.

I sincerely hope that the review of the licence on the 17th July 2024 will put and end to the noise disturbance/pollution once and for all.
