**1. LICENSING HISTORY:**

- 1.1 This is the first application for a premises licence at 119 Cecil Road, EN2 6TR. The premises previously operated as Argos.
- 1.2 The premises is located on the outskirts of Enfield town centre, and the following similar premises are licensed for:

**2 THIS APPLICATION:**

On 24 January 2018, an application by Iceland Foods Limited for a new Premises Licence at Iceland, 119 Cecil Road, ENFIELD, EN2 6TR.

- 2.1 The application originally sought:
  - 2.1.1 **Hours the premises are open to the public:** 08:00 to 23:00 daily.
  - 2.1.2 **Supply of alcohol (off supplies only):** 08:00 to 23:00 daily.
- 2.2 In response to the representations, the application has been amended and now seeks:
  - 2.2.1 **Hours the premises are open to the public:** 08:00 to 21:00 daily.

- 2.2.2 **Supply of alcohol (off supplies only):** 08:00 to 21:00 daily.
- 2.3 The proposed Designated Premises Supervisor (DPS) is Mr Robert Hayes, Licensing Manager at Iceland Foods Limited.
- 2.4 Each of the Responsible Authorities were consulted in respect of the application.
- 2.5 A copy of the application and plan is attached as Annex 2.

### **3 RELEVANT REPRESENTATIONS:**

- 3.1 **Other Persons:** Representations have been made, against the application, by two residents. The grounds of representation include the prevention of crime & disorder; the prevention of public nuisance and the prevention of children from harm.
- 3.2 The representation made by local resident referred to as IP1 and the applicant's response is attached as Annex 3. IP1 still seeks the licensable hours be no later than 8am to 9pm Monday to Saturday and 11am to 5pm Sunday. IP1 also seeks additional conditions to address litter.
- 3.3 The representation made by local resident referred to as IP2 and the applicant's response is attached as Annex 4. IP2 objects to the hours sought.
- 3.4 The Metropolitan Police and Licensing Authority made representations in respect of this application, namely seeking modification of conditions. The applicant has agreed those conditions, and subsequently the representations have been withdrawn.

### **4 PROPOSED LICENCE CONDITIONS:**

- 4.1 The conditions arising from this application are attached as Annex 5.

### **5 RELEVANT LAW, GUIDANCE & POLICIES:**

- 5.1 The paragraphs below are extracted from either:
  - 5.1.1 the Licensing Act 2003 ('Act'); or
  - 5.1.2 the Guidance issued by the Secretary of State to the Home Office of April 2017 ('Guid'); or
  - 5.1.3 the London Borough of Enfield's Licensing Policy Statement of January 2015 ('Pol').

#### **General Principles:**

- 5.2 The Licensing Sub-Committee must carry out its functions with a view to promoting the licensing objectives [Act s.4(1)].

- 5.3 The licensing objectives are:
  - 5.3.1 the prevention of crime and disorder;
  - 5.3.2 public safety;
  - 5.3.3 the prevention of public nuisance; &
  - 5.3.4 the protection of children from harm [Act s.4(2)].
- 5.4 In carrying out its functions, the Sub-Committee must also have regard to :
  - 5.4.1 the Council's licensing policy statement; &
  - 5.4.2 guidance issued by the Secretary of State [Act s.4(3)].

**Hours:**

- 5.5 The Sub-Committee decides licensed opening hours as part of the implementation of the licensing policy statement and is best placed to make decisions about appropriate opening hours in their area based on their local knowledge and in consultation with responsible authorities [Guid 10.13].
- 5.6 Stricter conditions with regard to licensing hours may be required for licensed premises situated in or immediately adjacent to residential areas to ensure that disturbance to local residents is avoided. This will particularly apply in circumstances where, having regard to the location, size and nature of the premises, it is likely that disturbance will be caused to residents in the vicinity of the premises by concentrations of people leaving, particularly during normal night-time sleeping periods [Pol s.8.4].

**Decision:**


- 7.1 As a matter of practice, the Sub-Committee should seek to focus the hearing on the steps considered appropriate to promote the particular licensing objective or objectives that have given rise to the specific representation and avoid straying into undisputed areas [Guid 9.37].
- 7.2 In determining the application with a view to promoting the licensing objectives in the overall interests of the local community, the Sub-Committee must give appropriate weight to:
  - 7.2.1 the steps that are appropriate to promote the licensing objectives;
  - 7.2.2 the representations (including supporting information) presented by all the parties;
  - 7.2.3 the guidance; and
  - 7.2.4 its own statement of licensing policy [Guid 9.38].
- 7.3 Having heard all of the representations (from all parties) the Sub-Committee must take such steps as it considers appropriate for the promotion of the licensing objectives. The steps are:
  - 7.3.1 to grant the application subject to the mandatory conditions and such conditions as it considers necessary for the promotion of the licensing objectives;
  - 7.3.2 to exclude from the scope of the licence any of the licensable activities to which the application relates;
  - 7.3.3 to refuse to specify a person in the licence as the premises supervisor;
  - 7.3.4 to reject the application [Act s.18].

b) The prevention of crime and disorder

1. the premises shall maintain a CCTV system which gives coverage of all entry and exit points. The system shall continuously record whilst the premises are open to the public and conducting licensable activities. All recordings shall be stored for a minimum period of 28 days and shall be capable of being easily downloaded. Recordings shall be made available upon the receipt of a request by an authorised Officer of the Police or the local Authority.
2. There shall be 'CCTV in operation' signs prominently displayed in the premises.
3. An incident log (whether kept in written or electronic form) shall be retained at the premises and made available for inspection by an authorised Officer of the Police or the Local Authority.
4. The premises shall operate a proof of age scheme, such as Challenge 25, whereby the only forms of acceptable identification shall be a photographic driving licence, valid passport, military identification or any other recognised form of photographic identification incorporating the PASS logo, or any other form of identification from time to time approved by the Secretary Of State.
5. The premises will be fitted with a burglar alarm system.
6. The premises will be fitted with a panic button system for staff to utilise in the case of an emergency.

c) Public safety

The Premises Licence Holder shall ensure that the appropriate fire safety, and health and safety regulations are applied at the premises.

d) The prevention of public nuisance

A complaints procedure shall be in operation at the premises, details of which will be made available in store.

e) The protection of children from harm

1. All relevant staff will receive training in relation to the sale of alcohol. No member of staff will be permitted to sell alcohol until such time as they have successfully completed the aforementioned training.
2. A till prompt system will be utilised at the premises in respect of alcohol
3. A refusals register (whether kept in written or electronic form) will be maintained at the premises and will be made available for inspection by an authorised Officer of the Police or the Local Authority.





> I write in connection with Iceland's application for alcohol sales from 8am-11pm.  
>  
> I feel strongly that the request should be denied and the hours should be limited to that of the neighboring store, Lidl, i.e. 9pm.  
>  
> As a resident of Cecil Road, I am growing increasingly concerned by anti-social behaviour, particularly concentrated in the local park, Cecil Road and the surroundings of Enfield library. Since the opening of Lidl, I have also noticed a significant rise in the amount of rubbish in the surrounding streets, overflowing bins, abandoned trolleys and discarded gum on the pavement.

> The local area is largely residential and there are enough shops nearby where alcohol can be purchased late at night. The close proximity of Iceland to the town 'hotspots' for anti-social behaviour will encourage problems and, undoubtedly, cause misery for local residents.

> I urge you to curtail the hours requested by Iceland and prioritize the needs of local residents.

I live on Cecil Road, just along from the Iceland store which is due to open shortly. I have some concerns about their application for a licence to sell alcohol until 11.00pm.

While I welcome the arrival of a new store rather than having yet another empty unit in Enfield Town, and am looking forward to visiting an Iceland for the first time in several years, I would question their opening until 11.00 o'clock at night in this largely residential area, especially when no other shops in the town do. While the Sainsbury's on London Road is currently open until that time and sells alcohol, and I am not aware of particular problems for homes in the vicinity, I wonder if it's a different sort of "passing customer" here. We see a lot of groups of youths congregating in the area and if they are hanging around the bus stops outside Lidl (which currently closes at 9.00pm) and the new Iceland, the late availability of alcohol might be a magnet for more anti-social behaviour. We have noticed such behaviour is on the increase anyway and (since this is on the subject of alcohol), I do often get beer bottles and cans discarded in my garden.

Speaking to neighbours, many of us are of the same mind. We hope you will give the application very careful consideration. It would at least be reassuring to know decisions to grant such late licences, especially in residential areas, are not made lightly and hopefully the situation would be monitored were the application to be successful.

## Annex 5

### **Conditions Agreed between the Applicant and the Responsible Authorities**

#### Annex 1 - Mandatory Conditions

The Mandatory Conditions are attached and form part of the Operating Schedule of your licence/certificate. You must ensure that the operation of the licensed premises complies with the attached Mandatory Conditions as well as the Conditions in Annex 2 and Annex 3 (if applicable). Failure to do this can lead to prosecution or review of the licence.

#### Annex 2 - Conditions consistent with the Operating Schedule

1. There shall be no adult entertainment or services, activities or matters ancillary to the use of the premises that may give rise to concern in respect of children.
2. All staff involved in the sale of alcohol shall receive induction and refresher training (at least every six months) relating to the sale of alcohol and the times and conditions of the premises licence.
3. All training relating to the sale of alcohol and the times and conditions of the premises licence shall be documented and records kept at the premises. These records shall be made available to the Police and/or Local Authority upon request and shall be kept for at least one year.
4. A 'Challenge 25' proof of age scheme shall be operated and relevant material shall be displayed at the premises.
5. A record of refused sales shall be kept on the premises and completed when necessary. This record shall be made available to Police and/or the Local Authority upon request and shall be kept for at least one year from the date of the last entry.
6. The Designated Premises Supervisor shall regularly check the refusals system to ensure it is being consistently used by all staff.
7. An age verification till prompt system shall be used for all alcohol sales.
8. A digital CCTV system must be installed in the premises complying with the following criteria:
  - (1) Cameras must be sited to observe the entrance and exit doors the alcohol displays and retail floor areas.
  - (2) Cameras on the entrances must capture full frame shots of the heads and shoulders of all people entering the premises i.e. capable of identification.
  - (3) Cameras overlooking floor areas should be wide angled to give an overview of the premises.
  - (4) Provide a linked record of the date, time, and place of any image.
  - (5) Provide good quality images.
  - (6) Operate under existing light levels within the premises.
  - (7) Have the recording device located in a secure area or locked cabinet.
  - (8) Have a monitor to review images and recorded picture quality.
  - (9) Be regularly maintained to ensure continuous quality of image capture and retention.

- (10) Have signage displayed in the customer area to advise that CCTV is in operation.
  - (11) Digital images must be kept for 28 days.
  - (12) Police or authorised local authority employees will be provided access to images upon the making of a reasonable request to the Premises Licence Holder.
  - (13) Appropriate staff shall be trained to operate the CCTV system and download images/footage upon reasonable request by Police or authorised local authority employees.
  - (14) The equipment must have a suitable export method, e.g. CD/DVD writer so that the police can make an evidential copy of the data they require. This data should be in the native file format, to ensure that no image quality is lost when making the copy. If this format is non-standard (i.e. manufacturer proprietary) then the manufacturer should supply the replay software to ensure that the video on the CD can be replayed by the police on a standard computer. Immediate copies must be made available to Police or authorised local authority employees on request.
9. An incident log (whether kept in written or electronic form) shall be retained at the premises and made available for inspection by an authorised Officer of the Police or the Local Authority.
10. The premises will be fitted with a burglar alarm system.
11. The premises will be fitted with a panic button system for staff to utilise in the case of an emergency.

**ANNEX 4****Conditions as agreed by Applicant & Responsible Authorities****Annex 1 - Mandatory Conditions**

The Mandatory Conditions are attached and form part of the Operating Schedule of your licence/certificate. You must ensure that the operation of the licensed premises complies with the attached Mandatory Conditions as well as the Conditions in Annex 2 and Annex 3 (if applicable). Failure to do this can lead to prosecution or review of the licence.

**Annex 2 - Conditions consistent with the Operating Schedule**

1. There shall be no adult entertainment or services, activities or matters ancillary to the use of the premises that may give rise to concern in respect of children.
  
2. A digital CCTV system must be installed in the premises complying with the following criteria:
  - (1) Cameras must be sited to observe the entrance and exit doors both inside and outside, the alcohol displays, and floor areas.
  - (2) Cameras on the entrances must capture full frame shots of the heads and shoulders of all people entering the premises i.e. capable of identification.
  - (3) Cameras overlooking floor areas should be wide angled to give an overview of the premises.
  - (4) Provide a linked record of the date, time, and place of any image.
  - (5) Provide good quality images.
  - (6) Operate under existing light levels within and outside the premises.
  - (7) Have the recording device located in a secure area or locked cabinet.
  - (8) Have a monitor to review images and recorded picture quality.
  - (9) Be regularly maintained to ensure continuous quality of image capture and retention.
  - (10) Have signage displayed in the customer area to advise that CCTV is in operation.
  - (11) Digital images must be kept for 28 days.
  - (12) Police or authorised local authority employees will have access to images at any reasonable time.
  - (13) All staff engaged in the sale/supply of alcohol shall be trained to operate the CCTV system and download images/footage upon request by Police or authorised local authority employees.
  - (14) The equipment must have a suitable export method, e.g. CD/DVD writer so that the police can make an evidential copy of the data they require. This data should be in the native file format, to ensure that no image quality is lost when making the copy. If this format is non-standard (i.e. manufacturer proprietary) then the manufacturer should supply the replay software to ensure that the video on the CD can be replayed by the police on a standard computer. Immediate copies must be made available to Police or authorised local authority employees on request.

- 3. Signs shall be prominently displayed on the exit doors advising customers that the premises is in a 'Designated Public Place Order' and that alcohol should not be taken off the premises and consumed in the street. These notices shall be positioned at eye level and in a location where those leaving the premises can read them.**
- 4. All staff involved in the sale of alcohol shall receive induction and refresher training (at least every three months) relating to the sale of alcohol and the times and conditions of the premises licence.**
- 5. All training relating to the sale of alcohol and the times and conditions of the premises licence shall be documented and records kept at the premises. These records shall be made available to the Police and/or Local Authority upon request and shall be kept for at least one year.**
- 6. A 'Think 25' proof of age scheme shall be operated and relevant material shall be displayed at the premises.**
- 7. A record of refused sales shall be kept on the premises and completed when necessary. This record shall contain the date and time of the refusal, a description of the customer, the name of the staff member who refused the sale, and the reason the sale was refused. This record shall be made available to Police and/or the Local Authority upon request and shall be kept for at least one year from the date of the last entry.**
- 8. The Designated Premises Supervisor shall regularly check the refusals system to ensure it is being consistently used by all staff.**
- 9. Prominent, clear and legible notices shall be displayed at all public exits from the premises requesting customers respect the needs of local residents and leave the premises and area quietly. These notices shall be positioned at eye level and in a location where those leaving the premises can read them.**
