### **674. WELCOME AND APOLOGIES**

Councillor Jewell welcomed everyone to the meeting. Apologies for absence had been received from Councillor Vince, Anolue and Tony Theodoulou. Apologies for lateness received from Councillor Georgiou.

### **675. DECLARATIONS OF INTEREST**

There were no declarations of interest.

### **676. MINUTES OF THE PREVIOUS MEETING**

The minutes of the previous meeting held on the 24<sup>th</sup> July 2018 were **AGREED**

#### Matters Arising

- Anne Stoker advised dates will be circulated to members regarding MASE (Multi Agency Sexual Exploitation) meetings which are convened monthly and police led to share information and intelligence
- The Chair advised the terms of reference of the Vulnerable Young People Task Group in the Councils Constitution have been amended to show the proportionality change of members for the group
- Anne Stoker informed the task group that she is in negotiations with Enfield Strategic Partnership to fund the theatre play "Chelsea's Choice" to be performed in schools, also Enfield Strategic Partnership have also been engaged regarding funding a production on "County Lines"

- Councillor Lappage also advised the Task Group on a similar production company called Platinum Performing Arts based at the Millfield Arts Centre on key themes such as knife crime.

### **677. SECTION 11 AUDIT**

Andrea Clemons, Head of Community Safety tabled the Contextual Safeguarding Report.

NOTED:

- Section 11 of The Children's Act 2004 requires that agencies have in place safeguarding arrangements
- To ensure that Enfield Council is meeting its obligation, the Chief Executive requested a self-audit and subsequent report by the Safeguarding Children's Board Chair and conducted an internal inspection of how services meet the Sect 11 requirement
- A panel comprising of The Chief Executive of the Council, Independent Chair of the Children's Safeguarding Board and Senior Nurse from NHS England provided challenge and scrutiny to the self-audit findings
- Andrea highlighted an example of Contextual Safeguarding work at Ponders End Park. Police Officers and ASB Officers investigated and agreed a response to disrupt drug dealing. Actions taken included Installation of CCTV and briefing staff, trimming trees and bushes, joint operation with the police, commissioning of Oasis to provide youth outreach work, removal of small covered shelters which was being used as cover
- Challenges going forward include having access to enough resources to meet increasing demand, with particular focus on early help
- Applications have been made for external funding, agencies are working more closely, and intelligence is shared more effectively to support young people and their families.

Andrea Clemons then invited the task group for questions and comments.

Q1.

When the five service leads were interviewed regarding how services met the Section 11 requirement. Were they happy to co-operate and keen to assist?

A.

Yes, all services assisted with internal inspections

A comment was made highlighting early intervention as a priority and advised the work at the Ponders End Park has made a big difference.

It was also highlighted that the work on fireworks night with trading standards to tackle underage sales had a positive impact on Turkey Street and Enfield Highway wards.

### **678. SAFEGUARDING ADOLESCENTS FROM EXPLOITATION STRATEGY**

## VULNERABLE YOUNG PEOPLE TASK GROUP - 13.9.2018

Harriet Potemkin, Strategy & Policy Hub Manager and Arzhang Yusefi, Policy & Strategy Officer presented the Safeguarding Adolescents from Exploitation and Abuse Strategy.

### NOTED

- Harriet Potemkin highlighted this was a multi-agency partnership strategy owned by ESCB and will be replacing the current CSE (Child Sexual Exploitation) Strategy 2014
- Current context covers CSE, Criminal exploitation, School exclusion and Children missing from home, care & education.
- Consultations were held with 23 young people affected by exploitation and 25 parents who are members of PEP in summer 2018.
- Feedback from Young people and parents were gathered, and recommendations were made from both parties.
- Visions and Strategic Priorities were identified as prevention and early intervention, protecting and supporting victims and disrupting and stopping perpetrators
- Next steps to be taken were;
  - A. Present a refined version to the VYP Subcommittee of the ESCB on the 24<sup>th</sup> September
  - B. Conduct a partnership workshop to discuss and further develop strategy on the 28<sup>th</sup> September
  - C. Present the finalised version for approval at the ESCB meeting on the 3<sup>rd</sup> December
  - D. Launch the Strategy in January/February 2019.

Harriet Potemkin, Strategy & Policy Hub Manager and Arzhang Yusefi, Policy & Strategy Officer invited the task group for questions and comments.

1.

The Chair acknowledged the proposed vision but highlighted there is a group of victims we have missed e.g. before students leave school. Are they being advised about their rights and how to deal with being bullied or exploited?

A comment was also made supporting the chairs comments, adding that young women working in bars are being harassed. Have they been supported regarding their rights and dealing with these situations?

A.

Harriet Potemkin advised that this is valuable feedback and will investigate supporting the groups of young people and will feedback at the next meeting.

2.

It was highlighted former gang members are working with young offenders/victims at Albany Park and that working with the community to identify individuals who can be positive role models for young people have a huge impact on prevention and early intervention.

It was also mentioned that as per the parents feedback it is vital that empowering individuals, families and communities to report incidents of violence and crime should be a primary focus.

3.

A comment was raised that an action plan should be devised at this stage and why does it take so long to implement strategy (January/February 2019)

A.

Following the week after the 28<sup>th</sup> October 2018, the Strategy will push for early implementation, the reasons for the delay was that there are many partners who are involved in the strategy and to also ensure that all areas are covered before putting strategy into place.

4.

It was raised that the structure is not clear and there isn't anything different to other strategies and projects that have been proposed in the past.

A.

Angela Bent advised that bringing in young people and parents as well as other organisations it's hoped will have a positive effect on the strategy.

Anne Stoker added that at present Enfield have a very strong CSE team and partnerships with community safety, gangs and county lines have never been stronger.

5.

It was advised that the order of the vision and strategic priorities were the wrong way around and that disrupting and stopping perpetrators should be first.

A.

Harriet Potemkin advised that strategy will be looked at taking the comments from the task group on board, the partnership workshop on 28<sup>th</sup> will allow her team to work with the organisations and businesses.

# Enfield CSEP Team

Enfield CSEP team was established in July 2015.

Based at Triangle House, Palmers Green since May 2017

- Service Manager for LAC and Leaving Care and CSEP
  - One Team Manager
  - Three social workers
  - Two youth workers
  - One Triage Worker
- Four police officers (based at Edmonton Police Station)
  - Safer London worker
- Child Exploitation and Vulnerability Co-Ordinator

# Work of the Team

- **Referrals Via Single Point of Entry or Referral and Assessment Team.**
- **Child and Family Assessments**
- To ascertain if the young person is a victim of ongoing CSE and if any interventions are needed to support the family and young person.
- **Outcome of assessment might be;**
- Child in Need plan
- Child Protection Plan
- Looked After Child.
- Information and Advice
- Youth worker support
- **Preventative Work**
- Presentations in Schools
- CSE awareness Assemblies and Group work
- Residential units
- Youth Centres

## Child in Need Plan

1. Aim to support the family and young person to remain at home.
2. Package of support including Youth worker to do direct one to one sessions, educational CSE awareness sessions.
3. Practical support – e.g. Support to attend Sexual Health Clinic / Accessing Education / Accessing Therapy.
4. Family work – Social workers can provide family work / Precious moments/mediation.
5. Multi- Disciplinary work – CSE police / SET at Stratford / Trident/Health / Education.
6. Regular Strategy Meetings
7. Disruption - Police can issue CAWN's (Child Abduction Warning Notices) or SRO (Sexual Risk Orders)
8. Referrals CAMHS / HEWS / SAFE / Brandon Centre MST /PAARS (Parent Abuse and Reconciliation Service) /YUVA (DVIP)
9. Core Group every 6 weeks
10. Case reviewed every 3 months

## Contextual Safeguarding

- Changing the focus from individual case work to making communities safer.
- MACE Meetings – Share information with partner agencies and identify problematic areas – Schools / Parks /Local Areas.
- Educational sessions in Schools, Youth Clubs, Residential Units.
- Meetings with Community Safety Team and Tasking Force re Ponders End Park
- Actions around a particular school with drug / gang issues.
- Action re McDonalds on Fore Street
- Local Shops – Off Licence /Kebab Shop/ Tatoo Parlour
- Training other Teams

## **CSE Awareness work**

- **CSE awareness / Educational work.**
- Direct one to one sessions.
