# 163. WELCOME & INTRODUCTIONS

The Chair welcomed everyone to the meeting.

# 164. APOLOGIES

Apologies had been received from Sheila Stacey, Harry Landsman and Pat Jackson.

# 165. CHAIRS FEEDBACK

The meetings that the Chair has participated in this period are: Safer and Stronger Communities Board, Safer Neighbourhood Board Chairs meeting in New Scotland Yard on two occasions and chaired the Hate Crime Case Management Panel twice.

The Chair and Susan O'Connell met with Havana, the new MOPAC representative for Enfield, and Julie Taylor and the Chair met with Galop regarding domestic abuse reporting and support in the LGBT Community.

The Chair gave a talk about SNB's to the EREC/LBE equalities meeting this month.

On Monday evening at the Safer Neighbourhood Board Chairs meeting we had a presentation about the new way CAPE's (Ward Panels) will be working. This raised lots of concerns on the direction of the CAPE's going forward. There was lots of heated debate and an updated presentation will be sent through to the SNB Chairs, hopefully this can come to the next SNB meeting.

The Chair raised the issue of ward boundary changes and where were the extra 16 or 17 officers coming from? Tim was assured that the mayors promise would be honoured, and extra officers would be provided.

Stop & Search group provided feedback, there is a meeting next Tuesday and this is going well. The computer issues have been resolved so footage can be viewed. The group receive reports and view footage and provide a critical friend approach.

The CCTV Monitoring Station Group has not visited for a while, but there are 6 trained volunteers who visit and make random inspections. Tim advised that he will need to step down from this group due to his other commitments. Sheila will send an email round to ask for another interested party. give some feedback today.

It was agreed to change the order of the agenda items 5 and 6 but for the minutes the order will remain unchanged.

# 166. MINUTES OF PREVIOUS MEETING

The minutes from the meeting 24 April 2019 were agreed.

# 167. PROPOSAL TO CHANGE THE ENFIELD SAFER NEIGHBOURHOOD CONSTITUTION

The proposed changes were noted and that this would need to be ratified at the AGM meeting in April 2020.

At this time the Constitution will also be looked at again as Safer Neighbourhood Board have now been in place for five years so this also needs updating and removing information that is no longer valid.

# 168. BRIEFING ON DOMESTIC VIOLENCE

Julie Tailor, Domestic Violence Co-ordinator presented this report and highlighted the following:

- The report provided an overview of domestic violence and abuse and the work undertaken in this area.
- The report provided the government definition of domestic violence and abuse, controlling behaviour and coercive behaviour
- The domestic abuse statistics for Enfield showed that Domestic Abuse, Sexual Offences and Rape Offences had all decreased over the last 12 months, but Domestic Abuse Violence with Injury offences had increased.
- Ideally, we would like to see the number of domestic abuse incidents increase as this is viewed as an increase in awareness of services and an increase in the confidence to report and a decrease in violence with injury as would hope that early intervention work would reduce this figure.
- Multi-agency risk assessment conference (MARAC) was covered in detail in the report explaining- who attends, what the purpose is; how often this is held in Enfield and the categories of referral.
- The role of independent domestic violence advocate (IDVA) is to address the safety of victims at high risk of harm and they normally

work with victims from the point of crisis. The advice and support they offer was detailed in the report.

- The Protection orders that are available and are used dependent on the situation and the victims wishes were detailed in the report
- In Enfield there are 4 IDVA's at Edmonton Police Station, I is dedicated to Enfield residents; 2 IDVA's at North Middlesex Hospital in the A & E department; 1 IUDVA dedicated to the children centres; 2 new additional IDVA's will be based in the borough, location to be determined but this is likely to be at the police station; 1 new IDVA will be based in Chase Farm Hospital; 2 IDVA's at Highbury Court and Children's services are creating a Domestic Abuse team which will include 2 domestic abuse managers and 6-7 domestic abuse trained social workers.
- The Draft Domestic Abuse Bill was published in 21<sup>st</sup> January 2019, there was a further hearing on the 16 July and will need to be another hearing, the date for this is unknown at present. The key measures within this were detailed in the report.
- A link to the Violence Against Women and Girls Strategy was provided in the report and some details of previous campaigns that had been run were provided.

Board members welcomed conversations on this subject and felt this was a step in the right direction. Violence against women and girls had been agreed as one of the priorities by the Safer Neighbourhood Board.

Co-location at the police station was viewed as very helpful by the police.

Coercive control was discussed, whilst this is law it is currently very difficult to prove and there has only been one conviction.

Following a question on contact with GP's details were provided of the Iris Project who have 2 outreach workers who train GP's and provide support services. Many of Enfield's GP's are signed up to this.

Julie was thanked for her presentation.

# 169. NORTH AREA BOROUGH COMMANDER TREENA FLEMING

Treena Fleming, introduced herself she has now been in post 3 months and was previously working at Camden & Islington setting up the Safeguarding strand for the Met. She highlighted the following:

- Her vision and priorities are to:
  - Reduce ASB and repeat victimisation
  - Reduction of violence with injury; all residents should feel safe
  - Stop young people carrying knives
  - Reduction of burglary
- Prevention and enforcement are key, it is important to safeguard residents.

- She would like to see an increase in sanction detections for all (Total Notifiable Offences) to help instil confidence that offenders will be punished, and justice prevails
- Fear and perception of crime needs to be addressed so that people are aware of the realistic picture and the actions that the police are taking to address issues.
- It is key that the police response is right first time whatever the offence is
- There is a positive arrest policy for domestic abuse even if the victim does not want to press charges. This allows pause for thought and assists with safeguarding the victim and ensuring that multi agency support can be provided.
- Enhance trust with communities and how this could be improved. Including enhancing trust with young people. This will be through ward panels, community meetings, Independent Advisory Group and the Youth Independent advisory Group
- Adopt a trauma informed approach always thinking about safeguarding
- Further promotion of Crime stoppers, this is totally anonymous and helps provide intelligence

Further comments and questions were raised:

- Further to concerns raised on burglary in Cockfosters, with regards to response officers not having enough time to investigate. Treena advised that NA BCU are 7 months into the new policing model so there will be challenges. It is important to get it right first time at the scene. Every police officer should see themselves as an investigator and we need to equip our officers with appropriate training/ experience to be a good investigator. If resourcing is an issue in a particular area/crime type, then the new model allows for there to be much better flex of local resources where appropriate.
- Shift patterns are currently being reviewed, this is in consultation at present and should better allow for resources to be in the right place at the right time around the patterns of crime
- In response to how the police work with other boroughs, Treena advised that there are only 12 BCU's across the Met. They meet every month exploring crime types, best practice working together for the best response. They are also working with Herts.

# 170. EXAMINATION OF CRIME STATISTICS

The report on crime statistics had been circulated in advance with agenda papers. The chair reminded board members to prepare questions.

Superintendent Sheikh provided more up to date information and highlighted:

- There has been an increase in total Notifiable Offences to 9%, this is above the Met average of 6.4%
- Reviewing which wards are suffering the most, what resilience is there to meet demand and the use of Pulse Patrols

- Pulse Patrols will be used to blitz areas for 45 minutes talking to and engaging with residents, creating a police presence.
- Pulse patrols, where an increased number of officers are in an area for a period to patrol the area, actively engage with the public to gather any intelligence on issues and deter criminals from operating in the areas. This proactive style of policing which will involve looking at officer shift patterns
- This will involve change of hours, so this is in consultation at present and will conclude in approximately 2 months
- All unmarked police cars will be marked in future to improve visibility and to deter crime

Following a query that burglars often don't live in the borough, it was explained that they do tend to stick to same routine and areas and that the police do work with counterparts in other boroughs.

In response to a query on target establishment the Board was advised that 47 new officers will be coming through from now to December. With regards to DWO's, there was 1 vacancy in Winchmore Hill; the replacement will come through in September. There will be a further vacancy in Chase, this will go to local resources to allocate a replacement.

Planned and current operations

- There had been an extensive police operation in Ponders End resulting in 24 arrests and 93 Sanction Detections. This could be bought back in future to the Board as a case study. However, this is currently going through the legal process, so no further information can be given
- Following an increase in robberies in Enfield Town over 6-8 weeks, an operation involving extensive use of CCTV and working with McDonalds had resulted in 4 people being arrested and the number of robberies has now reduced to 2 a month.
- Roads Transport Police have undertaken well-advertised work on the issues on the A10 resulting in:
  - Speeding -147
  - Drink/Drug Driving- 5
  - No insurance-7
  - Stolen vehicles- 6
  - o S59 notices- 9
  - Vehicle defect -36
- Prostitution in Fore street, the number of sex works has increased recently. This is believed to be a result of work undertaken in Redbridge which has displaced sex workers. An operation is due to start in August for 2 weeks involving enforcement and outreach workers to work with the sex workers.
- Burglary issue in Lower Edmonton and Upper Edmonton- officers to provide prevention advice to whole streets not just affected property
- Enfield have introduced meet on your street sessions with the Police, this is proving successful and more people are engaging this way

- Operations on burglary taking place in highlands in a similar way to what had previously taken place in Cockfosters.
- Talked about Neighbourhood Watch and Streetwatch and how these should be increased and spread across the whole of Enfield.

I and S Calls

The I grade calls (response within 15 minutes) has been maintained at 83.3% which is the same as last year.

The S grade calls are at an average of 82.4%throughout the year.

The Chair and Susan O'Connell will meet with the police to discuss how future information is provided to the board.

# 171. ANY OTHER BUSINESS

The Chair advised that a number of bids had been received and were being reviewed they total £26,400. Enfield's allocation is £26,838, the deadline for the SNB funding application to be submitted to MOPAC is the  $2^{nd}$  August.

At the next meeting of the SNB details would be provided of what funding had been agreed.






# **Statutory Court Orders**

# MPS Safer Schools Officers – Briefing Note

There are currently 2.3 million young people (YP) in London, representing 25% of the overall population, and this will increase by 2020. Safer Schools Officers (SSOs) form part of the BCU Youth Team (Neighbourhoods) which also consist of Youth Engagement Officers (YEOs) and VPC Co-ordinators. The MPS currently has 630 Safer Schools Partnerships in place with Schools and Colleges across London.

### **Objectives**

To meet Mayoral Commitments, the MPS Business Plan and address high harm offending, Schools officers' activity should be focused around following three core principles:

### Deter, Detect and Divert.

Schools officers will deliver a sustained and familiar visible presence that:

- Minimises the risk of Anti-Social behaviour (ASB), serious youth violence (SYV) and Child Sexual Exploitation (CSE)
- Increases actionable intelligence on weapon carriage and storage, and the times, places and events that present risk of serious youth violence
- Significantly reduces the number of young victims of violence
- Increases engagement with YP, parents and teachers
- Provides reassurance to YP, parents and the wider community
- \* Deliver early intervention and diversion through restorative approaches and multi-agency referrals
- Deliver targeted prevention messages on High Harm, High Risk topics
- Schools officers will perform weapon sweeps of


SSOs will deploy between 1500-1800 hours each weekday in and around schools, colleges and key transport routes and interchanges to provide visible reassurance and prevent violence offences.

- The MPS Children & Young People (C&YP) Strategic Plan provides a focus on the areas of risk and harm that affect YP the most, from SYV, Gang involvement, Weapons and knife crime, to domestic abuse (Op Encompass), hate crime, Sexual offences, CSE, Extremism and radicalisation.
- The Youth Engagement & Crime Prevention plan for each BCU/Borough enables supervisors to strategically plan yearly activity and target areas of risk and harm for YP at key times.
- With the new YEO role, we plan to enhance partnership working with Youth Offending Services (YOS) & YP within the system to prevent recidivism. Through the YEOs, SSOs will utilise diversion schemes more effectively to deal with those on the cusp of offending as well as persistent young offenders.
- We will refresh the Safer Schools Activity Matrix to refocus SSO problem solving and enforcement activity in schools and Pupil Referral Units on violent crime and high harm offending. For example, enhance SSO input into the Gang Matrix, proactively identify gang members and those on the periphery of gang membership in schools (siblings of gang members, girls in gangs, etc.), proactively identify habitual knife carriers through support of adhoc searching in schools, screening arch operations and weapon sweeps, etc.
- The VPC is the Mets diversion programme for YP with over 5,100 cadets. We actively encourage referrals into the VPC programme from SSOs, YOTs and youth partner organisations. 30% of cadets are defined as vulnerable. 57% are BAME.
- The VPC on every borough will continue to perform monthly smart water operations, weapon sweeps and test purchasing Operations to combat CSE (Op Makesafe), the sale of weapons (Op Sceptre) & alcohol to those under age.
- We have a resource hub of corporate educational presentations in which over 590 officers currently have access. It contains presentations on county lines, Trident inputs on gangs and consequences, knife crime, etc. The delivery of these presentations is targeted through the use of the Youth Engagement & Crime Prevention plan and emerging local issues identified by SSOs

### Safer Neighbourhood Board Report 3<sup>rd</sup> October 2019.

### **Performance Framework**

#### • Summary

Total Notifiable Offences in Enfield have increased by 7.7% in the year ending August 2019. In London, there has been a smaller increase of 6.8% in the same period.

Residential Burglaries in Enfield have increased by 8.1% in the year ending August 2019.

Enfield is currently the 2<sup>nd</sup> highest borough in London for Serious Youth Violence victims and has increased by 8.8% in the year ending August 2019, compared to the last year. London has seen a small increase of 0.5% in the same period.

Domestic Abuse Violence with Injury has increased in Enfield by 3.9% in the year to August 2019.

ASB calls have increased in Enfield by 6.8% in the year ending August 2019, compared to same period in the previous year.


### • Serious Youth Violence

There were 421 Serious Youth Violence victims<sup>1</sup> in Enfield in the year ending August 2019, an 8.8% increase, compared to the same time in 2018, when 387 victims were recorded. London experienced an increase of 0.5% in the same year.


The borough of Enfield recorded the second highest number of Serious Youth Violence victims out of all the 32 London boroughs, ahead of our bordering borough Haringey recording 383 victims. Currently the borough of Westminster is the highest borough, recording 519 victims in the same period.

On average, Enfield recorded 35 serious youth violence victims a month in the last year, equating to just over one victim per day.

Since April 2019, the number of SYV victims in Enfield continued to increase until they peaked in July 2019, a strong contrast to the pattern experienced the same time the previous year. However, the number of victims recorded in August 2019 dropped significantly, mirroring the pattern experienced in London. This reduction in victim numbers may be due to the school summer holidays.


# Charts 3-12: The below graphs show Enfield's position out of the 32 London boroughs for weapon enabled offences recorded to the year ending August 2019.








### <u>Knife Crime in Enfield</u>

In the year ending August 2019 Knife Crime<sup>4</sup> in Enfield has increased by 11.1%, compared to the previous year. London has experienced a small decrease of 1% in the same period.

On average there has been 56 knife crime offences per month in the year ending August 2019, compared to 50 per month the previous year.

Knife Crime offences have continued to rise month on month since April 2019, peaking in June 2019. However, number of offences have fallen in August 2019 recording 48.



### Knife Crime Possession Offences

In the year ending August 2019 Knife Crime Possession offences increased by 16.4%, compared to the previous year. London has experienced a 2.9% reduction in the same period.

The number of Knife Possession offences have continued to fall from June 2019 in Enfield, remaining steady in August 2019.






#### Knife Crime with Injury

In the year ending August 2019 Knife Crime Injury offences had decreased by 15.1%, recording 157, compared to previous year of 185. In London there was a reduction of 13.9%.

Since February 2019, knife crime with injury offences were increasing month on month, however, in June 2019 this trend ended, and offences have continued to fall to August 2019.





## <u>Non-Domestic Knife Crime Injury Victims</u> <u>Not DA Under 24</u>

Non-Domestic Knife Crime victims under 24 make up 48% (n=76) of all knife crime injury victims in Enfield and overall there has been a reduction of 17.4%, with 76 victims in the last year, compared to 92 the previous year.

In London there was a reduction of 18.9% recording 1,647 victims, compared to 2,032 the previous year.

Like knife crime injury, victims of knife crime under 24 have also experienced a further decline in offences in August 2019, after a continual rise between March to May 2019.

### Gun Crime

Gun crime<sup>5</sup> offences in Enfield increased by 3.7%, recording 112 offences in the last year to August 2019, compared to 108 the previous year. London experienced a 12.8% decrease in the same period.

In August 2019, Gun crime offences peaked to 13 offences, the second highest month in 2019.





### <u>Gun Crime Lethal Barrelled</u> <u>Discharged Offences</u>

Gun crime lethal barrelled offences in Enfield recorded 20 in the year to August 2019, more than double when compared to the 9 offences the previous year.











When considering the age group and the reason for the arrest, the top two age groups recorded were the 15 to 19-year olds that accounted for 28% of all individuals arrested, followed by those aged between 20 to 24 years old recording 26%. These age groups recorded the highest overall for arrests for drugs and weapons, points and blades.

Drugs and weapons, points and blades<sup>6</sup> were the most prevalent arrest types throughout the borough accounting for 62% of all arrests. The wards Edmonton Green and Upper Edmonton recorded the highest proportion of both drug and weapons, points and blades.

#### **Reducing Burglary and Keeping People Safe in the Home**

#### • Residential Burglary


There were 2,597 Residential Burglaries in Enfield in the year ending August 2019, compared to 2,402 in the previous year, an increase of 8.1%. Enfield is significantly above London which recorded an increase of 0.8% in the same period.

Enfield is a large borough with an estimated 131,707 households (GLA Estimates 2017) which equates to a rate of 20 residential burglaries in the last year per 1,000 households in Enfield, compared to 22 residential burglaries<sup>7</sup> in our neighbouring borough Haringey.

Although there has been an increase of 8.1% in residential burglary in Enfield year on year, since January 2019, there has been a steady decline in residential burglaries in Enfield. This pattern in Enfield has also mirrored the pattern for residential burglaries in the capital in the same time.

However, it is evident from the past two years seasonal trends in residential burglary that this downward trend may increase from September 2019 onwards as the darker evenings set in and with the run up to the Christmas period, as it has done previously in both Enfield and in London.



The wards with the highest volume of residential burglaries in the last year were Upper Edmonton, followed by Enfield Highway and Enfield Lock. Upper Edmonton and Enfield Lock have the highest household populations in Enfield according to the Census 2011 and have a burglary rate of 31 and 26 per 1,000 household respectively. While Enfield Highway has the smallest household population of these top three wards, it has the second highest rate of 29 burglaries per 1,000 households.

In contrast Lower Edmonton for example, has a high number of households and low rate of 16 burglaries per 1,000 households.

Southgate Green and Palmers Green wards all experienced a high reduction in burglaries in the same period. However, when considering the rate per 1,000 households they both had relatively high rate of 23 burglaries in each ward in the same period.

#### Enfield Prolific Burglar Profiles (IOM Cohort 06/09/2019)

We looked at the small number<sup>9</sup> of prolific burglars currently being managed by the Integrated Offender Management (IOM) police team based in Enfield. The IOM team is a multi-agency partnership team approach that brings together key partners to supervise, manage and positively impact on the criminal activities of offenders in the community, with intention to disrupt recidivism among the most prolific offenders.

When considering the offender profile of the small number of prolific burglars managed by the IOM team, they were typically male of white ethnic appearance, ages ranging between 28 and 43, the average age being 35 years old. The offending patterns of all these individuals are linked to supporting drug dependency issues and their offending is predominantly within the borough of Enfield, the surrounding borough of Haringey and the county of Hertfordshire.

The youngest age for the first burglary conviction for individuals in this cohort was 13 and the oldest was 29, with an average age of 18 years old and collectively this cohort has a total of 152 burglary convictions.



Overall this small cohort was responsible on average for 14 convictions each, suggesting that these individuals have been influenced into a life of crime from a young age and commit crime to support their substance misuse issues and life style.

Using police data from CRIS regarding all those accused<sup>10</sup> of committing a residential burglary on the borough between September 2018 and August 2019, it is evident from the below map that at the time of this report the majority of those accused reside in the north and western London boroughs, with a small number from the northern counties of Hertfordshire and Essex suggesting they have travelled into the borough to offend.

## Map 2: The below map demonstrates the borough of residence of those individuals accused of residential burglaries in Enfield, between September 2018 and August 2019.



Where the value of property stolen from residential burglaries was recorded on the CRIS system it was valued between £100 and £25,000. Typically, it was high value pieces of jewellery taken from burglaries, for example high value watches, earrings, that can be sold on quickly, particularly made of gold. After jewellery, items such as cash and credit cards were frequently stolen, followed by electrical equipment such as laptop computers and entertainment equipment.



#### Tackling Violent Crime in all its forms.

#### <u>Violence Against the Person in</u> Enfield

In the year ending August 2019 there were a total of 7,571 Violence Against the Person offences (VAP)<sup>11</sup> recorded in Enfield, compared to 6,911 offences the previous year, equating to an increase of 9.5%. In London, there was a smaller increase of 4.2% in the same period.

VAP offences have continued to increase since April 2019 and peaked in July 2019 recording the highest month so far (n=781 offences). However, in August 2019, the number of offences dropped significantly, recording the least this year with 547 offences.



#### <u>Non-Domestic Violence with Injury</u> <u>Offences in Enfield</u>

In the year ending August 2019 there were 1,700 offences, compared to 1,606 the previous year, equating to an increase of 5.9%. In London there was a decrease of 0.4%.

After offences peaked in June 2019, the number of offences each month has continued to decline recording 121 offences in August 2019.





#### Violence Against Women and Girls (VAWG)

#### Domestic Abuse Incidents

There were 5,793 Domestic Abuse Incidents<sup>12</sup> recorded in the year ending August 2019 in Enfield, compared to 5,665 incidents in the previous year, equating to an increase of 2.3%. In London, there was an increase of 1% in the same period.

Since February 2019 domestic incidents have increased month on month and in July 2019, they reached the highest number for the year with 592 incidents, slightly higher than the same month last year (n=520). However, in August 2019 there was a reduction in incidents, recording 508.

### <u>Domestic Abuse Violence with Injury</u> <u>Offences</u>

Violence with Injury offences which were domestic related have increased by 3.9% in Enfield, recording 979 offences, compared to 942 offences in the previous year. In London, there was a decrease in the same period of 1.2%.



#### <u>Sexual Offences</u>

In the year ending August 2019, reports of Sexual Offences in Enfield increased by 0.3%. There were 629 offences in the year ending August 2018 and 631 offences this year. In London, there was a decrease of 2.3% in the same period.

After a decline in Enfield in the calendar first quarter of 2019, offences in April 2019 experienced an increase and offences have continued to increase to July 2019. However, in August 2019, the number of sexual offences fell in Enfield to 50 offences, compared to 65 the previous month.



Hate crime in Enfield increased by 6.3% in the year ending August 2019 recording 473 offences, compared to 445 in the previous year. In London, there was an increase of 9.6% in the same period.

In August 2019, there was a slight increase in offences, recording 37 offences. This increase maybe due to the increase in Homophobic hate crime reports that have increased on the borough since April 2019, albeit by small numbers, this strand of Hate Crime has experienced the biggest increase, recording 50 offences in the year ending August 2019, compared to 31 offences the previous year.

In London, Hate Crime increased by 9.6% in the same year. Racist Hate Crime recorded the highest numbers of offences, followed by Homophobic Hate Crime.


#### Rape Offences

Rape offences reported in Enfield have experienced a decrease of 0.8%, recording 258 offence by year end August 2019, compared to 260 offences in the previous year. In London, there was a decrease of 4.7% in the same period.

Rape offences have remained steady recording 25 offences both in June and July 2019 and have fallen in August 2019, recording 22 offences.

There have been 487 cases have been discussed at MARAC in the 12 months to the 31st August 2019, which represents a 16% (n=69) increase in the number of referrals, compared to 418 cases the previous year. Of those referrals 15% (n=71) were repeat referrals, increasing from 16% (n=65) in the previous 12-month period.






#### Satisfaction trends over time for victims of crime from MPS


#### Satisfaction trends over time for victims of crime from North Area




