The motion to amend the order of business was agreed and the Motions were taken in the following order: Motion 2, Motion 3, Motion 4 and Motion 1.

Councillor Nesil Caliskan moved the motion and Councillor Claire Stewart seconded the following motion:

*“Enfield Council notes:*

- 1. The incredible dedication and hard work of health workers during the coronavirus pandemic, including those who work in our two local NHS hospitals: Chase Farm Hospital and North Middlesex Hospital.*
- 2. That in marking International Women’s Day on 8th March, we paid tribute to female NHS staff who make up 77% of the total workforce.*
- 3. That the Government’s 1% pay offer to health workers would see them receive a settlement that is in reality a real-terms cut to their pay.*
- 4. That the 1% pay increase does not reflect promises made by Government to value and support NHS health workers.*

*Enfield Council:*

- 1. Believes there should be a far more generous pay settlement that includes a clear pay rise for NHS workers.*
- 2. Supports the British Medical Association (BMA), UNISON and the Royal College of Nursing (RCN) in their condemnation of the 1% pay offer from the Conservative Government.*
- 3. Will join others in lobbying the Government including all affiliated unions in their campaign to improve the pay of NHS workers.*
- 4. To ask our local MPs to call on the Government to deliver fair pay for NHS workers.”*

Councillor Terry Neville moved an amendment to the motion and Councillor Joanne Laban seconded the amendment.

*“Enfield Council notes:*

- 1. The incredible dedication and hard work of health workers during the coronavirus pandemic, including those who work in our two local NHS hospitals: Chase Farm Hospital and North Middlesex Hospital.*

2. *Supports NHS Providers, the British Medical Association (BMA), UNISON and the Royal College of Nursing (RCN) in their demand the government reconsiders its 1% pay offer.*
3. *Will join others in lobbying the Government including to improve the pay of NHS workers.*
4. *To ask our local MPs to call on the Government to support the above."*

Councillor Laban moved, and Councillor Rawlings seconded the below amendment to the motion:

*In seeking a solution to secure the future of Whitewebbs, Enfield Council will enhance the current level of public access at Whitewebbs, maintaining the*

*woodland and open areas, ensure refreshment and welfare for all users of the park, and a more inclusive range of leisure and sports activities.*

*Green and open spaces are important supporting physical fitness, tackling obesity and in maintaining good mental health.”*
