The Chair welcomed everyone to the meeting and apologies for absence were received from Cllr Doris Jiagge, and Cllr Guney Dogan, who was substituted by Cllr Suna Hurman (Deputy Mayor).

5. OFFICERS REPORT ON MAYOR'S CHARITY APPEAL FUND 2021-22

The Trustees and Officers received the Officers' Report in respect of the Mayor's Charity Appeal Fund 2021-2022. The Internal Audit team found no outstanding items of risk to report on this review.

6. MAYOR'S CHARITY APPEAL FUND 2021-2022 UNAUDITED ACCOUNTS AND AUDITORS REPORT

MAYOR'S CHARITY APPEAL FUND MEETING - 30.11.2022

The Trustees received the unaudited accounts and Auditor's report. The Chair asked for any comments or questions, and none were forthcoming.

AGREED: to note the report.

7. LIST OF DISTRIBUTION OF FUNDS 2021-22

The Trustees received the distribution list from Cllr Sabri Ozaydin where a total of £53,203 was received, of which £2,249 was from 2020-2021 and rolled over as agreed previously.

The Chair asked for any comments or questions in respect of the distribution list and the following were received:

Cllr Edward Smith congratulated Cllr Ozaydin on the considerable amount of money raised but voiced his concern that the money should go to a wider range of ethnic groups.

In response, Cllr Sabri Ozaydin explained the cultural differences between the charities chosen. He also reminded the Trustees of his pledge to help and support charities who offer help to women and children against violence and abuse. Many of the charities identified have supported the Past Mayor in his fund-raising endeavours as well as providing much needed guidance and support to the community.

Further clarification was received by Claire Johnson [Head of Governance, Scrutiny & Registration Services.] that all the charities will be asked to respond in writing, advising how they have supported the Mayor, in order to benefit from the contributions they will receive.

The Chair and Cllr Suna Hurman congratulated Cllr Sabri Ozaydin for raising the highest amount of money so far and the current Mayor will also congratulate him at the next Council meeting.

AGREED: the report and distributions.

8. MAYOR'S CHARITY APPEAL FUND 2022-2023

The Trustees received a list of charities identified by the Mayor, Cllr Doris Jagge. The theme for her mayoral year is domestic violence and how it affects the mental health of young people. She will raise awareness during her mayoral year and help as many people as possible.

It was noted that the Multiple Sclerosis Society was not a registered charity (normally a pre-requisite) but in fact a not-for-profit Community Interest Company. Based in Barnet, they help and support residents affected by multiple sclerosis both in Barnet and Enfield.

MAYOR'S CHARITY APPEAL FUND MEETING - 30.11.2022

AGREED: the list of charities chosen by the Mayor, and as long as no further charities are added to the list during the year, the beneficiaries were agreed, including the Multiple Sclerosis Society (CIC).

Purpose of Report

To agree final accounts of Mayors Charity Bank account by the Trustees of the Board.

Recommendation

The Mayors' Office will continue to implement all the recommendations identified in previous years to the best of their ability to avoid any further identifications for the future.

Main Considerations for the Panel

The accounts for 2022-2023 have been independently examined and work has been completed by the Internal Audit team which identified their key findings below.

The draft financial statements were prepared by the Mayoral Services Manager, Koulla Panaretou, for the Mayor of the London Borough of Enfield Appeal Fund, year ended 30 June 2023. The financial statements were prepared using the records maintained by the Mayor's Office. Internal Audit carried out a detailed reconciliation to the bank statements of cash payments and receipts to verify the accuracy and completeness of the underlying records. In addition, Internal Audit considered whether the accounting records had been kept in accordance with the regulations made under the Charities Act 2011.

Only those charities with gross income of more than £25,000 in their financial year are required to have their accounts independently examined or audited. An independent examination is needed if gross income is between £25,000 and £500,000 and an audit is needed where the gross income exceeds £500,000. The Internal Auditors established that procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion was given by Internal Audit as to whether the accounts presented a 'true and fair' view.

Summary by Internal Audit

Internal Audit reviewed the financial statements and accounting records provided. Their review had not identified any significant concerns regarding the accuracy and completeness of the accounting records relating to the Mayor of the London Borough of Enfield Appeal Fund for 2022/23 and they confirmed that the amount available for distribution was £9485.37.

Internal Audit have not identified any further recommendations during the Mayoral year 2022-2023.

Charitable Distributions

We note the Trustees have agreed that donation recipients will provide details of how the donations were spent within a set timeframe for accountability purposes. This will take effect from monies raised during 2021-22. The 2022-23 audit testing will continue to ensure that this is put into practice and evidence provided to them to secure this recommendation.

Donation Distribution List

The Trustees are due to agree the distributions of donations.

Outstanding Information

There are no outstanding items in relation to this review.

Conclusion

The Mayors' Office will adhere to all recommendations identified previously to ensure the smooth running of the charitable account.

SUMMARY

Contractual income and performance related grants

This is only included in the SoFA once the related goods or services have been delivered.

Interest income

This is included in the accounts when receivable.

Expenditure and liabilities

Liability recognition

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources.
