### 4. ITEMS FOR PRESENTATION

# (a) SWERRL: Enfield Behaviour Support Service

This item was presented by Mr Maidens, Head of SWERRL

**RECEIVED** the annual report and a presentation from Mr Maidens key highlights from the annual report.

**REPORTED** the academic year 2022/23 had been particularly challenging because Mr Ellerby-Jones, the previous Head of SWERRL, became seriously ill and Mr Maidens was appointed as the acting Head of SWERRL. Following Mr Ellerby-Jones retirement at the end of October 2023, Mr Maidens was then appointed Head of SWERRL.

Mr Maidens advised the Forum that the service supported children with social, emotional, and mental health needs due to developmental trauma. The Service supported the children through a graduated response that was in line with the strategic vision of Enfield.

#### NOTED:

- (i) For the fifth year, there had been no permanent exclusions at primary level in Enfield. This was below the national average. In order to achieve this, SWERRL provided schools, pupils and parents with targeted support, training / coaching, and modelling. SWERRL also worked collaboratively with partner services, and this included delivering borough wide training.
- (ii) The number of pupils receiving targeted support during 2022/23 had seen a decrease from the previous year and was at similar level to 2020/21. However, there was significant increase in strategic involvement that required working closely with schools to consider and address the needs of pupils within the school environment. In total, there had been 70 requests for pupil support and 40 strategic involvements with schools.

The Forum noted the SWERRL annual report and thanked Mr Maidens for attending to present the annual report.

### (b) London Councils: School Finances and School Places Report

**RECEIVED** outcomes from a survey carried out by London Councils on the year-end position in terms of school finances and school places across London.

#### NOTED:

- (i) The funding issues facing schools were due to cost pressures, falling pupil rolls and the impact of the national funding formula on individual schools.
- (ii) In Enfield, eighteen schools had reported a deficit and their capacity to manage the deficit was difficult because they did not have resources to facilitate a change.

The survey highlighted that this picture was similar to other London LAs and some of these LAs had or were considering closing schools. This had not yet happened in Enfield, however if the pupil numbers continue to decline then consideration would have

to be given to closing schools.

- (iii) The problem for schools were cost pressures and pay awards were not fully funded and there was no marginal funding left in the system.
- (iv) It was commented that fall in pupil roll was a particular challenge for schools and this was then exacerbated by the part funded pay award for teachers and the unfunded pay award for teaching assistants. This was resulting in most schools now either choosing to delay or not recruiting to a vacant post. This position was not tenable in the long term.

The Forum noted London Councils report and findings.

#### 5. <u>ITEMS FOR DISCUSSION & DECISION</u>

# (a) Enfield Nurture Group Outreach and Support Model

This item was presented by Ms Hide, Head of Early Years Social Inclusion

**RECEIVED** a report that gave an update on the delivery of the part-time Nurture Groups and outlined proposals to extend the reach of Nurture Groups.

**REPORTED** Nurture Groups were evidenced-based intervention that aimed to support key stage 1 pupils with social, emotional and mental health needs (SEMH) and attachment difficulties over four school terms by building trust and filling gaps to aid development. .

During the last academic year, the provision supported 220 pupils who presented at least four of the 26 possible needs. The support was provided over four school terms. Ms Hide explained these possible needs in further detail to the Forum. Upon leaving the Nurture Group, the evidence indicated that these pupils were either able to access mainstream education without recourse to an Education, Health and Care plan (EHCP) or the issuing of the EHCP was delayed.

The feedback from schools hosting a Nurture Group was positive. Therefore, the Forum was being asked to consider expanding Nurture Group provision to support more pupils.

Following feedback from the Education Resources Group, the proposals being presented to the Forum were amended to enable up to 15-20 eligible schools to host a Nurture Group. Also, enable other schools to submit an expression of interest in hosting a Nurture Group.

The Service would also provide outreach support to all schools including secondary schools.

#### NOTED:

- (i) In response to a question, it was stated that some data had been collected on the long term impact of pupils attending a Nurture Group as they progressed in their education. The collection of this data was made challenging because not all pupils were on the SEN register. However, the Service were considering other options for collecting this data to assess longer term impact of Nurture Groups.
- (ii) It was commented the inclusion of outreach support for secondary schools was welcomed.

**RESOLVED** to support the changes proposed for the delivery of Nurture Groups.

#### (b) School Funding Arrangements – 2023/24 and Responses to Consultation

**RECEIVED** a report summarising the responses to the proposals to the transfer and use of 0.5% from the Schools to the High Needs block for 2024/25. It also outlined a proposal to review arrangements for funding special school.

**REPORTED** following the last Schools Forum meeting, a consultation document that sought

responses to the transfer and use of 0.5% from the Schools to the High Needs block for 2024/25 was published. By the deadline, no responses to the consultation had been received.

The lead representatives for the primary and secondary sector, who were members of this Forum, were contacted and advised that no responses had been received. They were asked to discuss and confirm with their sector as to whether they supported the 0.5% transfer from the Schools to the High Needs block for 2024/25. It was confirmed that the two sectors agreed to the continuation of the 0.5% transfer from the Schools to the High Needs block to support schools with above a calculated average number of pupils with ECHP.

Separately, the special school headteachers had requested that their place funding be reassessed to include additional financial support for pupils with needs above the upper descriptor level and also an audit and place funding review be carried out.

#### NOTED:

(i) As part of the proposal to provide additional financial support for pupils with needs above the upper descriptor level for special schools, the proposal was for all requests be considered by a panel that included a special school headteacher, SEN officers and other lead professionals.

The Forum was advised when the current arrangements were agreed, there were mixed views whether to have predictability of funding through an average cost model or a banding model which assessed individual pupil needs.

The Forum noted that the additional financial support would require some funding set aside from the High Needs block and may impact on the overall deficit position.

(ii) The Forum was informed, similar to last year, there may be a need when the early years funding arrangements were published to consult on the local arrangements during the early part of the Spring term.

**RESOLVED** the Forum confirmed its agreement to:

- 0.5% from the Schools to the High Needs block to support schools with above a calculated average number of pupils with ECHP;
- Creating a panel to consider requests for additional support above the upper descriptor level and earmarking some funding from the High Needs block;
- If required, consulting on the early years funding formula.

#### (c) Central Services School Block and De-delegation

**RECEIVED** a report detailing the allocation of the central services school block and the central services available for de-delegation to maintained schools.

**REPORTED** there were no changes to allocation of statutory services from the central services school block, however in line with DfE policy, funding for historic commitments had been reduced by 20%.

With regards to de-delegated central services, the Council had stopped providing long service awards, therefore this service was no longer available for de-delegation.

The per pupil rate for Licenses, GDPR and Trade Union Facilities Time had been uplifted to support costs pressures or impact of recent pay awards.

**NOTED** information had been shared with the lead representatives from both the primary and secondary sectors. Both representatives had discussed and sought the views of their sector as to which central services they would support for de-delegation.

# (d) <u>Funding for local authorities to support their maintained schools in financial difficulty:</u> allocations - 2023-24

**REPORTED** a notification had been received confirming an allocation of £965.7k from £20m available nationally to support Enfield maintained schools in deficits / financial difficulties.

**NOTED** the proposal was to earmark 31% of the grant to secondary schools and the balance to primary schools. The grant would then be allocated to schools that either reported a deficit at year-end, the first year of three year plan or their quarter 1 return.

The Forum noted the information on the one-off grant and supported the proposed allocation of funds.

# **Purpose of Report**

This report sets out the initial 2024/25 Dedicated Schools Grant (DSG) allocation announced on 19th December 2023 and the Enfield 2024/25 draft schools' budget.

The report seeks the approval of Schools Forum to finalise the school funding formula unit values.

# **Proposal**

The Schools Forum is asked to:

- Note the indicative allocations to schools as set out in Appendix D.

# Relevance to the Council's Council Plan

The Dedicated Schools Grant (DSG) is a ringfenced grant which funds schools and some central education functions. Updates on the DSG position are provided on a quarterly basis to EMT and Cabinet as part of the council's overall financial monitoring reports.

### Main Considerations for Education Resources Group and Schools Forum

### 1. 2024/25 Dedicated Schools Grant (DSG) Settlement

The Department for Education (DfE) published initial information regarding the 2024/2025 Dedicated Schools Grant (DSG) in July 2023. This included indicative information on additional funding, funding guidance and the response to the National Funding Formula Consultation. An initial overview report was provided to the October 2023 Schools Forum meeting.

The updated 2024/25 DSG settlement was published on 19th December 2023, with the initial DSG block allocations confirmed for the schools, high needs, early years and central schools services funding blocks.

Table 1 summarises the 2024/25 DSG allocation before recoupment and other adjustments for Enfield by DSG block in comparison to the current 2023/24 DSG allocation as at November 2023.

Local Authority DSG allocations are subject to in-year adjustments. Further updates will be presented to Schools Forum during the year.

Further details on each DSG block are outlined in the sections below.

#### **Schools Block**

Mainstream school funding in the DSG has been increased nationally by 2% per pupil in 2024/25, compared to 2023/24.

The 2024/25 Enfield schools block DSG allocation before recoupment and other adjustments is £312.283m, an overall increase of 0.92% after the impact of pupil number changes.

The total schools block allocations are based on the primary and secondary units of funding, premises funding and growth funding. The pupil numbers that are used to calculate the schools block funding allocations are outlined in the tables below.

Growth funding and funding for premises factors is included in the schools' block DSG allocations.

# **Central Schools Services Block (CSSB)**

The CSSB funding is allocated to local authorities to carry out central functions on behalf of maintained schools and academies, based on the following:

- Ongoing responsibilities funding for functions that local authorities have a statutory duty to deliver for all pupils in maintained schools and academies
- Historic commitments funding for historic commitments following the introduction of the school funding reforms (funding for historic commitments made prior to 2013 to 2014 continues to be reduced annually by 20%)

The CSSB funding allocations have been updated to reflect the October 2023 dataset, the updated allocations are detailed in table 5.

The Schools Forum are asked to note that the central schools services funding has reduced compared to the provisional allocation presented to the Schools Forum in December 2023 as a result of the reduction in pupil numbers. The planned spend will be adjusted to the allocation available.

# **High Needs Block**

High needs funding has been increased nationally by £10.5 billion in 2024/25, a 4.3% increase in comparison to 2023/24. The national high needs funding formula is based on funding floor set at 3% so that each local authority will receive an increase of at least 3%, considering changes in their population aged 2-18 years.

The 2024/25 Enfield high needs block DSG allocation before recoupment is £78.032m, an increase of £2.411m or 3.19% compared to 2023/24. This allocation is subject to in year adjustments, with expected updates including in-year import/export adjustments. Of the High Needs Block allocation, £3.3m will be recouped from the authority and provided direct by the Education Skills and Funding Agency to fund post 16 places in FE provision and places in FE provision and places in special schools and mainstream academy ARPs / units. This amount will be adjusted during the year to reflect any change in pupil numbers or new academy conversions.

A detailed report on the high needs budget will be presented to the March 2024 Schools Forum meeting.

### **Early Years Block**

The 2024/25 early years block DSG allocation is £39.095m, an increase by £12.954m or 49.55% compared to 2023/24. This reflects the introduction of a new national funding formula for children aged 9 months up to (and including) 2 year olds and the extension of the Early Years Pupil Premium and Disability Access fund. Early years funding is subject to further invear adjustments.

A detailed report on the early years budget is a separate agenda item.

# 2. Draft Schools Budget and Formula Factors 2024/25

The Education & Skills Funding Agency (ESFA) released the Enfield 2024 to 2025 Authority Proforma Tool on the 19 December 2023. The tool is prepopulated with the school level pupils and indicators that the authority is required to use for the schools' block funding formulae to determine individual school budgets. This data has been used to produce a draft schools' budget as outlined further in this report.

The total schools block funding to be distributed through the formula is shown in the table below.

#### 2024/25 Dataset

The October 2023 census dataset that is used to determined individual school budgets for 2024/25 is based on a total of 48,264 pupils, a decrease of 526 pupils in comparison to 2023/24. In addition to the October 2023 pupil numbers, the LA is required to estimate the pupil numbers expected to join growing schools in September 2024, where the schools are still adding year groups. This applies to Wren Academy in 2024/25 with an adjustment of 107 pupils. The updated total pupil numbers used to determine individual schools' budget are outlined in table 5.

# **National Funding Formula (NFF)**

The Government has confirmed the intention to move to a direct funding formula for mainstream schools, completing the reforms to school funding which started when the NFF was first introduced. This will mean that the DfE determines funding allocations for individual schools, without substantial local adjustment. In view of this, Local Authorities are required to move their local formula values at least a further 10% closer to the NFF in 2024/25, building on the progress made in 2023/24.

Enfield mirrored the NFF in most funding formula values in 2023/24 except for the Basic Entitlement and Sparsity factors. The NFF rates and Enfield formula rates are outlined in Appendix B.

Key changes to the Schools' NFF from 2023/24 to 2024/25 include:

- Rolling the 2023 to 2024 mainstream schools additional grant (MSAG) into the NFF;
- Introducing a new national formulaic approach to split site funding;
- Increasing the NFF factor rates;

• Introducing a methodology for calculating and allocating funding for falling rolls. Where local authorities have a falling rolls fund they must follow the new requirements for falling rolls funding (not applicable to Enfield).

#### 3. Draft Formula Factors

The draft schools budget has been calculated using the pupil and school characteristics from the 2024/25 APT, based on the October 2023 dataset and the National Funding Formula unit rates. This resulted in an affordability gap of £1.5m, which has been addressed by adjusting the Basic Entitlement formula rates in line with the methodology previously discussed with Schools Forum and 2023/24 approach.

The same methodology has been used this year as was applied in 2023-24, with the following key points to note in relation to the calculation of the draft budget:

- Mainstream schools additional grant (MSAG) the 2023/24 MSAG funding has been rolled into the NFF factor values.
- DSG transfers the draft formula reflects the 0.5% transfer to the high needs block agreed in December 2023.
- National Funding Formula (NFF) rates the rates including the area cost adjustment have been applied to all formula factors in the Enfield schools' formula, except the Basic Entitlement rates which have been adjusted to address the affordability gap.
- Minimum Funding Guarantee the MFG has been set at the lowest permitted level of 0%, total MFG funding allocated to schools in 2024/25 £0.6m.
- Minimum per pupil level (MPPL) for primary and secondary schools the NFF minimum per pupil levels have been applied, total funding allocated to schools in 2024/24 £0.3m.
- Private Finance Initiative (PFI) contracts draft school budgets have been based on an estimated total PFI contract increase of 10.4%, consistent with the RPIX uplift that has been applied to the DSG schools block premises funding. This represents a budget pressure of approximately £0.5m.
- Business Rates Enfield uses the central NNDR payment process where ESFA pays the NNDR bills on behalf of schools. Draft budgets have been based on the NFF NNDR values which is subject to change.
- Notional SEN budgets the draft budget has been calculated on the same basis as 2023/24
- SEN unit numbers currently based on 2023/24 numbers.
- De-delegated services the rates agreed at the December 2023 Schools Forum meeting have been incorporated into the APT. These amounts will subsequently be deducted from individual school budgets for mainstream schools.
- Split site funding the new formulaic approach to split site funding has been applied, with funding allocated based on the NFF unit rates for basic eligibility funding and distance funding (applies to five schools).
- Sparsity the NFF rate and calculation has been applied based on the year group size taper and distance taper threshold (applies to one school).
- Disapplication request the disapplication that applied to Wren Academy's minimum funding guarantee (MFG) baseline to phase this out over two years in 2022/23 and 2023/24 has now ceased.

# 4. Risks and Uncertainties

The timescales for calculating the draft school budget allocations and finalising the APT are challenging, with the updated funding allocations and dataset published on the 19 December

2023 and the final APT is required to be submitted to the ESFA by 22 January 2024. The budget calculations outlined in this report are indicative allocations based on the best information available at the time of writing this report and other relevant assumptions.

The final 2024/25 schools' budget is subject to change as a result of:

- Changes that may result from updated information or final checks of the school formula allocations by LA officers;
- Validation checks by the ESFA.

Where changes are required, it is proposed to address any funding impact by adjusting the Basic Entitlement rates to achieve a balanced school budget position.
