

1. the presentations regarding joint Council and Police enforcement activity affecting licensed premises (codename operation LEMA) and an analysis of police crime statistics affecting licensed premises.

2. that Under the Licensing Act 2003, the Committee had a responsibility to receive reports on crime and disorder and to ensure that this was properly reflected in Committee decisions.

1. EXECUTIVE SUMMARY

- 1.1 This report concerns designated controlled alcohol zones. These are public places where the consumption of alcohol is controlled.
- 1.2 It is proposed that new controlled alcohol zones be introduced covering all parks / open spaces, railway and London Underground stations in the borough.
- 1.3 The Licensing Committee has delegated power to agree to extend designated controlled alcohol zones, subject to a statutory consultation process.

2. **RECOMMENDATIONS**

2.1 Controlled alcohol zones be extended to include all London Underground / railway stations and all parks / open spaces in the borough as shown in Appendix 1.

2.2 It is recommended that due to the large number of parks / open spaces in the borough the controlled alcohol zones be introduced in 5 phases, as set out below:

Phase 1

All Railway and London Underground Stations

Phase 2

Wards: Ponders End, Highlands, Southbury, Jubilee, Cockfosters **Phase 3**

Wards: Haselbury, Grange, Chase, Bush Hill Park, Palmers Green **Phase 4**

Wards: Turkey Street, Southgate Green, Enfield Lock, Edmonton Green, Enfield Highway.

Phase 5

Wards: Winchmore Hill, Southgate, Bowes, Lower Edmonton, Town, Upper Edmonton.

- 2.3 That the controlled alcohol zones around stations also extend to areas in the vicinity of licensed premises.
- 2.4 Where a station is situated on a road that is already partly in an existing controlled alcohol zone it is recommended that the new controlled alcohol zone should link with the existing area so that the whole road is covered. This will make the zones simpler for the public to understand and easier to police.
- 2.5 That the boundaries of the areas covering parks / open spaces be the current boundaries of these areas and that one controlled alcohol zone sign be placed at every entrance point. Some open spaces are not gated/fenced and access can be gained along a wide frontage. In this instance it is recommended that signage be placed adjacent to any footpaths into the sites or spaced equidistant along the boundary.
- 2.6 That officers undertake the statutory consultation with;
 - a) The Borough Police Commander;
 - b) The Police Commanders for Barnet and Haringey (only is designated areas adjacent);
 - c) Barnet and Haringey Councils; (only is designated areas adjacent)
 - d) The licensee of any licensed premises who may be affected by the designation.
 - e) Friends of the Parks Group, cafes lessees and other relevant commercial operators.

This will include the statutory notice published in a local paper

2.7 That officers make the necessary arrangements to implement the extension of controlled alcohol zones, subject to any minor amendments following consultation to be agreed with the Chairman of the Licensing Committee.

3. BACKGROUND

- 3.1 Sections 12-16 of the Criminal Justice and Police Act 2001 came into force on 1st September 2001. These provide local authorities with an adoptive power to restrict anti-social public drinking and they provide the police with the power to enforce this restriction. The penalty is a maximum fine, currently £500.
- 3.2 A local authority may only designate a public place in their area if they are satisfied that:
 - a) Nuisance or annoyance to members of the public or a section of the public; or
 - b) Disorder has been associated with the consumption of intoxicating liquor in that place.
- 3.3 Also on 1st September 2001, the Local Authorities (Alcohol Consumption in Designated Public Places) Regulations 2001 came into force. These Regulations set out the procedures to be followed by Local Authorities in designating public places for this purpose.
- 3.4 The London Borough of Enfield currently has ten areas designated under this legislation.
- 3.5 On 29th April 2002, Enfield's Licensing Committee granted an Order designating Enfield Town as a controlled alcohol zone, which became effective on 1st June 2002.
- 3.6 On 4th September 2002, Enfield's Licensing Committee granted an Order designating Edmonton as a controlled alcohol zone, which became effective on 1st October 2002.
- 3.7 On 10th November 2004, Enfield's Licensing Committee granted orders designating Bush Hill Park Enfield Town Extension, Enfield Wash, Ponders End, Southgate, New Southgate, Green Lanes and Winchmore Hill as controlled alcohol zone, which became effective on 1st June 2005.
- 3.8 Occasional events take place in parks where alcohol is available or likely to be consumed. Conditions will be placed upon these events by the Parks Service to ensure all rubbish is collected and that behaviour of participants is monitored.
- 3.9 Properly licensed premises and areas within their boundary are disapplied as designated public places.

4. ALTERNATIVE OPTIONS CONSIDERED

4.1 Designating 100 Metre Areas A number of factors have determined the exact location of the proposed zones around stations. Originally it was intended for zones to cover a 100m radius around every station. However this sometimes meant that a zone ended next to licensed premises. The zones have therefore been stretched so that they cover licensed premises in their vicinity.

4.2 Prioritising Certain Geographical Areas

Research indicates that the 5 wards most in need of a controlled alcohol zone are: Ponders End, Highlands, Southbury, Jubilee and Cockfosters and that tube stations are worse than railway stations and parks. Police information suggests that the following areas should be considered when looking at future controlled alcohol zones: Broomfield Park, Brimsdown Railway Station, Enfield Lock Railway Station, Cockfosters ward and the Grange ward. An alternative would be to just target these areas but it is believed having different rules in different parks / stations will be too complicated for the public to understand and more difficult to police.

4.3 Making the whole borough a controlled alcohol zone Legislation does not permit the Council to do this without evidence to prove that nuisance and annoyance is caused by alcohol consumption in all public places.

5. REASONS FOR RECOMMENDATIONS

- 5.1 Over a period of five weeks (18th April 19th May 2005) 12 railway stations, 2 tube stations and 24 parks / open spaces were visited so see if alcohol consumption was creating a social problem in these areas. Evidence of alcohol consumption in the form of empty cans, bottles and other litter was found at all of the stations and 93% of the parks visited.
- 5.2 Whilst grounds maintenance personnel are required to inspect all grass areas prior to cutting operations, cans and bottles are sometimes caught up in cutting machinery this results in both damage to the machinery and sharp shards of both glass and metal being left on the grass, which can cause harm both park users and wildlife
- 5.3 Many visitors to the Borough arrive by train or tube and a station littered with cans and bottles of alcohol creates a poor impression. It also contributes to continuing disregard for the area, leading to further littering.
- 5.4 Alcohol is known to affect balance and judgement. According to a Transport for London article (<u>www.tfl.gov.uk</u> The 5 most numerous customer injuries) alcohol was the cause of 934 incidents in the last two years. This shows that there are significant safety issues relating to alcohol and tube/rail use. Alcohol can also make people louder and sometimes aggressive which can be intimidating for commuters.
- 5.5 Controlled alcohol zones could potentially reduce the number of alcohol related accidents, improve the Boroughs appearance, decrease vandalism and damage to vehicles and personal injury as well as making the public feel safer. If people feel safe they will make greater use of these facilities.

5.6 The police provided information regarding CAD calls (calls such as 999 calls that go through to the police control room) and crime reports that refer to drunkenness within a 400m radius of train stations. Excluding stations that are already in an existing controlled alcohol zone the stations with the highest number of CAD calls were Brimsdown and Enfield Lock. In the same 12-week period drunkenness was mentioned in 40 completed crime reports. The wards with the highest number of these crime reports were Cockfosters and Grange.

6. COMMMENTS OF THE DIRECTOR OF FINANCE AND CORPORATE RESOURCES AND OTHER DEPARTMENTS

6.1 Financial Implications

The Legislation makes no provision for cost recovery and therefore any costs of introducing additional areas will fall upon Environment Street Scene and Parks, revenue budget, and can be met within 2005/06 provision.

8. PUTTING ENFIELD FIRST

- 8.2 The Policy recognises the importance of protecting local residents and businesses, whose lives can be seriously affected by disturbance and anti-social behaviour which may arise from irresponsible alcohol consumption.

1. EXECUTIVE SUMMARY

1.1 This report provides information and identifies activities undertaken to discharge the Council's licensing functions for the period 1 January 2005 to 31 December 2005.

2. **RECOMMENDATIONS**

- 2.1 That the Licensing Panel notes the report;
- 2.2 That a further report be brought to a future meeting identifying
 (1) the categories, opening times and geographical distribution of premises licences granted under the Licensing Act 2003;
 (2) the impact upon crime and disorder, live music and dancing.

3. LICENCES ISSUED BY THE COUNCIL JANUARY TO DECEMBER 2005

- 3.1 The Licensing team have processed 2472 licences between 1 January and 31 December 2005.
- 3.2 A summary of the licences issued is provided in Appendix 1.

4. LICENSING ACT 2003

4.1 **Premises Licences and Club premises certificates**

- 4.1.1 The Licensing Act 2003 was enacted on 6 February 2005 and came into force on 24 November 2005. It brought together a number of licensing regimes. Previously, separate licences were required for the sale of alcohol, late night refreshment and various entertainments. The Act requires the licensing of premises for the:
 - Provision of alcohol,
 - Provision of late night refreshment; namely the supply of hot food or hot drink between 2300 and 0500 hours, and
 - Regulated entertainment namely:
 - the performance of a play
 - an exhibition of a film
 - an indoor sporting event
 - boxing or wrestling entertainment
 - a performance of live music
 - any playing of recorded music
 - a performance of dance
 - or entertainment of a similar description to live music, recorded music or dance
- 4.1.2 Licensing authorities must carry out their functions with a view to promoting four licensing objectives. These are:
 - The prevention of crime and disorder
 - Public safety
 - The prevention of public nuisance
 - The protection of children from harm
- 4.1.3 Licensing authorities must decide applications in connection with premises licences and club premises certificates on the basis of the steps it considers necessary to promote these objectives having considered any representations made by the responsible authorities (such as the Police, Fire Brigade, Trading Standards, Environmental Health, Planning and Child Protection Services) and interested parties (residents and businesses in the vicinity).
- 4.1.4 A summary of the applications which have been received to 31 December 2005 is as follows:-

- 689 Premises applications have been received
- 226 applications were scheduled to be heard at panel of which 132 applications were heard by the panel and 94 were withdrawn/determined under delegated powers before they went to panel
- 97% of applications (128) had been subject to responsible authority representations
- Approximately 50% have been subject to interested party representations (over 1000 individuals)
- Of the132 applications heard by panel
 - Approximately 10% have been substantially rejected
 - Approximately 15% granted in full
 - Approximately 75% granted in part
- 4.1.5 Appendix 2 provides details an analysis of the hours granted for 161 of the premises licences applications.
- 4.1.6 There have been 19 appeals against the licensing panel's decisions been lodged to date. Of which:-
 - 2 have been heard. One was upheld but modified and the decision of the other is pending
 - 3 have been withdrawn by the applicants
 - 14 are scheduled to be heard between January and March 2006.

4.2 Personal Licences

- 4.2.1 The Licensing Act establishes a regime for the granting of personal licences to individuals to supply, or to authorise the supply of alcohol. All premises authorising the supply of alcohol must have an identified personal licence holder known as the designated premises supervisor. This person will usually be responsible for the day-to-day running of the premises. All supplies of alcohol under a premises licence must be made by or under the authority of a personal licence holder.
- 4.2.2 The Police are statutory consultees and if they consider that there is a risk to the prevention of crime and disorder licensing objective they can make a representation and the matter is referred to the Licensing Panel to determine. The Licensing Panel has heard 4 cases regarding personal licences where the Police raised a representation and 3 applications were rejected and 1 was granted.

4.3 Temporary Events

4.3.1 These are small-scale, temporary events of which licensable activities form part, that are allowed to take place without the need for a premises licence or club premises certificate. The event organiser (who must be over 18 years) has to notify the licensing authority, by giving a "temporary event notice" (TEN). There are certain limitations imposed on this system. These include:

- No more than 499 people (including staff/organisers) attending at any one time
- An individual is limited to giving 5 TENs in a calendar year, unless they are a personal licence holder for the sale of alcohol, in which case they can give 50
- A limit of 12 temporary event notices may be given in respect of any particular premises in a calendar year
- An event may last for no more than 96 hours
- The maximum aggregate duration of the periods covered by temporary event notices at any individual premises of 15 days.
- 4.3.2 The Police are statutory consultees and if they consider that there is a risk to the prevention of crime and disorder licensing objective they can serve a counter notice and the matter is referred to the Licensing Panel to determine. The Licensing Panel has heard 2 cases regarding temporary events and it transpired that 1 was a private party and therefore a TEN was not required and the other was granted.

4.4 SPECIAL ORDER EXEMPTIONS

4.1 Under the previous licensing regime (Licensing Act 1964) occasional permissions known as Special Orders Exemptions (SOEs) were granted by Police. Between 1 January and 23 November 2005 there were 925 SOEs granted.

4.5 FIREWORKS LICENSING

- 4.5.1 The Manufacture and Storage of Explosives Regulations 2005 introduced revised registration and licensing requirements for the storage of fireworks. The Trading Standards Team and other staff fin Environmental Health and Regulation undertook firework patrols between 26 October to 6 November 2005. There were 168 firework calls received which was a 26% decrease from 2004.
- 4.5.2 There was an increase in enforcement:
 - 7 Fixed Penalty Notices were served for letting off fireworks
 - 5 arrests for a firework related incident
 - 1 business had fireworks seized for selling without a licence and is subject to legal proceedings.
- 4.5.3 One business was refused a licence because the storage arrangements for fireworks were unsafe.

4.6 AGE RESTRICTED SALES

- 4.6.1 These are planned test purchase of products such as alcohol, tobacco, solvents, fireworks and video recordings with child volunteers working under the strict Home Office guidelines and the supervision of Trading Standards staff.
- 4.6.2 The results for the period January to December 2005 are as follows:-

4.6.3 The number of sales have decreased from the previous period January to December 2004 when the total percentage overall of sales made was 25%. The advice and enforcement campaigns of the Trading Standards Team and the work of the 'Safer Business Safer Streets' Project Co-ordinator will have contributed to this.

4.7 AMUSEMENT WITH PRIZES PERMITS

- 4.7.1 The responsibility for the issuing of these permits was transferred from magistrates courts to Licensing Authorities on 24 November 2005.
- 4.7.2 Amusements with prizes machines (AWP machines), more commonly known as fruit or slot machines, were authorised by permits for individual premises, granted under Section 34 of the Gaming Act 1968. Local authorities were already responsible for issuing these permits for lower value AWP machines in amusement arcades.
- 4.7.3 The Licensing Act 2003 transferred the additional responsibility of authorising AWP machines in alcohol-licensed premises to local authorities. The main type of AWP machine covered by the change is the "all cash" fruit machine, which has a maximum stake of 30p and a maximum prize of £25.
- 4.7.4 The Council has received 6 applications to date.

4.8 ENFORCEMENT

4.8.1 Age related sales of alcohol, public entrainment and late night cafes

Appendix 3 details enforcement action taken in respect of age related sales, public entertainment and late night cafes between 1 January 2005 and 31 December 2005.

4.8.2 Licensing Act 2003

Enforcement visits commenced soon after 24 November 2005. Approximately 110 visits have been made out of hours between November 2005 to date to undertake observations, enforcement visits and to investigate complaints about licensed premises. In the first weekend of enforcement, a premises agreed to close as they were not compliant with the conditions attached to their licence which granted the premises extended trading hours (beyond 23:00).

There were a very small proportion (0.5%) of premises that were unlicensed on 24 November 2005 and are the subject of investigations with a view to formal action. There are also a number of premises that are the subject of investigation for suspected breaches of their licence conditions with a view to formal action.

4.8.3 Enforcement campaigns concerning licensed premises

Operation Lema I and II:

Operation Lema II ran between February and March 2005 and the purpose was to promote Enfield's 'Responsible Licensee Scheme' amongst liquor licensed premises. This involved 63 visits to 'On-licenced' premises and 70 visits to 'Off-licenced' premises.

Operation Leo/Pridian:

This ran between June and July 2005 and was a joint operation with the Police to target 'high risk/problem' liquor licensed premises. This involved 57 visits to premises resulting in a number of observations concerning noise, antisocial behavior etc. and 3 fixed penalty notices were issued for underage drinking/sales to minors, 2 for drinking in alcohol control zones and 8 doormen were reported for not displaying their identification badges. There were 2 arrests.

AMEC 4 Campaign:

The Home Office/Police AMEC (Alcohol Misuse Enforcement Campaign) campaign ran in December 2005. This campaign was regarding age related sales, drink-drive, antisocial behavior around licensed premises. Some joint visits were undertaken between the Police and Trading Standards and the

police and licensing enforcement staff. The results of this campaign are not yet available.

4.8.4 Special Treatment Licence enforcement

One premises is under investigation with a view to formal action for suspected breaches of its special treatment licence.

4.9 DESIGNATED ALCOHOL CONTROL ZONES

- 4.9.1 The London Borough of Enfield currently has ten areas designated under this legislation.
- 4.9.2 In addition to the existing alcohol control zones of Enfield Town and Edmonton, the orders granted on 10 November 2004 by Enfield's Licensing Committee became effective on 1 June 2005 for the following areas: Bush Hill Park, Enfield Town Extension, Enfield Wash, Ponders End, Southgate, New Southgate, Green Lanes and Winchmore Hill.
- 4.9.3 The Safer Neighbourhoods Parks Unit have statistics for enforcement taken in the alcohol control zones in the Town Park and Pymmes Park and 53 verbal warnings and 17 fixed penalty notices have been issued for alcohol between 1 July and 31 December 2005.

4.10 FORTHCOMING LEGISLATION:

4.10.1 Gambling Act 2005:

This will be implemented in September 2007. The Licensing Authority will become responsible for gambling premises only and the Gambling Commission will license operators and individuals.

4.10.2 Charities Act:

This will transfer the responsibility for the licensing of street and house collections from the Police to local authorities.

4.10.3 Animal Welfare Bill/Act:

The implementation date for this is not yet known but may be this year. The Act will extend the scope of premises that will need to be licensed, inspected and enforced for animal welfare purposes.




