**1. LICENSING HISTORY & CURRENT POSITION:**

- 1.1 On 30 November 2005, an application by Mr Nicos Yiapatos for a new Premises Licence as a conversion and simultaneous variation, was granted in part by the licensing sub-committee (LN/200502145).
- 1.2 On 20 February 2007 an application by Mr Yilmaz Kaya for transfer of the Premises Licence, which was not subject to any representations, was granted by officers in accordance with delegated powers
- 1.3 On 19 December 2011 an application by **B. Lads Ltd** for transfer of the Premises Licence, which was not subject to any representations, was granted by officers in accordance with delegated powers.
- 1.4 On 18 February 2013, a minor application by **B. Lads Ltd** to modify conditions, was granted by officers in accordance with delegated powers.
- 1.5 On 9 January 2015, a new application by **Ms Lale Hassan** for a new Premises Licence was withdrawn.
- 1.6 The current Premises Licence permits:
- 1.6.1 **Hours the premises are open to the public:** Sunday to Thursday from 10:00 to 00:00, Friday and Saturday from 10:00 to 00:30 the following day.
- 1.6.2 **Supply of alcohol (on and off supplies):** Sunday to Thursday from 10:00 to 23:30, Friday and Saturday from 10:00 to 00:00.
- 1.6.3 **Live music:** Monday to Sunday from 10:00 to 23:00
- 1.6.4 **Recorded music:** Monday to Sunday from 10:00 to 23:00
- 1.6.5 **Facilities for Making Music:** Monday to Sunday from 19:00 to 23:00
- 1.6.6 **Late Night Refreshment:** Sunday to Thursday from 23:00 to 00:00, Friday and Saturday from 23:00 to 00:30 the following day.
- 1.6.7 **Indoor sporting events:** Monday to Sunday from 10:00 to 23:00

1.7 A copy of a location map of the premises is attached as Annex 01.

1.8 A copy of the current Premises Licence is attached as Annex 02.

## 2 THIS APPLICATION :

2.1 On 3<sup>rd</sup> February 2015 an application was made by **B Lads Ltd** for a **new Premises Licence** for The Bird in Hand, 100 Tottenhall Road, N13 6DG. The application seeks:

2.1.1 **Hours the premises are open to the public:** Sunday to Thursday from 10:00 to 00:30, Friday and Saturday from 10:00 to 01:30 the following day.

2.1.2 **Supply of alcohol (on and off supplies):** Sunday to Thursday from 10:00 to 00:00, Friday and Saturday from 10:00 to 01:00 the following day.

2.1.3 **Indoor sporting events:** Monday to Sunday from 10:00 to 00:00.

2.1.4 **Live music:** Sunday to Thursday from 10:00 to 23:30, Friday and Saturday from 10:00 to 00:00.

2.1.5 **Recorded music:** Sunday to Thursday from 10:00 to 00:00, Friday and Saturday from 10:00 to 00:30 the following day.

2.1.6 **Performance of Dance:** Sunday to Thursday from 10:00 to 00:00, Friday and Saturday from 10:00 to 00:30 the following day.

2.1.7 **Late Night Refreshment (indoors):** Sunday to Thursday from 23:00 to 00:00, Friday and Saturday from 23:00 to 01:00 the following day.

2.1.8 To attach a new plan of the licensable area at the premises (the layout of the premises has been altered to include a take away grill/kitchen area).

2.2 The application was advertised in accordance with the requirements of the Licensing Act 2003.

2.3 Each of the Responsible Authorities were consulted in respect of the application.

2.4 A copy of the application is attached as Annex 03.

**3 RELEVANT REPRESENTATIONS:**

- 3.1 **Metropolitan Police:** Representation is made, against the application, on the grounds of the prevention of crime and disorder. The authority considers that it is appropriate, for the promotion of the licensing objectives, to object to the full hours sought, and recommend that the licensable activities match the times of the existing licence (LN/200502145) – see 1.6 above.
- 3.2 A copy of the representation is attached as Annex 04.
- 3.3 **Licensing Authority (including Licensing Enforcement, Environmental Health, Trading Standards, Planning, Health & Safety and Children's Services):** Representation is made, against the application, on the grounds of the prevention of public nuisance. The authority considers that it is appropriate, for the promotion of the licensing objectives, to object to the full hours sought, and recommend that the licensable activities match the times of the existing licence (LN/200502145) – see 1.6 above.
- 3.4 A copy of the representation is attached as Annex 05.
- 3.5 **Other Persons:** Representations have been made, against the application, by persons residing at 27 separate addresses. The grounds of representation include the prevention of crime & disorder and the prevention of public nuisance.
- 3.6 A copy of the representation is attached as Annex 06.

**4 PROPOSED LICENCE CONDITIONS:**

- 4.1 The conditions arising from this application are attached as Annex 07, which have not been disputed by the responsible authorities.

**5 RELEVANT LAW, GUIDANCE & POLICIES:**

- 5.1 The paragraphs below are extracted from either :
- 5.1.1 the Licensing Act 2003 ('Act'); or
- 5.1.2 the Guidance issued by the Secretary of State to the Home Office of March 2015 ('Guid'); or
- 5.1.3 the London Borough of Enfield's Licensing Policy Statement of January 2015 ('Pol').

**General Principles:**

- 5.2 The Licensing Sub-Committee must carry out its functions with a view to promoting the licensing objectives [Act s.4(1)].
- 5.3 The licensing objectives are :
  - 5.3.1 the prevention of crime and disorder;
  - 5.3.2 public safety;
  - 5.3.3 the prevention of public nuisance; &
  - 5.3.4 the protection of children from harm [Act s.4(2)].
- 5.4 In carrying out its functions, the Sub-Committee must also have regard to :
  - 5.4.1 the Council's licensing policy statement; &
  - 5.4.2 guidance issued by the Secretary of State [Act s.4(3)].
- 5.5 The Sub-Committee may not have regard to whether or not a proposal is likely to be permitted in accordance with the law relating to planning or building [Pol s.17.1].
- 5.6 There can be confusion about the difference between the "need" for premises, and the "cumulative impact" of premises on the licensing objectives. "Need" concerns the commercial demand for another pub or restaurant or hotel, and is a matter for the planning authority and for the market. This is not a matter for the Sub-Committee in discharging its licensing functions [Guid 13.18].

**Cumulative Impact Policy:**

- 5.7 The applicant premises/club premises is not located in a Cumulative Impact Policy Area [Pol s.9.20].

**Hours:**

- 5.8 The Sub-Committee decides licensed opening hours as part of the implementation of the licensing policy statement and is best placed to make decisions about appropriate opening hours in their area based on their local knowledge and in consultation with responsible authorities [Guid 10.13].
- 5.9 However, there is no general assumption in favour of lengthening licensing hours and the four Licensing Objectives should be paramount considerations at all times. Where there are representations against an application and the Sub-Committee believes that extending the licensing hours would undermine the Licensing Objectives, they may reject the application or grant it with appropriate conditions and/or different hours from those requested. [Pol s.8.3].
- 5.10 Stricter conditions with regard to licensing hours may be required for licensed premises situated in or immediately adjacent to residential areas to ensure that disturbance to local residents is avoided. This will particularly apply in circumstances where, having regard to the location, size and nature of the premises , it is likely that disturbance will be caused to residents in the vicinity of the premises by concentrations of people leaving, particularly during normal night-time sleeping periods [Pol s.8.4].

**Decision;**

- 5.11 As a matter of practice, the Sub-Committee should seek to focus the hearing on the steps considered appropriate to promote the particular licensing objective or objectives that have given rise to the specific representation and avoid straying into undisputed areas [Guid 9.36].
- 5.12 In determining the application with a view to promoting the licensing objectives in the overall interests of the local community, the Sub-Committee must give appropriate weight to:
  - 5.12.1 the steps that are appropriate to promote the licensing objectives;
  - 5.12.2 the representations (including supporting information) presented by all the parties;
  - 5.12.3 the guidance; and
  - 5.12.4 its own statement of licensing policy [Guid 9.37].
- 5.13 Having heard all of the representations (from all parties) the Sub-Committee must take such steps as it considers appropriate for the promotion of the licensing objectives. The steps are :
  - 5.13.1 to grant the application subject to the mandatory conditions and such conditions as it considers necessary for the promotion of the licensing objectives;
  - 5.13.2 to exclude from the scope of the licence any of the licensable activities to which the application relates;
  - 5.13.3 to refuse to specify a person in the licence as the premises supervisor;
  - 5.13.4 to reject the application [Act s.18].

**Annex 1 - Mandatory Conditions**

1. No supply of alcohol may be made under the premises licence : (a) At a time when there is no designated premises supervisor in respect of the premises licence; or (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

**Annex 2 - Conditions consistent with the Operating Schedule**

3. There shall be no adult entertainment or services, activities or matters ancillary to the use of the premises that may give rise to concern in respect of children.
4. Children under 18 years old shall not be permitted on the premises after 23.00.
5. The use of the beer garden shall be limited from the permitted opening hours to 23.00 on Monday to Saturday and from permitted opening hours to 22.30 on Sunday.
6. The management shall make subjective assessments of noise levels outside at the perimeter of the premises approximately hourly from 20:00 until closing time, whilst licensable activities are provided to ensure that noise from the premises does not cause a disturbance to local residents. Records shall be kept of the times, dates and any issues discovered. These records shall be kept for six months. Records must be made available to an authorised officer of the Council or police, upon request. Where monitoring by staff identifies that noise from the premises is audible at the perimeter, measures shall be taken to reduce this i.e. turning volume down.
7. The Local Authority or similar proof of age scheme shall be operated and relevant material shall be displayed at the premises. Only passport, photographic driving licences or ID with the P.A.S.S. logo (Proof of Age Standards Scheme) may be accepted.
8. Prominent, clear and legible notices shall be displayed at all public exits from the premises requesting customers respect the needs of local residents and leave the premises area quietly. These notices shall be positioned at eye level and in a location where those leaving the premises can read them.
9. A personal licence holder is to be present on the premises and supervise the sale of alcohol, throughout the permitted hours for the sale of alcohol.
10. No one under the age of 18 years shall be permitted to enter the premises unless accompanied by an adult.
11. A digital CCTV system must be installed in the premises complying with the following criteria: (1) Cameras must be sited to observe the entrance

and exit doors both inside and outside and floor areas; (2) Cameras on the entrances must capture full frame shots of the heads and shoulders of all people entering the premises i.e. capable of identification; (3) Cameras viewing till areas must capture frames not less than 50% of screen; (4) Cameras overlooking floor areas should be wide angled to give an overview of the premises; (5) Cameras must capture a minimum of 16 frames per second; (6) Be capable of visually confirming the nature of the crime committed; (7) Provide a linked record of the date, time and place of any image; (8) Provide good quality images - colour during opening times; (9) Operate under existing light levels within and outside the premises; (10) Have the recording device located in a secure area or locked cabinet; (11) Have a monitor to review images and recorded picture quality; (12) Be regularly maintained to ensure continuous quality of image capture and retention; (13) Have signage displayed in the customer area to advise that CCTV is in operation; (14) Digital images must be kept for 31 days; (15) Police will have access to images at any reasonable time; (16) The equipment must have a suitable export method, e.g. CD/DVD writer so that the police can make an evidential copy of the data they require. This data should be in the native file format, to ensure that no image quality is lost when making the copy. If this format is non-standard (i.e. manufacturer proprietary) then the manufacturer should supply the replay software to ensure that the video on the CD can be replayed by the police on a standard computer. Copies must be made available to Police or authorised local authority employees on request.

12. Toilets at the premises shall be checked for any sign of drug use on average of every two hours between 10:00 and closing time at all times licensable activity is taking place. A record shall be kept of the times, dates and any issues discovered. These records shall be kept for six months. Records must be made available to an authorised officer of the Council or police upon request.

13. At least six prominent, clear and legible notices shall be displayed throughout the premises, including all toilets warning customers that drug use will not be tolerated.

14. There shall be no entry or re-entry of patrons to the premises after 23:00.

15. With the exception of access and egress, all external doors and windows shall be closed when the premises are in use for the purpose of licensable activities.

16. All those hiring the function room shall be required to sign a hire agreement, which shall specify the terms of use of the premises, including the times and conditions of the premises licence.

17. All those hiring the function room are required to show three forms of ID at time of booking, and a copy to be held by the premises licence holder.

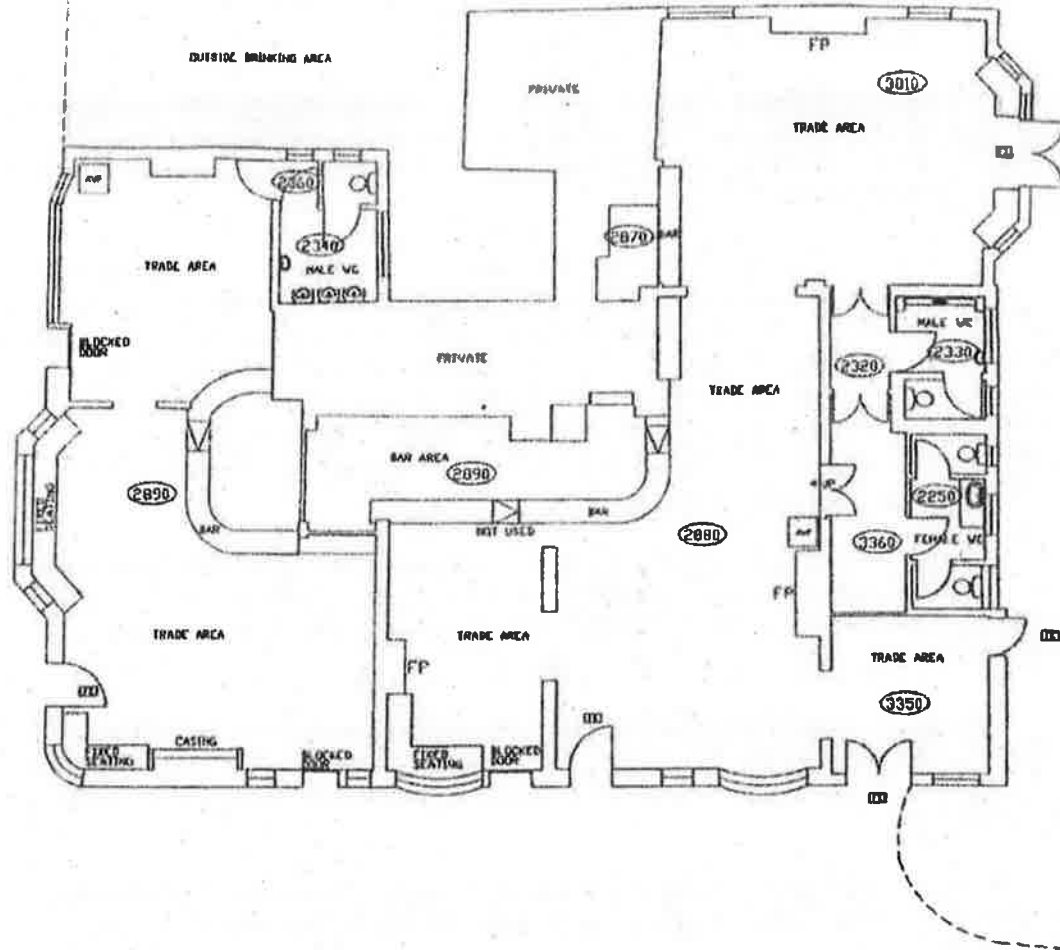
18. All staff shall receive induction and refresher training (at least every three months) relating to the sale of alcohol and the times and conditions of the premises licence.

- 19. All training relating to the sale of alcohol and the times and conditions of the premises licence shall be documented and records kept at the premises. These records shall be made available to the Police and/or Local Authority upon request and shall be kept for at least one year.**
- 20. A written record of refused sales shall be kept on the premises and completed when necessary. This record shall be made available to Police and/or the Local Authority upon request and shall be kept for at least one year from the date of the last entry.**
- 21. A minimum of two door supervisors shall be employed on the premises on Fridays and Saturdays from 20:00 until the premises has closed. At least one door supervisor shall remain directly outside the premises for 30 minutes after the premises has closed or until all customers have dispersed. The duties of these staff will include the supervision of persons entering and leaving the premises to ensure that this is achieved without causing a nuisance. All door supervisors shall be easily identifiable by wearing high visibility jackets or armbands.**
- 22. A log must be kept indicating the date and times door supervisors sign in and out for duty and must include clearly printed details of each door supervisor's name, SIA licence number, employer, and the duty they are employed to carry out on any particular night.**
- 23. Children under 18 years are not permitted to remain at or enter the premises after 19:00 unless attending a pre booked function in the designated function area; or, eating a table meal whilst accompanied by an adult in the restaurant area.**
- 24. All tables and chairs from the outside smoking area shall be removed when the premises is not open for licensable activity, with effect from 1st June 2013.**

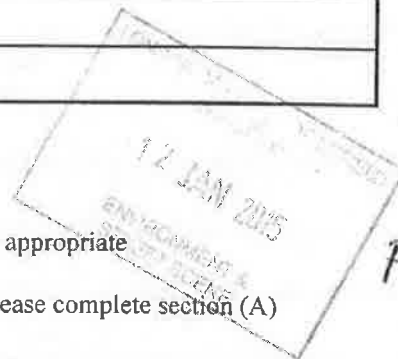

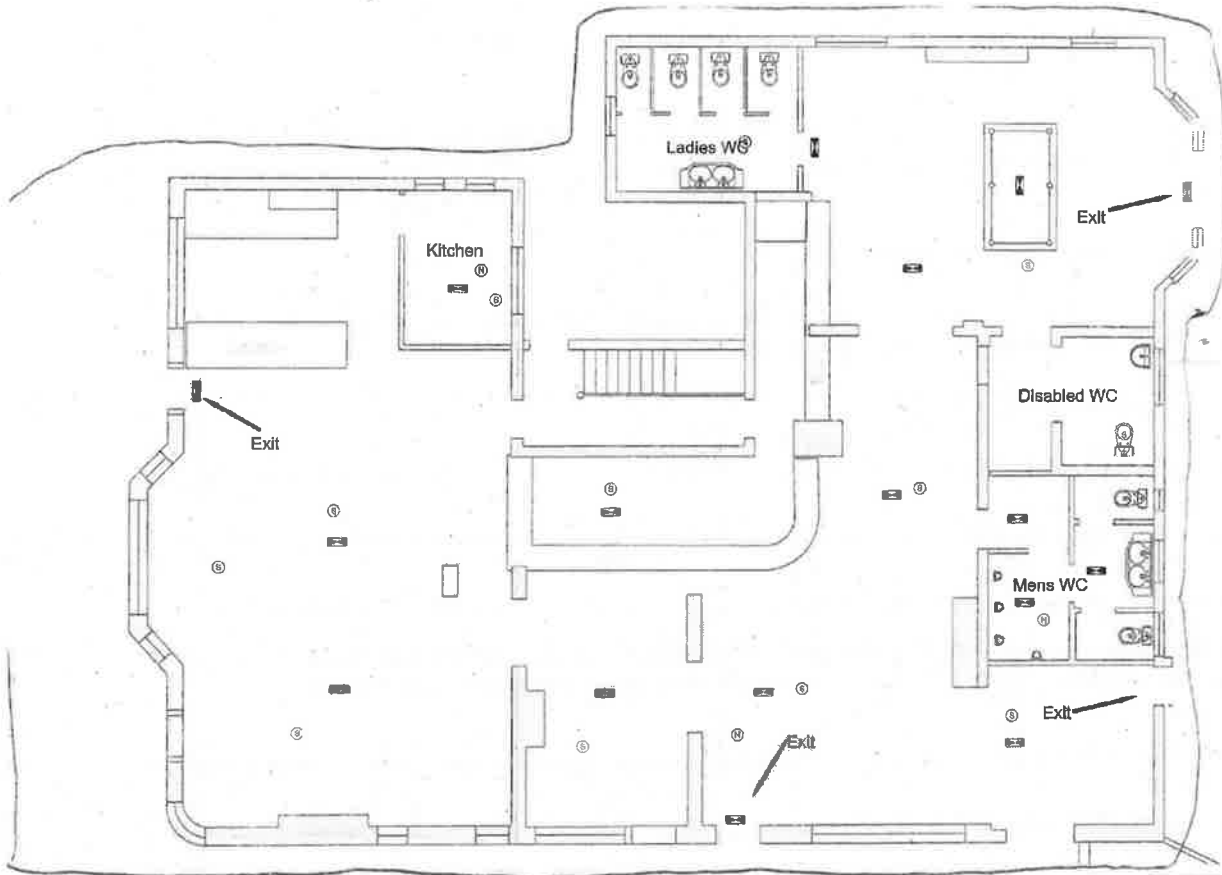

If the proposed hours were to be granted, I feel that the potential for noise nuisance issues by way of customers leaving the venue at closing time would be detrimental to those residents living nearby. I also believe that the later hours would also very likely lead to increased incidents of crime & disorder as customers would be able to consume more alcohol with the negative effects that this often leads to.

Although the proposed times are only one hour above those currently held at weekends and half an hour for the remaining days of the week, I still feel strongly that the negative impact on the local community would far too harmful and impactful on their right to peace and quiet in their own homes.

Police therefore object to this application in its entirety

I am happy with the current conditions on the premises licence.

A new premises licence is required rather than a variation, as there have been significant changes made to the layout of the licensable area, including the provision of a hot food grill area.

This premises is currently licensed (LN/200502145); Premises Licence Holder B. Lads Limited, 100 Tottenham Road, LONDON, N13 6DG since 19/12/2011, and Designated Premises Supervisor Mr Mehmet Ali Arslan, 20 Lemsford Close, Tottenham, London, N15 6BY since 8/12/2011. The same PLH and DPS are named on the new premises licence application; therefore it is relevant to include the background history.

On 18/02/2013, the premises licence LN/200502145 was varied by means of a minor variation application, to add and amend conditions to strengthen the licence, at the request of Licensing Enforcement and the Police. The history below will start from this date.

#### **History of Complaints and Inspections:**

Since 18/2/2013, the premises has applied for and been issued 45 Temporary Event Notices (TEN), to provide alcohol and regulated entertainment up to as late as 3.30am, but more often until 2 or 3am.

**23/4/2013** – Complaint A called Licensing Enforcement to report of customers being noisy outside the pub up to 5am at the weekend. Complainant A did not call the police or the OOH noise team. A TEN was in place during this weekend. The TEN applicant and manager at the premises, Layle Hassan was advised of the complaint, who advised that all customers were gone from the area by 2.30am, and regular noise checks had been carried out. As a result of this complaint, Licensing Enforcement carried out late night observations shortly after where no problems were witnessed and all was deemed to be quiet.

**3/5/2013** – Licensing Enforcement carried out observations of the premises at approximately 21:30, no noise or ASB issues. The officers then entered the premises and met with Layle Hassan, to carry out a full inspection. The following conditions were found to be non-compliant:

C11 – CCTV images not all in colour during opening hours, or recordings kept for 31 days.

C18 & 19 - No evidence that all staff have received training on sale of alcohol and no evidence of training being recorded.

Advice given, training guidance and record book issued. Further advice about recent complaint was given.

**22/5/2013** – Licensing Enforcement carried out a daytime inspection to check outstanding conditions – all now satisfactory.

**25/5/2013** – Licensing Enforcement carried out observations at 00:15am. On arrival to the venue, the music could be heard approximately 50 metres and could clearly hear the person singing karaoke. The door to the site was shut but the music could still be heard. Officers spoke to Layle Hassan and explained that the music needed to be lowered and she agreed, and the volume was lowered. Layle stated that she had been doing sound checks from across the road and that she could not hear the music as described by the officers. Officers pointed out where their observations had taken place, and advised that at that the level, the music was very likely to be a nuisance to persons living either side and opposite their premises. The officers stated that in their

opinion considering the close proximity of the neighbouring residential premises to the public house, later hours for music at that level would be likely to cause a nuisance.

**26/5/2013** – Out of Hours noise team carried out observations at 00:12am as requested by Licensing Enforcement. Officers observed two door supervisors working and both the DPS and Layle working. Officers could hear music from outside the adjacent property and across the road. A few customers were seen leaving and smoking outside the premises, and no issues were observed. Officers advised the DPS of their noise observations.

**2/3/2014** – Complainant B called the OOH noise team to report of noise disturbance from the Bird in Hand. The officers visited the premises at 2.31am and observed 12 customers outside the premises, several males talking, shouting & swearing. One door supervisor seen walking around and talking to patrons. A car pulled up and tooted its horn, a customer spoke to the driver, who then drove off. 5 customers shortly got into a taxi. No music could be heard coming from premises. When officers left the premises, there were still several customers on the premises. A TEN was in place on this date. Licensing Enforcement advised the premises of the complaint.

**5/4/2014** – Out of hours observations were carried out between 2.02am and 2.27am, following the last complaint. A handful of smokers were seen, some noise from their talking heard. Music was only just audible when the door opened. A door supervisor was seen on duty outside. When a large number of customers (approx. 14) left the premises at the end of the night, loud talking was heard. A TEN was in place on this date.

**16/4/2014** – An anonymous complaint was received reporting of concerns with customers using the seating area on the pavement outside the front of the premises.

**10/5/2014** – In response to the last complaint, Licensing Enforcement carried out observations at 23:55 until 00:05. No customers seen outside. Windows and doors shut. No seating outside pub. No ASB witnessed. A DJ was operating inside the venue. Music was audible outside from across the road of venue, and it was louder when the front door opened. However, officers confirmed that it would be unlikely to be a statutory nuisance at this volume.

**23/5/2014** – Further observations were carried out between 22:05 and 22:15. Officers were unable to neither hear any music nor witness any ASB. Three tables were seen at the front of the premises, at which customers were sitting at, but no issues.

**6/6/2014** – Further observations were carried out between 21:20 and 21:35. Officers could hear loud music, as a result of both main doors being left open; however, it was not significantly audible from across the road and unlikely for it to cause a "likely to" nuisance at that level. There were two door supervisors at the front. Officers approached them and advised that they will need to close the doors to contain the noise outbreak, which they actioned. Once they were closed the music was audible from immediately outside on the pavement, but when officers moved away to Tottenham Road, it was not. The DPS a Mr Mehmet Arslan came out to speak to the officers and advice was given.

**14/6/2014** - Licensing Enforcement officers visited between 21:30 - 21:40 during a World Cup match, and spoke to the DPS. The premises was busy with 94 people inside according to door supervisors clicker, but no issues observed. It was noted that a kebab shop had been installed inside the premises, did not reflect the plan attached to the licence – advice was given to submit an application.

**19/06/2014** – Licensing Enforcement observations carried out during World Cup match, at midnight. No issues, premises was closing.

**29/06/2014** - Licensing Enforcement observations carried out during World Cup match, at midnight. No issues, premises was closed.

**8/7/2014** – Licensing Enforcement received a call from Layle Hassan, requesting advice about the plan, which was given.

**3/8/2014** – Complainant C called the OOH Noise Team at 00:29 to report of loud music form the premises. When the officers visited at 00:59, the music had stopped and musicians seen leaving the premises. A TEN was in place on this date.

**3/9/2014** – Complainant D emailed the Licensing Enforcement team, reporting issues from loud noise from the use of the premises' beer garden. Contact was made with the complainant to request further information, no response received.

**14/9/2014** – Complainant A called the OOH Team at 2.19am to report of customers talking very loudly, even shouting outside the pub, which is an ongoing issue. Complainant A did not want a call back, and officers did not visit at time. A TEN was in place on this date.

**19/9/2014** – Complainant A called the Licensing Enforcement team to advise of the problem of noise from customers standing outside the premises talking once the pub has closed. The premises were subsequently advised of the complaint.

**30/12/2014** – Licensing Enforcement were made aware of the concerns about the variation application to extend the hours, on behalf of the local councillor and residents association.

**7/1/2015** – Licensing Enforcement carried out a full licence inspection and all conditions were deemed to be satisfactory.

**9/1/2015** – Licensing Enforcement carried out observations of the Bird in Hand at 23.15. Loud music clearly audible with car windows shut from 20 metres away. There were approximately 12 persons on pavement outside entrance, several were play fighting and being loud, messing around, and boisterous. No effort made by door supervisor or management to control this behaviour. When entrance door opened, it allowed loud music to escape. No music audible from 75 metres from premises, but could hear people noise, the officers believed this could have been because the music had stopped by 23.15. Officers returned to outside premises, and confirmed music had finished and people chatting outside entrance quietly. The officers made the recommendation that any exteñsion to the hours at this venue was inappropriate as there are already issues at 11pm, 1am would make matters worse, the specific issues that need to be addressed relate to the patrons outside and volume of music.

Further observations were carried out by the Out of Hours Noise Team, as requested by Licensing Enforcement, at 23:45. A door supervisor at the door and 11 patrons were smoking and talking loudly by the front door. Music could be heard when the door was opened. Door supervisor observed to be carrying out written noise assessments. Premises seemed to close down at midnight, as no more music, customers leaving, a couple of whom were talking loudly. Officers left area at 00:20am.

**14/1/2015** – Licensing Enforcement advised Layle Hassan of the issues witnessed at the weekend, and gave advice on how to prevent further issues. Layle stated that the music after 11pm is from the TV - advised to ensure TV is turned down even more. Advised to keep customers inside until taxi arrives, and to assist in the taxi/customer arrangements and to encourage door supervisor to intervene more when customers are noisy outside.

**16/1/15** – Out of Hours noise team carried out observations at 23:25 as tasked by Licensing Enforcement. Premises was closed.

**23/1/2015** - Licensing Enforcement carried out observations at 23:30. DJ observed to be packing up equipment, and no music audible: Approximately 6 male smokers, and the odd laughter could be heard, but no ASB observed. Door supervisor was situated in close proximity to these customers.

**1/2/2015** – Complainant C reported to Out of Hours that loud music was playing from the premises until approximately 00:30. The OOH officers were unable to visit on this occasion. A TEN was in place on this date.

**13/02/2015** – Licensing Enforcement carried out observations between 23:05 and 23:15. DJ could be seen at 23:05, and music could be heard when the door opened, but was not considered loud enough to be a statutory nuisance. DJ was then seen clearing equipment away. Officers entered premises and spoke to Layle and DPS. Advised that the music was too loud to be considered background music, and it was turned down to a level agreed by the officers. No ASB, shouting or any other issues observed.

**21/02/2015** – Out of Hours noise team carried out observations at midnight as tasked by Licensing Enforcement. On arrival, approximately 11 patrons were observed standing outside the pub smoking and talking quietly. One door supervisor was seen outside premises. No music audible. All customers left premises by 00:16, some left in taxis. No issues observed.

**22/2/2015** – Out of Hours noise team carried out observations at 00:08am as tasked by Licensing Enforcement. Officers observed a door supervisor on the entrance, no music heard and three patrons outside smoking quietly. No issues.

#### **Prevention of Nuisance:**

This premises is not located within a Cumulative Impact Policy Area, however the premises is situated in a highly residential area. As mentioned above, residents have been disturbed by music from this premises and customers smoking or leaving the premises in the past, during normal operating hours and TEN events.

#### **Planning Information**

No relevant planning information.

**In summary I wish to make representation on the following:**

- **Prevention of Nuisance**

Looking at the history of the premises as a whole from 2013, eight complaints have been received, mostly in spring 2014, and nearly all complaints link to TEN events and the noise disturbance from customers outside the premises, rather than music. These

complaints have stemmed from four residents at separate addresses, who have made their concerns known to the Council.

Officers have made observations on at least 19 occasions, and on five of these occasions, issues mainly music level were observed. However, it is important to note that on no occasion, the music was at such a level that the serving of a Section 80 Noise Abatement Notice was deemed necessary. No such notice has ever been served at the premises.

Of the inspections, a couple of non-compliances were identified on one occasion, and were rectified shortly after. Internal management of the premises seems generally good, and the customers are not necessarily causing much anti-social behaviour, but they can be loud outside against an otherwise ambient background during the later hours of the evening.

The TEN events are a good insight into the suitability of the premises being open later. It is worth highlighting that out of the 45 TENs over the last couple of years; only 8 complaints in total have been received. This may seem a small percentage (17%), however linked with the concerns raised by officer observations; it cannot be ignored and shows perhaps an inconsistency in being able to manage the external noise from music and smokers from the premises, which is a concern.

In order to support the prevention of public nuisance licensing objective and protect local residents from suffering disturbance within their homes, **the Licensing Authority do not feel that it is appropriate to permit any extension of hours as sought by the applicant, and object to the application in its entirety.**

However, should the application be granted in full or part, the proposed list of conditions are deemed as satisfactory by the Licensing Authority and do not wish to recommend any additions or amendments.

**Friday 27/2/15** - At 23:15, Out of Hours officers carried out observations of the premises. Recorded music was still playing, which was only audible when the front door opened. Up to seven customers and one door supervisor seen outside premises at any one time. Customers talking quietly and no ASB witnessed. At 23:35, no music was audible. Officers spoke to Layle Hassan and examined the noise records for that evening, which were being carried out hourly, no issues noted. When officers left at 23:43, only music was low level background music and people noise only audible when front doors opened.

**Friday 20/3/15** - At 23:10, Out of Hours officers carried out observations of the premises, and it was noted that the music was not unreasonably loud outside. Up to seven customers seen talking (occasionally loudly) and smoking outside, although a door supervisor was present. A DJ could be seen inside and customers were dancing. Officers entered the premises and spoke to Layle Hassan. They checked the noise records which were being completed. It was noted that the music was at background level during the visit.

**Saturday 21/3/15** - At 23:16, Out of Hours officers carried out observations of the premises, and it was noted that the general area was quiet. A door supervisor was seen walking around the pub carrying out noise checks. Ten customers were seen outside the pub talking quietly. A door supervisor was situated at the entrance of the door. No music was audible. Customers gradually went back into pub. No ASB witnessed. Officers left the area at 23:25.

**Conclusion**

The Licensing Authority acknowledge the above observations of the premises are generally compliant, however, our position remains the same to object to any hours beyond those of the current premises licence.

To ensure clarity, please allow me to repeat and clarify what I alluded to in my last email on this topic.

My position as Bowes councillor is that the Bird in Hand pub is located in a quiet residential neighbourhood and that it would be inadvisable to extend the license to enable music being played as late as being requested in the application. Were we talking about a pub on a large commercial street where there is already a lot of noise late at night, then things might be different because the extension would not materially change local living conditions. But in this particular case you are looking at changing the nature of the neighbourhood - against, as far as I can see, against the wishes of the people living there.

**Annex 1 - Mandatory Conditions**

1. **No supply of alcohol may be made under the premises licence : (a) At a time when there is no designated premises supervisor in respect of the premises licence; or (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.**
2. **Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.**

**Annex 2 - Conditions consistent with the Operating Schedule**

3. **There shall be no adult entertainment or services, activities or matters ancillary to the use of the premises that may give rise to concern in respect of children.**
4. **Children under 18 years old shall not be permitted on the premises after 21.00 unless accompanied by an adult.**
5. **The use of the beer garden shall be limited from the permitted opening hours to 23.00 on Monday to Saturday and from permitted opening hours to 22.30 on Sunday. This area after 23:00 until closing is only used for smoking (max 10 people at any time) no alcohol permitted or glassware.**
6. **The management shall make subjective assessments of noise levels outside at the perimeter of the premises approximately hourly from 20:00 until closing time, whilst licensable activities are provided to ensure that noise from the premises does not cause a disturbance to local residents. Records shall be kept of the times, dates and any issues discovered. These records shall be kept for six months. Records must be made available to an authorised officer of the Council or police, upon request. Where monitoring by staff identifies that noise from the premises is audible at the perimeter, measures shall be taken to reduce this i.e. turning volume down.**
7. **The Local Authority or similar proof of age scheme shall be operated and relevant material shall be displayed at the premises. Only passport, photographic driving licences or ID with the P.A.S.S. logo (Proof of Age Standards Scheme) may be accepted.**
8. **Prominent, clear and legible notices shall be displayed at all public exits from the premises requesting customers respect the needs of local residents and leave the premises area quietly. These notices shall be positioned at eye level and in a location where those leaving the premises can read them.**
9. **A digital CCTV system must be installed in the premises complying with the following criteria: (1) Cameras must be sited to observe the entrance and exit doors both inside and outside and floor areas; (2) Cameras on the entrances must capture full frame shots of the heads and shoulders of all people entering**

the premises i.e. capable of identification; (3) Cameras viewing till areas must capture frames not less than 50% of screen; (4) Cameras overlooking floor areas should be wide angled to give an overview of the premises; (5) Cameras must capture a minimum of 16 frames per second; (6) Be capable of visually confirming the nature of the crime committed; (7) Provide a linked record of the date, time and place of any image; (8) Provide good quality images - colour during opening times; (9) Operate under existing light levels within and outside the premises; (10) Have the recording device located in a secure area or locked cabinet; (11) Have a monitor to review images and recorded picture quality; (12) Be regularly maintained to ensure continuous quality of image capture and retention; (13) Have signage displayed in the customer area to advise that CCTV is in operation; (14) Digital images must be kept for 31 days; (15) Police will have access to images at any reasonable time; (16) The equipment must have a suitable export method, e.g. CD/DVD writer so that the police can make an evidential copy of the data they require. This data should be in the native file format, to ensure that no image quality is lost when making the copy. If this format is non-standard (i.e. manufacturer proprietary) then the manufacturer should supply the replay software to ensure that the video on the CD can be replayed by the police on a standard computer. Copies must be made available to Police or authorised local authority employees on request.

10. Toilets at the premises shall be checked for any sign of drug use on average of every two hours between 10:00 and closing time at all times licensable activity is taking place. A record shall be kept of the times, dates and any issues discovered. These records shall be kept for six months. Records must be made available to an authorised officer of the Council or police upon request.
11. At least six prominent, clear and legible notices shall be displayed throughout the premises, including all toilets warning customers that drug use will not be tolerated.
12. There shall be no entry or re-entry of patrons to the premises after 23:00 the exception of smokers.
13. With the exception of access and egress, all external doors and windows shall be closed when the premises are in use for the purpose of licensable activities.
14. All staff shall receive induction and refresher training (at least every three months) relating to the sale of alcohol and the times and conditions of the premises licence.
15. All training relating to the sale of alcohol and the times and conditions of the premises licence shall be documented and records kept at the premises. These records shall be made available to the Police and/or Local Authority upon request and shall be kept for at least one year.
16. A written record of refused sales shall be kept on the premises and completed when necessary. This record shall be made available to Police and/or the Local Authority upon request and shall be kept for at least one year from the date of the last entry.

- 17. A minimum of two door supervisors shall be employed on the premises on Fridays and Saturdays from 20:00 until the premises has closed. At least one door supervisor shall remain directly outside the premises for 30 minutes after the premises has closed or until all customers have dispersed. The duties of these staff will include the supervision of persons entering and leaving the premises to ensure that this is achieved without causing a nuisance. All door supervisors shall be easily identifiable by wearing high visibility jackets or armbands.**
- 18. A log must be kept indicating the date and times door supervisors sign in and out for duty and must include clearly printed details of each door supervisor's name, SIA licence number, employer, and the duty they are employed to carry out on any particular night.**
- 19. All tables and chairs from the outside smoking area shall be removed at 00:00.**
- 20. After 00:00 only ten smokers are permitted at the front of the building at any one time and no alcohol or glass permitted after this time.**
- 21. Provide wall mounted ashtrays and litre bins outside the premises.**
