<p>KD 3745 George Spicer Primary School Refurbishment & Alterations</p> <p>Under the Primary Expansion Programme, George Spicer Primary School is being enlarged from two to four forms of entry with a new Key Stage 1 building being provided on the Kimberley Gardens site. Originally it was proposed that the new school would open in September 2013 but due to extensive planning conditions, the accommodation is unlikely to be ready for occupation before Summer Term 2014. It will therefore be necessary to base more pupils at the main School site on Sketty Road in September 2013 than originally planned.
