<p>KD 3879 CRC Forecast Purchasing of Allowances for 2014/2015</p> <p>In April 2014, the Council has the opportunity to purchase its Carbon Reduction Commitment (CRC) Energy Efficiency Scheme allowances for 2014/15 a full year in advance at a reduced price (£15.60 as opposed to £16.40) for each tonne of carbon emitted.
