I certify that I have considered the summary review application and **I wish to make representations** in support of the Police representation as we have concerns that the Licensing Objectives are not upheld whilst licensable activity has been provided at the above premises.

1. Documentation

For this representation I have considered the following information:

- i) The existing premises licence.
- ii) Review application by the Police.
- iii) LSC Decision of Representations against Interim Steps Hearing 12/12/24.
- iv) LSC Decision of Representations against Interim Steps Hearing 17/12/24.

2. Background.

- 8/11/24 (Friday); Esther Hughes, Head of Service Consumer Protection & Waste Enforcement (Chair of the SAG), Victor Ktorakis, Senior Environmental Health Officer, and PC Francis Peters visited the Drumsheds to undertake an unannounced during performance licensing inspection. The inspection was prompted following the unfortunate incident on the 12/10/24.
- See EZH Appendix A for a copy of the inspection report. During the visit the premises were deemed compliant in relation to conditions checked.
- 13/12/24 (Friday); at the invitation of Drumsheds following the interim steps hearing, officers from Enfield Council and the Metropolitan Police carried out an inspection of the premises.
- See EZH Appendix B for a copy of the inspection report. During the visit the premises was deemed compliant in relation to conditions checked. The

inspection was divided between a focussed “paperwork audit” and a “physical inspection,” the latter being predominantly carried out by the Police.

- Due to the enhanced searching/security measures on the 13/12/24, where the venue was at full capacity of 14,999, there were significantly longer queues on entry and the search area/lanes were “full.”
- At the time of writing this report (20/12/24) the Licensing Team had received 51 complaints from persons attending the event on the 13/12/24. Most of these complaints were similar in nature relating to, but not limited to, the following areas:
 - extended queuing time (2 hours)
 - concerns re potential crushing in the queue
 - poor crowd management
 - aggressive staff
 - lack of welfare in the queues.
 - inadequate security – bags not searched.
- 19/12/24 A summary of the complaints was sent to the license holder.
- 19/12/24- Teams meeting with Esther Hughes, Met Police (PC Danni Jones; PC Derek Ewart; PC Mark Perry) and representatives from Broadwick (Simeon Aldred (PLH); Nilham Smith (Broadwick legal) and Paddy Whur (Woods Whur Solicitors) to discuss the visit of the 13/12/24 and to establish what if any additional/amended conditions the Licence holder would propose to uphold the licensing objectives.
- Based on the number and extent of the complaints and discussions on the 19/12/24 we would like the licence holder to offer amended/additional wording/conditions to strengthen the existing conditions as listed in Table 1 below.
- We would like the licence holder to give particular focus to, but not limited to,
 - Searching.
 - Use of ID scanners.
 - Welfare and medical arrangements/provision.
 - Drug detection dogs.

- Use of behavioural detection officers.
- Lighting/signage throughout the venue.
- Furthermore, having regard to the **enhanced conditions** implemented during the **interim steps hearings** it is recommended that the Licence holder considers if any of these should be made into specific licence conditions and offer these to the LSC accordingly.

Table 1: Existing conditions that require amending/strengthening.

Existing Licence Condition Number	Wording of Existing Conditions
18	SIA registered security staff shall be positioned at all entry and exit points in operation for each event to control entry and carry out searches if risk assessed as necessary in the Security Management and Deployment Plan, and to ensure an orderly dispersal from the event. Additional security may be deployed to other points as determined by the Security Management and Deployment Plan.
21	Prior to commencing any operational duties, all security and stewarding staff shall receive an event briefing for that event which shall include the necessary information in respect of the event, the premises and operating procedures.
23	Queues formed within and outside the premises shall be supervised by event staff. Such supervision shall be aimed at preventing disorder and discouraging anti-social behaviour.
26	For events that have been risk assessed as requiring searches to be carried out, all guests entering or re-entering the premises shall be searched by an SIA trained member of staff and search areas shall be monitored by the premises CCTV system. Anyone refusing to be searched shall be denied entry to the premises. The conditions of entry shall be made publicly available on tickets and shall be prominently displayed at the entrances to the premises.
30	The incident and event logbook shall be kept on the premises and completed on each occasion an incident or event as listed below occurs including recording the time, date, location and description of each incident, the name of the person reporting the incident and any action taken in respect of the incident: <ul style="list-style-type: none"> (a) all crimes reported to the site; (b) all ejections of patrons; (c) any complaints received; (d) any incidents of disorder; (e) any known faults in the CCTV system;

	(f) any visit by a relevant authority or emergency service; and (g) any other incident or event that impacts upon the promotion of the Licensing Objectives within the Licensing Act 2003.

I am writing as the solicitor who represents the interests of the operators of Drumsheds.



SUP30 Representation:

I am writing to express my support for Drumsheds as a venue that has consistently provided a safe, enjoyable, and well-organized environment for its events. Having attended two events there—Mas Tiempo on 16 December 2023 and False Idols on 30 November 2024—I can confidently say that Drumsheds stands out as a model venue for large-scale events.

One of the most important aspects of my experience at Drumsheds has been the emphasis on safety. Throughout both events, I felt secure thanks to the presence of attentive personnel who were always available to assist and guide guests. The venue’s layout and management also ensured that the space never felt overcrowded, contributing to a sense of ease and comfort.

The venue’s thoughtful design provided plenty of space for dancing while also offering areas to rest and hydrate, ensuring attendees could enjoy themselves without compromising their well-being. These facilities reflect Drumsheds’ commitment to creating a positive experience for all guests.

Beyond the excellent organization, what truly stood out to me was the sense of camaraderie among the attendees. The atmosphere fostered by the venue encouraged considerate and respectful interactions, enhancing the enjoyment of everyone present.

Drumsheds is not just a space for events—it is a place where music and community come together in a safe and welcoming environment. I strongly believe that losing such a well-regarded venue would be a disservice to the community and the cultural fabric of the area.

I urge you to consider the positive experiences of attendees like myself when reviewing the license for Drumsheds. Thank you for your time and consideration.

SUP31 Representation:

I am writing to share my experience of the three visits I have had to Drumsheds. I went to see PAWSA (11.10.24), Fatboy slim (23.11.24) and Bicep (7.12.24).

My first impression upon arrival for my first visit to the PAWSA concert was a sense of awe at the scale of the operation. Once nearby it is very clearly signposted and upon arrival there are lots of staff and security to help you find your way inside the venue. The security staff are completely different to what I have been used to at other venues, instead of being the usual aggressive and unhelpful type, they were engaging, polite and informative. They helped to navigate the crowd towards the entry with skill and ease. Upon the entry journey there were multiple signs outlining a zero tolerance on drugs policy, and this was also stated clearly on the tickets. Once

inside the building there was a huge security gate that I have only ever seen similar in an airport. Despite vigorous searches and everyone walking through detectors one by one the queues moved quickly due to the amount of security team that were on hand. Again here it was made very clear drugs were not allowed, and there was a sniffer dog being used in a very visible location for all to see. As a customer this did take time at a moment you are very excited to get inside, but it gave a real sense of safety as once through I felt assured that the crowd had been properly checked. This is very important to me and a big reason why I kept returning and brought my wife, my cousin and other friends. The sense of safety made me very comfortable bringing female friends to the venue, this is something I would usually not encourage at other venues. Once inside it was a sense of awe at what has been created, all in an old IKEA. The venue is huge, so once again it was super helpful having so many staff available to help me find myself around. I never saw any violence, aggression, drug taking, or signs of trouble - all of which are usually seen or felt in nightclubs.

Then the experience itself - it is absolutely mind blowing, that's why I had to go three times and will continue to go. What has been created is like nothing I've seen before, the audio and visual experience is ground breaking and unparalleled. And there is so much space inside you can really enjoy yourself without being crammed into a small room, you can always find an exit and be free from the crowd easily. There are plenty of toilets and I even noticed that there was a health centre / hospital signposted which is something I haven't seen anywhere else.

Overall id just like to state that Drumsheds has redefined what I thought of venues like this, instead of being a shady, unsafe late night room full of people unable to speak, they've created a big open safe environment where people can finally go and enjoy an amazing show amongst other interesting people who are there for a good fun time as well.

SUP32 Representation:

I would like to express my support for Drumsheds at the upcoming licensing review.

I've attended events at the venue in 7th December 2024 and 8th December 2023, both times I experienced an efficient yet thorough security review (less than 5 minute wait times), as well as security through out the venue that were enforcing anti-drug rules and ensuring people's safety.

Drumsheds has a significant impact on music culture in London, that is well known across the world.

SUP33 Representation:

I have visited Drumsheds as a guest- The Craig David event. The whole venue felt incredibly safe- the atmosphere was fantastic. Staff were attentive and present in every nook of the venue. It was clear that management had left nothing to chance

and health and safety was a firm priority.

SUP34 Representation:

I am writing to voice my support for Drumsheds as they undergo their licensing review. As someone in her 30s with professional experience in events—spanning both corporate and music sectors, including a focus on people flow—I have been truly impressed by the way Drumsheds operates. Having attended 7+ events at the venue this year and also multiple events last year, I’ve witnessed firsthand their ability to manage large crowds efficiently while creating a safe and enjoyable environment for everyone.

What particularly stands out to me is their commitment to ensuring women feel safe at their events. Initiatives like “Ask Angela” demonstrate a proactive approach to safety, and their focus on supporting female music artists is a refreshing and necessary step in promoting diversity and inclusion within the cultural space. Additionally, their introduction of a drug testing lab highlights their forward-thinking attitude and willingness to innovate in ways that prioritize the safety and well-being of attendees.

Additionally, the security team maintains a friendly and approachable demeanor, which helps to reduce any feelings of angst—something I don't always experience with security staff at other venues.

One event I recently attended was the Bicep show on December 7th, which I believe was sold out. Despite the high attendance, the experience remained seamless and enjoyable. The staff and venue's organisation ensured that the crowd was managed effectively, without compromising on comfort or safety, which I truly appreciated.

I also want to highlight my experience at "False Idols," an event hosted by Drumsheds that stood out for its commitment to creating a safe and inclusive space. The event fostered an atmosphere where individuals felt welcome and respected, regardless of their gender or sexuality. This inclusivity was evident right from the initial interactions with ticketing staff, who avoided assuming pronouns, and it continued throughout the evening, making the experience unique and impactful. I've not encountered this level of consideration and inclusivity at other large-scale venues in London.

Drumsheds has always felt like a venue where safety and guest experience are top priorities, setting a standard for similar venues in the city. I hope this feedback is helpful in demonstrating the venue's commitment to providing a secure, inclusive, and enjoyable space for all visitors.

I am just getting in touch as I was recently made aware that Drumsheds is currently under review by Enfield's licensing team. I felt obliged to contact your team to share my recent experiences of attending the venue and also my opinion of Drumsheds as a local resident.

There is a heavy security presence when entering the venue along with proper searches of all customers which I recognise is to ensure the safety of everyone inside, having said that in my experience of attending the venue the security have always been extremely friendly and helpful. Once inside the venue, my experience has also been super positive, it's clear they have made a huge effort to make customers feel safe with welfare and medical teams floating around the venue checking people are feeling okay.

In summary I would like to express my support for the extended licensing of the venue. With nightlife in London struggling so much as of late, I think Drumsheds is a very important cultural space for the community and for the whole of London.

I feel totally safe here and will continue to attend shows to come.

I wanted to express my support with drumsheds and my personal experience of attending the club.

Drumsheds is one of the most organised clubs I have been too in the UK. After attending many events such as rinse, honey Dijon and the hydra not only have I felt safe in the club but also leaving with travel organised for you as you leave really makes a difference for all the events.

It's a safe environment, there is someone always on hand, the searches on arrival also reassures me the club has security in place. The club has provided me with some of my favourite memories to date and this is down to the organisation and safety of everyone attending.

The anti drug stance is extremely clear and they even put little lids on your drinks to stop spiking - which is not something many other venues in London do. Upon entry the security is calm, welcoming, and well organised. I am confident that the search is well handled, and that staff feel

Appropriately trained to handle any situation which may later pose danger to individuals oothers. Inside the venue the security and staff presence remains strong, and it would not take long to find help should it ever be needed.

SUP75 Representation:

Drumsheds is hands down one of the best places to rave in London—and honestly, it's the only club I consistently choose to attend for the various shows it produces from Hydra, Bugged Out nights to classical music events. With over 20 years of clubbing experience and a background in the music industry, I can confidently say this venue, its staff, and their policies set an exceptional standard for a safe, friendly, and professional experience. Other clubs have a lot to learn from them. It's rare to find a place that does it right in London, and if Drumsheds were to disappear, I doubt other venue would come close to matching their level of care and professionalism at such scale for the high profile programming they offer. Clubbing is part of my culture, how I express myself, gather inspiration and congregate with people I love - getting rid of Drumsheds would be like knocking down a church.

From the moment you arrive, the vibe is incredible, and I always feel completely safe. The staff are super friendly and informative, and the security checks are thorough but respectful—you can tell they really care about keeping everyone safe. When I attended while on strong pain medication, security noticed my tablets during the bag search and checked in with me to make sure I was okay, reminding me not to drink and letting me know medical support was available on-site if needed. It's those extra steps that make the difference.

I also value their anti-drug stance and efforts, which really contributes to the positive atmosphere. As a woman who's experienced being spiked at other clubs on a couple of occasions, their considered extras, like drink lids for open cups and straws, don't go unnoticed. It's these policies that make it a place where I can truly let go, enjoy the music, the sound system, feel free and dance with my mates. If Drumsheds didn't exist, the London music and club scene would have significant hole - opportunists would try to fill this gap, but would struggle to even match let alone maintain safe clubbing standards Drumsheds provides.

SUP76 Representation:

Their commitment to fostering an inclusive, secure environment sets them apart and demonstrates their leadership in the industry.

As an organization that advocates for improving standards across nightlife, we strongly support Drumsheds and their licensing. Losing this venue would be a significant setback for the industry and the community.

Drumsheds creates a safe and positive environment for events, more so than any other venue I've been to and I've always had a great time there. It's a fantastic space, and I hope it continues to be a part of our community, especially during a time where London's night club scene is struggling.

SUP78 Representation:

I am writing to say that I've attended many Drumsheds shows- False Idols, Bicep, SAULT..the list goes on, and every time it's been the most professional of venues- seamlessly run with brilliant and safe ingress/egress. I work in the industry and am always so impressed by the operations here.

It's a safe, friendly, clean and well operated venue.

SUP79 Representation:

Please find this as a letter of support for the Drumshed venue in Enfield.

My name is xxxx and I work in operations, security and safety in the events industry in London. I have previously been the recipient of a successful events licence for the Elrow festival from the London Borough of Enfield, and worked closely with the council to successfully complete the event in 2019.

At a time when the UK media's rhetoric around the music industry has mainly focussed on the closure of venues due to financial and social issues, I was delighted to hear about the opening of such a landmark venue for culture and commercial events. I felt that this put London on the map again to be bold at a time of hardship for the events and music industries after the covid pandemic and during the cost of living crisis.

I have attended the Drumshed venue several times since its opening for multiple different events. The first time I attended was during the opening season and I was most recently there at the end of October this year. As someone who works in the operational, security and safety areas of the industry, going to new venues is very much a busman's holiday as these are the things that I primarily look out for, especially at a venue of this size and when attending with friends.

From the moment I stepped off the train at the station there was support for attendees to get to and from the venue safely and to allow the local residents to not be too disturbed by such a large number of people moving around the local area. There were security touch points with very vocal guards from the station all the way up to the front door, giving multiple opportunities to spot unwanted behaviour.

When at the venue I was delighted to see such a friendly but thorough search taking place as I entered. This was at peak ingress, but the guards remained vigilant with every attendee that I saw as well as myself and my wider group of friends. Guards explained the process so it was easy to understand and the search was thorough and professional. The entrance queues moved steadily and meant that there were no unforeseen issues with the entry process.

When in the venue the security presence was reassuring and I saw both static guards at emergency exit points and also response teams assisting in areas where crowd density was higher and moving through the crowd scanning the behaviour of attendees. All guards that I spoke to were knowledgeable about the venue and helpful, as well as being generally attentive to attendees. I also saw H&S officers in certain areas at peak times, actively monitoring crowd movement.

I have read in the news that the reasons for the licence being placed under review is due to two drug-related deaths, which are tragic occurrences that cannot be minimised. However from a licensing perspective they must be looked at in the context of the number of people who have safely moved through the venue over the time that it has been open. This is not the forum to speak about harm prevention as an alternative to zero tolerance, but there are other more effective ways to keep people safe rather than to close down the venues that are enjoyed by hundreds of thousands of people per year. Venues that keep people employed, add considerably to the local economy, and bolster London and the UK's reputation as leaders in cultural venues.

SUP80 Representation:

I am writing as a guest of Drumsheds to express my support for this venue during its licensing review. Having attended several events at Drumsheds, including recently on the 7th December for the Bicep show, I can confidently say that the venue provides a safe, well-managed, and inclusive environment that contributes significantly to London's nightlife.

From the moment you arrive, the venue's safety measures are clear. I've often thought it's almost comical how thorough the searches are, but for such a large venue there is obviously a reason they leave no stone unturned - this makes me feel so much more assured when I'm there and contributes massively to the safe space that the Drumsheds team have created.

Drumsheds also prioritizes inclusivity and diversity. It fosters an environment where everyone feels welcome, regardless of background or identity. This is essential in a

city as diverse as London, and it sets Drumsheds apart as a space where people can come together through music and shared experiences.

Drumsheds' collaboration with organizations like The Loop further demonstrates their commitment to safety and well-being. By this measure they're head and shoulders above all other venues at least in London, I'm not aware of any other space that is leading the charge in back of house drugs testing. This is monumental forward progress, such initiatives are crucial in ensuring that nightlife remains a positive and secure space for all attendees.

London's nightlife is a vital part of the city's culture, and venues like Drumsheds play an irreplaceable role in sustaining it. The closure of such a space would not only be a loss to the capitals music scene, but an entire backwards leap for the vibrant and diverse culture that we should be championing in this city.

SUP81 Representation:

I'm a guest of Drumsheds and have very much enjoyed two events at their site this year. I've attended Sugar Babe's comeback show in February, and most recently an event that saw Fourtet headline in November.

It's been brought to my attention that their license is under review, and I would like to share with you my experiences and thoughts. I am a London resident and a music professional myself and it is my opinion Drumsheds enriches our city's cultural landscape with significant value. Drumheads is an exciting venue for experiencing live music at a large scale, and an unequalled one in London, not least in light of the closure of Printworks, Broadwick Live's previous home for the events that they promote. Seeing artists perform at this scale with the production value that the venue provides is truly unique, in London, the UK and beyond.

My experiences at Drumsheds have been nothing but positive from a spectators point of view. But also, from my professional experience I recognise and can testify that my experience with the venue's crowd management has been nothing but impressive, pleasant and professional. Drumsheds provides a safe space for a large amount of visitors, their communication with their visitors on their house policies is diligent and clear, and safety measures that have been in place at both events I attended made me feel safe. Equally, the way they manage their large crowds and transport to and from the club has on both occasions been incredibly professional and well organised.

Please consider my testimony as part of the venue's license review. I sincerely wish and hope to be able to share many more special moments at Drumsheds with music fans alike.

SUP82 Representation:

I am a 67 year old woman and have been to 4 very different cultural performances at the extraordinary Drumsheds venue. Although I was saddened by the recent events I have to say that, in my experience the security and welfare staff have gone above and beyond to make sure people are safe. Even I at my great age I was thoroughly searched at the entrance on every occasion. I was very impressed.

We live in drug culture, drugs are everywhere and as far as I have experienced Drumsheds do their utmost to keep everyone safe.

SUP83 Representation:

I'm writing in support of the Drumsheds licensing review on the 7th January, 2025. Having attended multiple events at the venue since its opening, including the Fatboy Slim event, I have consistently observed the smooth operations and the care taken to ensure the welfare of all attendees.

I was a DJ in the 70s and have always been keen on attending music events in clubs and venues all through the decades

Now I'm an older person, keen to see that music events maintain the spirit of excitement and inclusion where everyone is having a good time and all generations are included. Keen also to report on bad vibes and negative experiences.

Currently I find that young people are inclusive of my 75 year old self, taking lots of selfies and "well done for still being here". This applies particularly to the Drumsheds.

I am watching how things are organised. Can't help myself comparing all the generations and how dynamics change. I have experienced good times and bad, and my experience is long lived. My feeling is that, these days, the young are more inclusive, aware of each other and, collectively, ready to quell any rising aggression. More so than in the past.

At the Sugar Babes, and Fatboy Slim events, I noticed that the searches at entry were thorough, and staff were really intensive. Always on hand to assist with any queries. Additionally, there was a well-marked welfare area in the main bar concourse, with clear signage throughout the venue pointing to it, which I believe further demonstrates the venue's commitment to safety and attendee well-being.

So from way back in the my youth, the 1970s, to now, I feel that the professionalism of the staff at Drumsheds and their attention to safety measures have exceeded my experiences of previous decades and contributed to a positive experience at every event I've attended.
