DECISION

AGREED:

1. To recommend to Council to approve a total budget of £33m as detailed within the Part Two of the report and that this figure is included in the Capital Programme for the delivery of a proposed housing scheme at the Bury Street West Depot.

Subject to no call-in being received, the following decisions will come into effect on Friday 21st November 2014:

approval (19th November 2014)

- a. Subject to Council approving the addition of the budget for the project in the Capital Programme in 1 above, to approve the budget for Stages 1 and 2 of the project and, approve the commencement of the procurement of consultants to prepare plans for the scheme as detailed within the Part Two of the report, and delegate approval for the appointment of consultants to the Cabinet Member for Housing and Estate Regeneration in consultation with the Director of Health, Housing and Adult Social Care and the Director of Finance, Resources and Customer Services.
- b. To approve the details of the scheme and its expenditure with the approved total budget subject to a further report being submitted to Cabinet.
- c. To delegate authority to the Cabinet Member for Housing and Estate Regeneration in consultation with the Director of Health, Housing and Adult Social Care and the Director of Finance, Resources and Customer Services to approve a mix of house types and tenure arrangements in advance of a planning application submission.
- d. To delegate authority to the Director of Health, Housing and Adult Social Care and the Director of Finance, Resources and Customer Services and with the Assistant Director of Strategic Property Services to submit a planning application for the redevelopment of the site.
- e. To approve the commencement for the procurement of a developer/contractor to take forward a scheme on receipt of planning permission and award of contract will be subject to further Cabinet approval.
- f. To note that a further in depth report will be presented to Cabinet updating the progress to date with the preferred delivery option for the site that have been detailed for consideration with the Part Two of the report.
- g. To approve in principal the acquisition of a property as detailed in the Part Two report.
- h. To note that the initial budget will be used to appoint consultants to assist in preparing scheme designs, feasibility studies, other investigations, site preparation and public consultation to support the preparation and submission of a planning application and appropriate documents to assist in the procurement of a developer/contractor and for land assembly purposes if required.
