- 1. Approve the inclusion of five additional land parcels to form part of the Alma Estate development, which are shown hatched Green on the Plan attached at Appendix 3, of the report.
- 2. Subject to 1 above, approve the boundary of the CPO plan attached at Appendix 1, of the report, to include these five additional parcels within the Order Land:
- 3. Note the draft Statement of Reasons (attached at Appendix 2 of the report) which sets out the justification for making the London Borough of Enfield (Alma Estate Regeneration) Compulsory Purchase Order 2014 in relation to the Order Land.
- 4. Resolve to use the Compulsory Purchase Order powers under section 226 1 (a) of the Town and Country Planning Act 1990 (as amended) to make the London Borough of Enfield (Alma Estate Regeneration) Compulsory Purchase Order 2014 in respect of the land shown edged red on the Plan ('the Plan') attached at Appendix 1 of the report to effect acquisition of land and new rights within the areas described in the report and shown edged red on the Plan (the proposed 'Order Land'). The Council being of the view that the proposed acquisition of the Order Land will:
 - a) Facilitate the carrying out of the development/redevelopment or improvement on or in relation to the Order Land; and
 - b) Will contribute to the promotion or improvement of the economic, social and environmental well-being of the Borough.
- 5. Delegate authority to the Director of Health, Housing and Adult Social Care, acting in consultation with the Director of Finance Resources and Customer Services, to take all the necessary steps consequent to the making of the London Borough of Enfield (Alma Estate Regeneration) Compulsory Purchase Order 2014 on the basis that there is a compelling case in the public interest to make the Order, including:
 - a) To publish the draft London Borough of Enfield (Alma Estate Regeneration) Compulsory Purchase Order 2014, to seek confirmation of the Secretary of State and if confirmed, implement the Order;
 - b) To modify the draft Statement of Reasons and the Order Plan and effect any other procedural requirements including (but not limited to) the publication and service of all notices and the presentation of the Council's case at any public inquiry;
 - c) To acquire any interests in land within the Order area by agreement and the making of payments equivalent to the market value of the property interest being acquired plus any statutory payments and disturbance compensation or the provision of property or services in lieu of the market value of the property interest being acquired and any statutory payments and disturbance compensation, in contemplation of the Order being made; and
 - d) If and when the Order is confirmed then to acquire by compulsion and make payments of statutory compensation, if voluntary agreements cannot be reached.

DECISION

AGREED: that the Leader, acting on behalf of Cabinet under the Cabinet urgency procedure approve:

- 1. The acquisition of the property at 30-38 London Road, Enfield EN2 6EF by the Council at auction (or prior) on the terms agreed as detailed in this report and in the Part 2 report and the recommended addition of the required funding to the capital programme (subject to para 2.3 of the report).
- 2. The release of General Fund capital resources to enable the acquisition, as set out in the Part 2 report.
- 3. That the Director of Finance, Resources and Customer Services be granted authority to make the necessary arrangements to acquire the property at maximum price, as set out in the Part Two report.
- 4. That management of the property and all leasing agreements with various tenants be delegated to the Director of Finance, Resources & Customer Services to administer and complete.
- 5. The addition of the capital funding requirement to the Capital Programme, subject to the property being acquired at auction.

ALTERNATIVE OPTIONS CONSIDERED:

Not trying to acquire the property is considered a lost opportunity to add flexibility to the existing investment portfolio, as well as losing the opportunity to add a key strategic land holding within the Town Centre.

REASONS FOR RECOMMENDATIONS:

- 1. This is a rare opportunity within the Enfield property market. The site's planning context and its possible future development potential in a regenerative context is unique and shows the Council's commitment in enabling development within the Town Centre.
- 2. The income stream produced by the property will enable the Council to meet its funding requirements over the short to medium term, with development proposals to come forward in the coming years.
- 3. Due to the need for an urgent decision to enable the Council to take advantage of the opportunity at auction to acquire the property, it has been necessary to use the Council's urgency procedure in order to gain the necessary approvals to proceed.
