- 1. To note that under S106 of the Local Government Finance Act 1992 any Member who is two months or more in arrears on their Council Tax would be required to declare their position and to not vote on any issue that could affect the calculation of the budget or Council Tax.
- 2. With regard to the revenue budget for 2015/16:
- i. To set the Council Tax Requirement for Enfield at £100.917m in 2015/16;
- ii. Subject to final pupil count data, to approve expenditure of £307.837m in 2015/16 for the schools' budget, funded from the Dedicated Schools Grant;
- iii. To set the Council Tax at Band D for Enfield's services for 2015/16 at £1,100.34 (as detailed in para 8.1 of the report), there being no increase over the 2014/15 Council Tax;
- iv. To approve the statutory calculations and resolutions set out in Appendix 10 of the report.
- 3. With regard to the Prudential Code and the Capital Programme:
- i. To note the information regarding the requirements of the Prudential Code (as detailed in Section 9 of the report);
- ii. To agree the Approved Capital Programme for 2015/16 to 2018/19, as set out in Table 9 and appendix 9 of the report and to note the Indicative Capital Programme, which would be reviewed in the light of circumstances at the time;

- 1. The progress made to implement the Care Act in Enfield and the key risks associated with implementation and the mitigating actions.
- 2. That the financial modelling to understand the impact of the Care Act continued at both local, regional and national level including through ADASS and London Councils, as advised at July Cabinet and October Council meetings. This would include ensuring a robust response to the government consultation on the funding reforms due in February. As previously reported, when the Government introduced the Care Bill it advised that any new burdens on local government would be funded. Until clear funding allocations are made available, there is a risk that this cost is not fully funded, but, at present it is not possible to form an opinion.
- 3. The major change was taking place within Enfield 2017 and this had provided a positive framework for Care Act implementation, in particular changes to the Gateway Services and assessment hub.

- Winchmore Hill (WMH028) Public Notice Boards to receive comments from Highway's officers and evidence of consultation.
- (4) To note that the following applications were withdrawn by ward councillors:
 - Lower Edmonton (LOED062) Dance Classes.
 - Southgate Green (SGTG021) Palmers Green Festival.

- (5) The following applications were not approved as they did not meet the criteria:
 - Jubilee (JUB036) Aiding Young Children Football Leagues, as it was not clear that there would be any benefit to children or young people.
 - Ponders End (PE047) Ponders End Park Planting, as the Parks Department was not in support of the project and it conflicted with existing work.
- (6) The chair of the sub-committee be given delegated authority to provide approval in cases where the applications are agreed in principle, subject to certain conditions and these conditions have been met.
- (7) The sub committee approves the contract/funding variations relating to Winter Wonderland (ENFL018 and HIWAY039) and Albany Park Community Hub Events (ENFL028) as set out in paragraph 3.4 of the report.
- (8) That the sub committee supports the decision to require applications from charitable organisations to be supported by their board of trustees.

ALTERNATIVE OPTIONS CONSIDERED:

That the projects are not considered and the funding is not allocated, this would not be recommended as this will not support community engagement and will not allow residents the opportunity to further improve the local area in which they live or work.

REASONS FOR RECOMMENDATIONS:

The projects submitted have been proposed and developed by the local people of Enfield, to help improve the social, economic or environmental wellbeing by tackling local need and deprivation. The projects all support the Council's vision of making Enfield a better place to live and work, delivering fairness for all, growth and sustainability and strong communities.
