DECISION

AGREED: subject to no call-in being received, the following decision will come into effect on Thursday 26th March 2015:

- 1. That officers actively commence the process of seeking relevant partners to deliver the proposed Enfield community libraries in accordance with the aims of the draft Library Development Strategy in preparation for a final decision by Council in June/July 2015.
- 2. That officers engage with appropriate organisations from the voluntary, community, statutory and commercial sectors by appropriate means and methods to identify potential partners who are able to deliver the aims of the Development Strategy.
- 3. That once partners are identified and agreed in principle, officers negotiate and agree the terms by which the service may be delivered at individual locations in preparation of and subject to the Council obtaining full and final authority in respect of the Library Development Strategy in accordance with the Council's constitution.
- 4. That realistic timescales for implementation be identified as part of the terms of agreement with partners.

ALTERNATIVE OPTIONS CONSIDERED:

1. The Council can decide not to undertake this preparatory work. However, by entering into this engagement with potential partners, the Council can produce a more detailed and informed report and draft strategy for Cabinet and Council to consider.

REASONS FOR RECOMMENDATIONS:

1. By entering into this engagement with potential partners, the Council can produce a more detailed and informed report and draft strategy for Cabinet and Council to consider. The consultation responses supported the idea of co-location and community libraries. No decisions will be taken and all potential partners will be made aware of the fact that the Council may choose not to proceed with the model of community library. The engagement does not pre-determine the final decision in any way.
