DECISION

AGREED: subject to no call-in being received, the following decision will come into effect on Tuesday 5th May 2015:

- 1. That the Cabinet Member for Housing and Estate Regeneration approves the Council concluding an Official Journal European Union (OJEU) compliant 'Housing Framework' agreement with the Contractors listed in Appendix 1 of the Report.
- 2. That the Cabinet Member for Housing and Estate Regeneration notes the creation of a "Strategic Alliance Agreement" with the proposed Framework Contractors, and the funding mechanism, which will help to deliver a single point of contact for training and job opportunities arising out of the planned programme of works between 2015 and 2018.
- 3. That the Cabinet Member for Housing and Estate Regeneration delegates authority to the Director of Regeneration & Environment to appoint the appropriate member of staff to support the operation of the "Strategic Alliance Agreement" with the proposed Framework Contractors.
- 4. It is also recommended that the Cabinet Member for Housing and Estate Regeneration, notes the revised timetable for delivery of the proposed works for the Lytchet Way contract, which will now be the subject of a separate report later this year.
