DECISION

AGREED: subject to no call-in being received, the following decisions will come into effect on Monday 14th September 2015:

To approve the novation of the contract from Temple Bright LLP to Lux Nova to ensure the continued engagement of the key personnel.

ALTERNATIVE OPTIONS CONSIDERED:

- 1. The contract remains with Temple Bright LLP; this would not be practical, as Temple Bright no longer have district heating expertise following the departure of the key personnel.
- 2. There is a new procurement for the provision of legal support services to LVHN: due to the project being at a crucial stage, to lose the continuity and experience of the Key Personnel would have a significant impact on the project as a whole. In addition the time that it would take to undertake a new procurement exercise would cause delays in the completion of the project.

REASONS FOR RECOMMENDATIONS:

- 1. The evaluation criteria used during the original procurement for legal advisers placed significant weight on the skills and experience of the personnel put forward by the competing firms. The key personnel were therefore instrumental in securing the award of the contract to Temple Bright.
- 2. The LVHN project is now at a crucial stage, and to lose the continuity and experience of the Key Personnel would have a significant impact on the project as a whole. In addition, the time that it would take to undertake a new procurement exercise would cause delays in the completion of the project.
