DECISION

AGREED: subject to no call-in being received, the following decisions will come into effect on Monday 12th October 2015:

- 1. That the proposed scheme is to be funded from the Housing Capital Programme.
- 2. That approval is given to accept the lowest price tender complying with the tender requirements of the Council submitted by Contractor 1 (As set out in Part 2 of the Report).
- 3. To note the financial appraisals in support of the recommendations, as set out in the Part Two Report.

ALTERNATIVE OPTIONS CONSIDERED:

The scheme forms part of the Council's major works programme, which includes for external refurbishment to ensure Council property is maintained. It was assessed as a priority on the stock condition survey and therefore no other alternatives have been considered.

REASONS FOR RECOMMENDATIONS:

- 1. All contractors who tendered for this project have fulfilled the Council's criteria for undertaking this type of value of work.
- 2. The recommended contractor has submitted the lowest priced tender and has been judged capable of complying with the specification and quality requirements.
- 3. The scheme provides for additional accommodation from the right to buy receipts to help towards addressing the current shortfall in housing in the Borough.
- 4. This scheme forms part of Enfield Homes' on-going programme to maintain its housing stock and fulfil its landlord obligations.
