## **DECISION**

**AGREED:** subject to no call-in being received, the following decisions will come into effect on Monday 7<sup>th</sup> December 2015.

- 1. That approval is granted for a new lease for a term of 10 years to Fit4less in accordance with the Heads of Terms detailed in the part 2 report.
- 2. To delegate agreement on the detailed lease terms to officers under the scheme of delegation subject to any amendments being non material in nature and otherwise in accordance with the Heads of Terms set out in the part 2 report.

#### **ALTERNATIVE OPTIONS CONSIDERED:**

1. Retention of the property in a vacant site is clearly not in the Council's best financial interest. If the property remained unlet it would fail to deliver a rental income stream to support borrowings and repayment of capital on the Library refurbishment scheme. In addition the Council would remain liable for outgoings including but not limited to repair, maintenance and business rates.
