#### **DECISION**

The following motion submitted for consideration at the Extraordinary Council Meeting was not approved:

In the name of Councillor Neville

"The Council condemns the behaviour of Councillor Stafford during the debate on the government's Trade Union Bill at the Council meeting on 11<sup>th</sup> November 2015, when he used an extremely abusive epithet directed at Councillor Alessandro Georgiou during the latter's speech.

Given that Councillor Stafford's portfolio responsibilities include legal and governance, in using such language he failed to lead by example. He has not only brought disgrace upon himself, but also on the Council and the Enfield Labour Group. In the absence of his voluntary resignation from the cabinet, this Council calls on the Leader to dismiss Councillor Stafford forthwith as a member of the Cabinet."
