DECISION

AGREED: subject to no call-in being received, the following decisions came into effect on Monday 1st February 2016.

- 1. To approve the award of the Contract to Ernst Young.
- 2. To note that the value of the contract and its construction is commercially sensitive until completion of the long term co-source arrangement approved by Cabinet on 18th November 2015.
- 3. To note the value of the contract as detailed in the Part Two Report.
- 4. To note that two elements of the tender proposals are interlinked with further details in the Part Two Report.

ALTERNATIVE OPTIONS CONSIDERED:

- 1. An option considered was the centralisation of existing staff from across the Council with no requirement for external support, but given the success of the pilot arrangement in Health Housing and Social Care Brokerage it was clear this was not the optimal solution either from a savings point of view, or a staff development one.
- 2. The option to move to a full tender immediately was also considered. However the Strategic Transition Board (STB) identified that it would be beneficial for all procurement and commissioning staff from across the Council to have worked alongside a delivery partner and to have benefited from the associated skills transfer within such an arrangement, before any recruitment and selection process to post with the new hub is undertake, and so the time taken for a full tender process would make this option less favourable. Additionally, this option was discounted as the need to make in year savings greater than the cost of the contract meant that it was not financial viable to delay the process.

REASONS FOR RECOMMENDATIONS:

The STB identified that it would be beneficial for all procurement and commissioning staff from across the Council to have worked alongside a delivery partner and to have benefitted from the associated skills transfer within such an arrangement, before any recruitment and selection process to posts within the new hub is undertaken and there was a need for an interim arrangement to delivery procurement and commissioning and support the identification and delivery of in year savings across the Council.

2. Rule 16 - Special Urgency

This procedure should only be used in exceptional circumstances where it is not possible to:

- provide the required 28 days' notice prior of a key decision; and
- provide a minimum of 5 working days' notice prior to the decision needing to be taken;

These decisions will not be eligible for call-in.

Reasons for Urgency:

Urgent approval is sought for the implementation of this decision for the following reasons:

- In order to maintain professional oversight of our brokerage service, which undertakes social care placements and negations requiring appropriate supervision and leadership at all times to ensure safeguarding requirements are maintained for vulnerable.
- To ensure that savings are embedded in both the current financial year and the processes and procedures put in place to ensure future delivery of improved outcomes and lower cost to the council.
- To provide clarify to staff around line management and professional support following LB Waltham Forest deciding to withdraw from the joint procurement arrangement with Enfield Council.
- To ensure all current tenders remain fully compliant with Council procedures and EU Law and bidders are not disadvantaged by any 'gap' in the provision of clear, concise and appropriate information on the leadership of the Council's procurement and commissioning function. This has to be done by Monday 1st February 2016.

It was not able possible to give the required 28 day notice and include the decision on the Council's Key Decision List because of the timing of the decision by London Borough of Waltham Forest to withdraw from the joint procurement team and the associated changes this has bought to the Councils own timetable for change.

Reasons for Urgency:

This proposal has been negotiated within a commercial confidentiality agreement and the financial modelling is based on significant commercial discounts from alternative suppliers that are time limited in nature. In order to minimise costs of transition and reduce risk a positive decision needs to be communicated to our partner suppliers without creating unnecessary uncertainty or delay within this process that a 28 day publicised lead in time would create. Some of the staff involved within service areas affected by this proposal support and administer highly sensitive systems, including those that underpin our safeguarding services and being able to ensure we are able to offer clarity of message and strong leadership regarding future direction of the service will be essential to staff retention and given the pace that negations have been concluded this cannot be achieved by a 28 day notice period.

It was not able possible to give the required 28 day notice and include the decision on the Council's Key Decision List because give the above reason and given the pace that negations have been concluded this cannot be achieved by a 28 day notice period, within the budget and savings proposals being offered as several elements of the proposal are time limited.
