#### **DECISION**

**AGREED:** subject to no call-in being received, the following decisions will come into effect on Monday 21<sup>st</sup> March 2016:

To approve:

- 1. The final New Homes Bonus (NHB) funded programme (paragraph 4 of the report); and
- 2. That the London Borough of Enfield enters into a grant agreement with the Greater London Authority for the grant funding.

# **ALTERNATIVE OPTIONS CONSIDERED:**

There are no alternative options comparable to the scale of the NHB programme available at this time. The GLA have agreed the funding allocation in principle and the grant agreements need to be formalised to allow delivery.

## **REASONS FOR RECOMMENDATIONS:**

- 1. The revised proposal allows a more joined-up approach and will add to other regeneration and business support activity within the Borough.
- 2. The NHB funding enables the Council to leverage in substantial funding to support the Council's ambition of creating thousands of additional jobs in the Borough.
