#### **DECISION:**

**AGREED:** Subject to no Call-in being received, the following decision will come into effect on Monday 12 September 2016: The Director of Regeneration and Environment:

1. To approve the release of £2,791,662 in Section 106 contributions received for the provision of affordable housing in the Borough to support the delivery of affordable housing as part of the Council's estate regeneration and to support of housing association developments as shall be notified to him.

#### **ALTERNATIVE OPTIONS CONSIDERED:**

No other options have been considered as, unless the s106 affordable housing contributions are used for the intended purpose, the Council shall be obliged to return the unspent amounts to developers with any accrued interest. This would negate the purpose of requiring developers to contribute to the provision of affordable housing in the Borough as a result of carrying out new developments.

## **REASONS FOR RECOMMENDATIONS:**
