# **AGREED** the following motions:

# In the name of Councillor Sarah Doyle:

"The Council calls upon the Government to make fair transitional state pension arrangements for all women born on or after 6th April 1951, who have unfairly borne the burden of the increase to the State Pension Age (SPA) with lack of appropriate notification.

Hundreds of thousands of women had significant pension changes imposed on them by the Pensions Acts of 1995 and 2011 with little/no/personal notification of the changes. Some women had only two years notice of a six-year increase to their state pension age. Figures show that more than 15,000 women living in the London Borough of Enfield have had their State Pension receipt date moved to the ages of between 63 and 66 years old.

Many women born in the 1950's are living in hardship. Retirement plans have been shattered with devastating consequences. Many of these women are already out of the labour market, caring for elderly relatives, providing childcare for grandchildren, or suffer discrimination in the workplace so struggle to find employment.

Women born in this decade are suffering financially. These women have worked hard, raised families and paid their tax and national insurance with the expectation that they would be financially secure when reaching 60. It is not the pension age itself that is in dispute - it is widely accepted that women and men should retire at the same time.

The issue is that the rise in the women's state pension age has been too rapid and has happened without sufficient notice being given to the women affected, leaving women with no time to make alternative arrangements. The Council calls upon the Government to reconsider transitional arrangements for women born on or after 6th April 1951, so that women do not live in hardship due to pension changes they were not told about until it was too late to make alternative arrangements.

# **MOTIONS CONTINUED**

We call upon the Leader of Enfield Council to write to the Secretary of State for Work and Pensions in the strongest possible terms, urging that fair transitional arrangements are introduced forthwith."

# In the name of Councillor Mary Maguire:

"This Council asserts that Councillors should uphold the principles of democracy and fair representation. It is, therefore, appalled that an entire political grouping of this Council should show such contempt for the democratic process through a planned walkout, en masse after 20 minutes, and mislead our residents present in the public gallery. The actions of the minority group on 21st September 2016 ensured they were absent for important debates.

Such actions produce a democratic deficit and show a scandalous disregard for the Council, its officers, the Mayor and residents of the London Borough of Enfield. This Council calls on the Councillors concerned to apologise publicly to the Mayor, the officers and the residents of Enfield.

Furthermore, this Council agrees to refer this matter to the Monitoring Officer and the Councillor Conduct Committee."

"This council is concerned to note that Councillor Katherine Chibah, a permanent member and Vice Chair of the Overview and Scrutiny Committee (OSC) has missed meetings on 30 June, 3 August, 4 October (the latter called to consider the council's projected revenue overspend), and 11 October. She has also now indicated that because she has been involved in the American elections she will not be here to consider several call-ins on the scheduled meeting date of the 10 November.

Council is even more concerned to note that in seeking to obtain a substitute for her at the meeting on 10 November, Councillor Chibah wrote to Councillors Maguire, Nesil Cazimoglu and Jemal, an email which included the following words:

"the Tories are absolutely playing silly games with these latest vexatious call-ins so we need someone who can give them a hard time and direct questions at them rather than at the Cabinet Member concerned....so any of you would be perfect...."

In so doing Councillor Chibah displays a complete failure to understand the statutory and constitutional independent role of members of the Overview and Scrutiny Committee which is particularly alarming given she is the elected Vice Chair, and by this action she renders herself wholly unsuitable to be a member of the OSC. Council therefore resolves to terminate her appointment as a member of the OSC and instructs the majority part to nominate a successor."

#### **DECISION:**

AGREED: Subject to no call-in being received, that the following decision will come into effect on Monday 21 November 2016:

1. To approve twelve providers and appoint them to a select list to provide Semi-Independent Accommodation with Support for Enfield Looked After Children and/or Adolescent & Leaving Care Service Clients aged 16-24. The duration of this list is 3 years (36 months), although providers can be removed during this providers can be removed during this period if they either cannot fulfil the requirements, fail to meet the required service standards or they request to be removed.

### **ALTERNATIVE OPTIONS CONSIDERED:**

- 1. There are no alternative options to tendering externally, as the Council is unable to provide such an extensive specialist service.
- 2. Providing Accommodation and Support is an obligation under the Children Leaving Care Act 2000 for those 16/17 year olds, leaving or preparing to leave care and also for those 16 and 17 year olds who are 'looked after children' under section 20 or section 31 Children Act 1989, it is therefore viable to have no service to all.
- 3. Corporate Procurement have been fully involved in the process and have agreed that the Select List model would be best suited to our requirements.

# **REASONS FOR RECOMMENDATIONS:**

1. The current framework has proved to be successful in securing good quality independent supported accommodation services your Young People aged 16 and 17. The Select List will enable us to continue the work already undertaken through the current framework while allowing us the flexibility to procure from new or specialist providers during the term of the new Select List.

#### **DECISION:**

**AGREED:** Subject to no call-in being received, that the following decision will come into effect on Monday 21 November 2016:

- 1. To note that the Council has served notice on SAP to terminate the current support contract in accordance with the terms and conditions of contract.
- 2. To agree the award of call-off contract, in accordance with Crown Commercial Service (Enterprise Application Support Services Framework RM1032 Lot 2) for the provision of SAP support and maintenance for two years to "Rimini Street" on the terms set out in Part 2 of the report.
- 3. To agree that in lieu of the unlimited liability normally sought from suppliers, liability, for the purpose of the new contract with Rimini Street, shall be capped at £500,000 and to further agree that the requirement to obtain a performance bond/parent company guarantee (CPR 21),is waived.

# **ALTERNATIVE OPTIONS CONSIDERED:**

1. Continuing with SAP's current support arrangements, however, the service offered by the alternative providers, matches if not exceeds the current support offered by SAP. The savings identified are substantial for very little risk.

# **REASONS FOR RECOMMENDATIONS:**

1. The alternative provision recommended provides Enfield Council with the support they require for SAP going forward but at a substantial cost saving.

The support that is offered by the alternative providers includes:

- Personalised update packages with all updates tailored to our specific deployments.
- Timeliness The updates for legislative changes are delivered faster than those of SAP as they are specific to the customer.

This compares favourably to the distant support offered by SAP where changes are not client specific and require extensive testing to ensure they work with bespoke areas of coding.
