The Proposed Submission Central Leeside Area Action Plan be endorsed and referred on to Cabinet and Council for approval for publication, under Regulation 19 of the Town and Country Planning (Local Planning) (England) Regulations 2012, and thereafter be subject to a statutory period of public consultation and submission to the Secretary of State for public examination.
- 2. That the Cabinet Member for Economic Regeneration and Business Development be delegated authority to agree the publication of the Sustainability Appraisal and Equality Impact Assessment of the Proposed Submission Central Leeside AAP.
- 3. That the Director of Regeneration & Environment be delegated authority to make appropriate changes to the Submission version of the Central Leeside AAP and undertake any further consultation required, in the run up to and during the public examination process into the document, in response to representations received, requests from the Planning Inspector and any emerging evidence, guidance or legal advice. Changes of a substantive nature will be considered by the Local Plan Cabinet Sub Committee.
- 4. Following a vote of the Committee members, the name be changed from Central Leeside Area Action Plan to Edmonton Leeside Area Action Plan.
