### **DECISION:**

AGREED: Subject to no call-in being received, the following decision will come into effect on Monday 5 December 2016:

1. That the Forward Plan, Collections Development Policy, Collections Care & Conservation Policy, Documentation Policy and Access Policy Statement for Enfield Museum Service are approved, enabling the application for full accreditation to be made.

#### **ALTERNATIVE OPTIONS CONSIDERED:**

The option not to re-apply for Accreditation has been considered and rejected. Accreditation is the UK standard for museums and galleries. It defines good practice and identifies agreed standards, thereby encouraging development. It is a baseline quality standard that helps guide museums to be the best they can be, for current and future users. It is important that Enfield Museum retains Accreditation, as the standard fosters confidence in museums as institutions that hold collections in trust for society and provides a benchmark for grant-making bodies, sponsors and donors wishing to support museums.

# **REASONS FOR RECOMMENDATIONS:**

- 1. To enable the Accreditation Assessor to submit Enfield Museum's application for accreditation in December 2016 with the recommendation that full Accreditation is re-awarded.
- 2. To obtain ACE Accreditation.
