<b>AGREED:</b>							
1. To make the necessary traffic management order without modification and to take all other necessary steps to amend the boundary of the Oakwood CPZ to include Ashmead N14, as indicated on the plan in Appendix 1.							
<b>ALTERNATIVE OPTIONS CONSIDERED:</b>							
1. <b>Do nothing</b> – this option would mean that residents and their visitors would continue to experience parking problems in their roads.							
2. <b>Controlled Parking Zone with Longer Hours/ Days of Operation</b> – longer hours were rejected by a majority of residents at the earlier stage of consultation.							
<b>REASONS FOR RECOMMENDATIONS:</b>							
1. The proposed scheme has the support of the majority of consultation respondents within the proposed zone boundary and will benefit the residents of the area by deterring non-residents from parking in Ashmead.
