AGREED:

- 1. To approve the disposal of Coppice Wood Lodge to Newlon Housing Trust through an unconditional offer.
- 2. To delegate authority to the Assistant Director (Strategic Property Services) to negotiate any non-material changes to the terms of sale.

ALTERNATIVE OPTIONS CONSIDERED:

1. Retention of property without regular review is clearly not in the Council's business interests. If property is not disposed of, it would cause a reduction in capital spending or increased borrowing. However, evaluation of individual cases may result in retention being the better option.

REASONS FOR RECOMMENDATIONS:

1. Potential disposal of the properties is recommended as being in the Council's best financial interests balanced against service and community needs.
