Should you wish to change the operation of the club premises in the future by adding new licensable activities or by changing the hours or removing conditions then you will need to apply for a variation of the certificate. Please contact us for further advice.

The certificate is subject to an annual fee, payable on each anniversary of the certificate first being granted.

- 3. Any supply of alcohol for consumption off the premises must be made to a member of the club in person.**

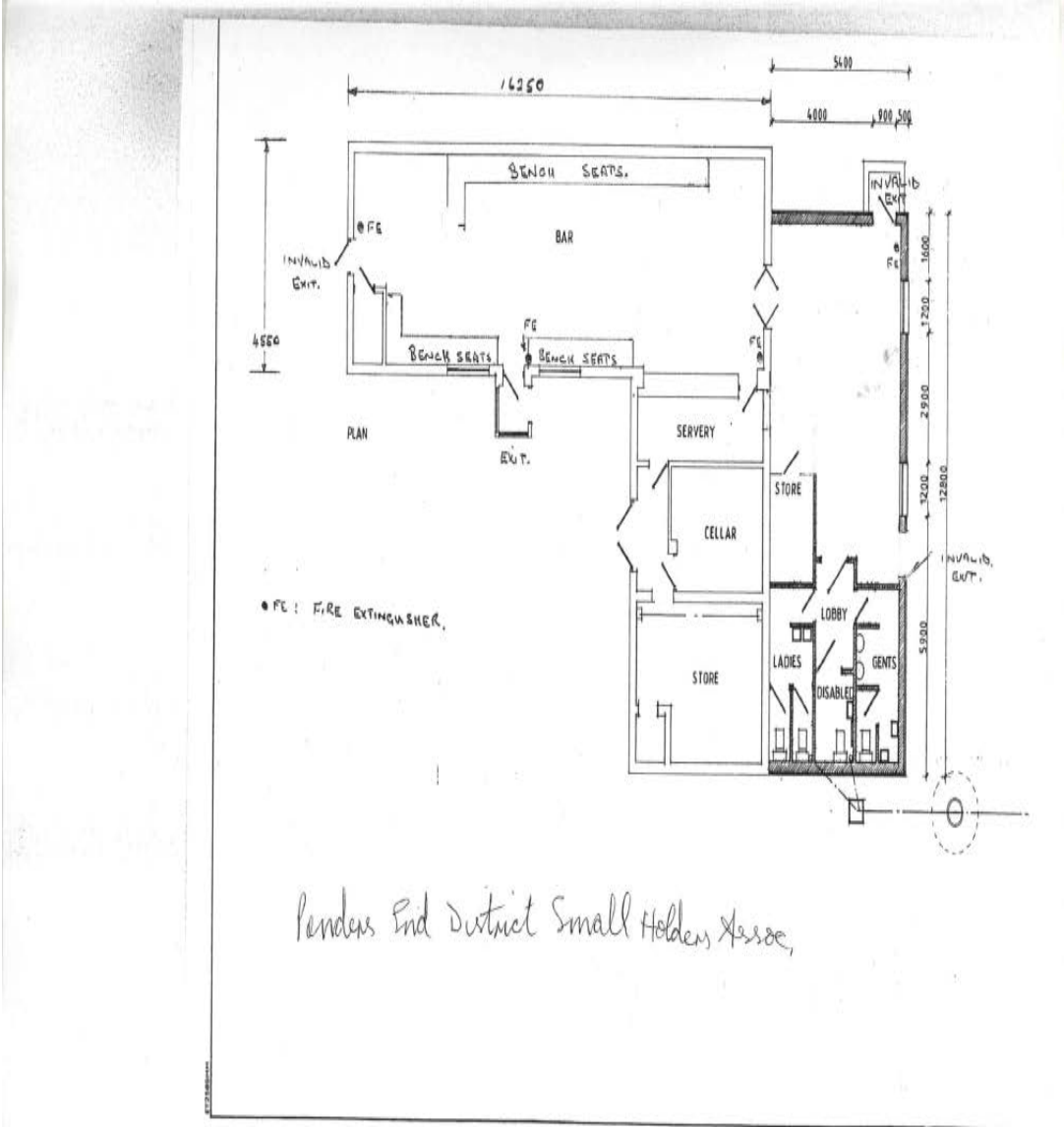
Annex 2 - Conditions consistent with the Operating Schedule
