To approve the grant of the lease to the successful applicant noted in Part 2 of the report. 2. To delegate authority to the Assistant Director of Strategic Property Services to finalise the lease terms and approve the final lease in consultation with the Assistant Director of Legal and Governance. **ALTERNATIVE OPTIONS CONSIDERED:** 1. Not to undertake a tender of the opportunity would have been a wasted opportunity to let this property that has sat empty for several years. 2. The Contract Procedure Rules (CPR) route was considered as a procurement approach; however after discussions with internal officers it was decided that this tender was for a lease, an interest in property, and hence it was considered best to proceed using the PPRs. **REASONS FOR RECOMMENDATIONS:** 1. It is recommended that the lease be granted to the chosen applicant for both lots to ensure a sustainable use including community use and sporting use for the next 20 years. 2. The property will undergo significant capital investment by the applicant bringing forward fit for purpose sporting facilities and community areas for all of the local area to benefit.
