1. That the Cabinet Member for economic Regeneration & Business Development approve the Revised Memorandum of Understanding (set out in Appendix 1) between the North London boroughs preparing the North London Waste Plan.

#### **ALTERNATIVE OPTIONS CONSIDERED:**

1. No other viable options exist. A signed Memorandum of Understanding (MoU) is already in effect but needs updating. If this is not revised, details contained within the agreement would not be in line with legal advice received since and exposes Enfield to significant risks in bringing about effective planning and regeneration in its area.

## **REASONS FOR RECOMMENDATIONS:**

1. Revising the NLWP MoU will ensure that the legal framework for delivering the Waste Plan is up to date.
