To approve the Variation to the existing contract to cover the additional services identified; 2. To authorise the authorised legal officer to complete and sign the Deed of Variation. 3. Recommendations as set out in the Part 2 report containing exempt information. 							
ALTERNATIVE OPTIONS CONSIDERED							
<p>1. Do nothing Do nothing would leave the Council without the support needed, resulting in an incomplete funding application for the Housing Infrastructure Fund. Consequently, the Council will be unlikely to secure the HIF funding from the MHCLG in early 2019 to deliver strategic infrastructure in Meridian Water.</p> <p>2. Re-tender Re-tender the additional services would result in a loss of valuable time and potentially the Council will lose the consultant that has all knowledge of the early work already carried out. Other companies will need time to catch up and get up-to-speed with the project. Delays at this stage of the project are likely to result in an inability to submit the funding application by the submission deadline of early December 2018, which will lead to missed opportunity to secure £156m of funding for strategic infrastructure in Meridian Water in early 2019.</p>							

REASONS FOR RECOMMENDATIONS

1. The current consultant was procured on a competitive basis for the original contract and apart from a high-quality response that showed excellent ability to undertake the work, their rates are competitive compared to the other bidders. The additional services are within budget already approved.
2. Re-tender the additional services would result in a loss of valuable time and potentially the Council will lose current consultant who have all knowledge of the early work already carried out. Delays are likely to result in an inability to submit the HIF funding application by the submission deadline of early December 2018, which will lead to missed opportunity to secure £156m of funding for strategic infrastructure in Meridian Water early 2019.
