1 MAYOR'S CHAPLAIN TO GIVE A BLESSING

Father Emmanuel Ogunnaike from St Edmund's Church, Edmonton gave the blessing.

2 DECLARATION OF INTERESTS

There were no declarations of interest.

3 ELECTION OF MAYOR

Councillor Caliskan moved and Councillor Laban seconded the nomination of Councillor Kate Anolue as Mayor of the London Borough of Enfield for the 2019/20 municipal year.

Councillor Caliskan said that she was delighted to nominate Councillor Anolue, a councillor held in high esteem, a strong, inspiring no nonsense, principled woman, who had previously been Mayor in 2013/14. She also welcomed her Young Mayor initiative.

Councillor Laban in seconding the nomination said that Councillor Anolue had in the past served the borough with distinction, had a dedication to public service, working as a midwife, was a caring and compassionate woman and she wished her all success in the year ahead.

AGREED that Councillor Kate Anolue be elected Mayor of the London Borough of Enfield, for the 2018/19 municipal year.

Councillor Anolue then made and signed a declaration of acceptance of office and was invested with the badge of office by Councillor Karakus, the retiring Mayor.

4 MAYOR'S ACCEPTANCE SPEECH

The Mayor began by saying it was wonderful to be back and that she would speak from her heart.

The Mayor thanked everyone for being there and welcomed them all to the meeting.

The Mayor said that she was proud to be part of this great, vibrant and diverse borough. That it was a great privilege and responsibility to be able to take on the role of Mayor and she sincerely appreciated the trust that her fellow councillors had put in her. She was committed to serving the people of Enfield with enthusiasm and compassion.

The Mayor had grown up the eldest of seven children, two girls and five boys, but her father at a time when girls were not educated, had believed in gender equality and had sent her to school. She thanked her father for this and for enabling her to come such a long way from Nanka, her small town in the state of Anambra in Nigeria, with only 40,000 people.

At this point the King and Queen of her home village, Nanka, entered. They had come from so far away, with their cabinet to celebrate with her. The Mayor welcomed them with a traditional greeting.

The Mayor had served 40 years in the National Health Service at North Middlesex Hospital. As a midwife she had bought many children into the world, many who were now mums and dads themselves. She had valued the support she had been able to give women over these years including women suffering from domestic violence.

Enfield had been a second home to her. She had been widowed when her youngest child was 18 months old, bought up her family of two boys and two girls as a single parent and so had a soft spot for single parents. It was not always easy to keep children honest and on the right path, but she believed that God did not give you what you cannot carry, and she had not given up.

Her father and her husband had supported her in her training to become a nurse and she had been determined to make the best use of her profession. However it was her father who had wanted her to become a nurse, she herself had wanted to be a lawyer, and so once she had achieved his ambition she had later studied for a law degree at the University of North London. This was at the same time as working full time and bringing up her four children.

After completing her degree, although continuing as a midwife, she had used it to help others by working as a shop steward at the hospital. This had eventually led her to becoming a councillor.

As a councillor she had been able to help many people. In 2014-18 she had taken a break from the Council and had set up two groups: a forum for African Caribbean and Asian women and a group to support women into politics. She had also worked with young mothers.

In 2007 the Mayor had been awarded the freedom of the borough and in recognition of her work, the people of Nanka had given her the title of Chieftain. Whenever she visited Nanka she would always encourage them not to leave women behind. She believed that if you educate one woman you can educate the nation. She had wanted to give something back and had travelled widely giving talks about women and their role in society.

During her travels, she had met a councillor from Barking and Dagenham who had inspired her with the idea of introducing a young mayor to represent young people. She was very pleased to have been involved in introducing the appointment of the very first young mayor and young deputy mayor in Enfield.

Finally, the Mayor thanked everyone for coming to the meeting. She said that there was so much happening, and she was concerned that everyone should do the right thing and make Enfield a Better place.

She gave special thanks to Councillor Nesil Caliskan, the Leader of the Council, Ian Davis (Chief Executive) and Jeremy Chambers (Director of Law and Governance) for their belief in her and her ideas.

5 ELECTION OF DEPUTY MAYOR

Councillor Nesil Caliskan proposed and Councillor Joanne Laban seconded the nomination of Councillor Sabri Ozaydin as the new deputy mayor.

Councillor Caliskan welcomed the distinguished guests and said that she was pleased to nominate Sabir Ozaydin, a councillor who had been elected in 2018, had worked to support the people of Turkey Street and had many plans for the future.

Councillor Laban in seconding the nomination hoped that he would have a good year.

AGREED that Councillor Sabri Ozaydin be elected as the Deputy Mayor of the London Borough of Enfield, for the 2019/20 municipal year.

Councillor Ozaydin then made and signed a declaration of acceptance of office and was invested with the badge of office by Councillor Anolue, the new Mayor.

He thanked members for nominating him and said that he would try his best to serve everyone in Enfield and would try to make a difference.

6 APPOINTMENT OF MAYOR'S AND DEPUTY MAYOR'S CONSORTS

1. Appointment of Mayor's Consorts

The Mayor thanked members for nominating her and announced the appointment of Chinelo Anyanwu and Amaechi Anolue as her consorts for the 2019/20 Municipal Year. She then invested them with their badges of office.

2. Appointment of Deputy Mayor's Consorts

The Deputy Mayor announced the appointment of Ozlem Ozaydin and Emre Ozaydin as his consorts for the 2019/20 Municipal year investing them with their badges of office.

7 PRESENTATION OF THE PAST MAYOR AND THE PAST MAYOR'S CONSORT BADGES

The Mayor presented the past Mayor's and Mayor's Consort badges and certificates recording the Council's appreciation to the retiring Mayor, Councillor Saray Karakus, and her consorts Ismet and Destiny Karakus.

The Mayor, on behalf of the Council, thanked them for the work they had undertaken during the 2018/19 municipal year.

The Leader thanked Councillor Karakus for all her incredible hard work over the past year and for the enthusiasm she had bought to the role. She mentioned the 100 years of volunteering event which she had attended with her recently which had been a fantastic event.

Councillor Laban echoed the Leader's thanks saying that Councillor Karakus had been an excellent Mayor. She had particularly appreciated the independence with which she had chaired the Council meetings and the compassion and energy she had shown bringing the community together. She hoped that she would continue with this.

8 PRESENTATION OF YOUNG MAYOR AND YOUNG DEPUTY MAYOR

The Mayor said that it gave her great pleasure to be able to introduce the new Young Mayor, Okan Gurhan and Deputy Young Mayor, Christevie Ngoma to the Council.

She said that it was going to be a great year and that the young mayors should never give up, should work hard and make their parents proud. She would support young people all the way and hoped that the youth parliament would last for ever.

The Mayor congratulated her attendant Gordon Hall who was retiring after 3 years with in the Mayoral office. She said that everyone would miss him and wished him all the best for the future.

The Mayor planned great things for her mayoral year and would be raising funds for several charities. This year she had chosen to support charities in support of sickle cell anaemia, dementia, cancer and the elderly and the retired as her core charities.

Last time she said that she had raised £44,000 which she thought was more than any other mayor. She hoped to beat her own record.
