Police (IP2) Additional (Numbered) Conditions for the Drumsheds licence

The Licence is to be time-limited until Jan 1st 2024

Please find below additional proposed conditions following a meeting with the applicant at Holborn Police Station on Thursday 4th July 2019. The below conditions are in addition to those which have been set out within the application.

The licensable hours for any licence granted will be 08:00 hours until 03:00 hours daily, including all non-standard hours.

The maximum capacity of the premises licence will be 7,000 persons.

The proposed conditions are provided under the following event categories:

Category A

Club Shows (Daytime)
12.00hrs – 23.00hrs

Maximum number of Events per calendar year;

2019 - 6 events
2020 - 16 events
2021 - 18 events
2022 - 18 events
2023 - 18 events

- **1:** All drinks shall only be served in cans or plastic containers. There will be no glassware.
- **2:** A risk assessment and security operational plan (including numbers of SIA door supervisors) shall be undertaken in advance of each event. The risk assessment and security operational plan shall be available to the Licencing Authority upon request and provided to the Metropolitan Police 28 days prior to the event.
- **3:** No tickets shall be sold 'on the door' and must be purchased in advance of the start time of the event.
- **4:** Sale of alcohol to cease 30 minutes prior to the premises closing.
- **5:** The premises will have in place a policy relating to illegal drugs, which will include the requirements to consider vulnerability and safety of people who have taken drugs. The policy should adopt a zero tolerance to illegal drugs (controlled substances) and require any person found to be in possession or

dealing illegal drugs to be ejected and permanently banned from future entry to the premises. There will be clear signage visible on queuing to enter the venue, and within the premises, including the toilet areas. The drugs policy should be clearly displayed on the venue's website and tickets/e-tickets.

- **6:** A Challenge 25 proof of age scheme, shall be operated at the premises.
- **7:** All persons entering or re-entering the premises shall be searched by an SIA trained member of staff and monitored by the premises CCTV system.

Category B (Club Shows)

17:00 hours – 03:00 hours

Maximum number of Events in the following years;

2019 – 0 Events

2020 – 4 events

2021 – 6 Events

2022 – 8 Events

2023 – 10 Events

- **8:** The premises shall have in place a transport management plan for each event, which shall include the provision of a shuttle bus service to be in operation from 24:00, to an appropriate local transport hub. The service should remain in place until dispersal of patrons of the venue.
- **9:** No entry / re-entry to the premises after 01:00
- **10:** A risk assessment and security operational plan (including numbers of SIA door supervisors) shall be undertaken in advance of each event. The risk assessment and security operational plan shall be available to the Licencing Authority upon request and provided to the Metropolitan Police 28 days prior to the event.
- **11:** No tickets shall be sold 'on the door' and must be purchased in advance of the start time of the event.
- **12:** Sale of alcohol to cease 30 minutes prior to the premises closing.
- **13:** The premises will have in place a policy relating to illegal drugs, which will include the requirements to consider vulnerability and safety of people who have taken drugs. The policy should adopt a zero tolerance to illegal drugs (controlled substances) and require any person found to be in possession or dealing illegal drugs to be ejected and permanently banned from future entry to the premises. There will be clear signage visible on queuing to enter the venue, and within the premises, including the toilet areas.

The drugs policy should be clearly displayed on the venue's website and tickets/e-tickets.

- **14:** A Challenge 25 proof of age scheme, shall be operated at the premises.
- **15:** All persons entering or re-entering the premises shall be searched by an SIA trained member of staff and monitored by the premises CCTV system.

Category C

Live Shows

19.00hrs-23.00hrs

Maximum number of Events in the following years;

2019 - 4 events

2020 - 18 events

2021 - 20 events

2022 - 25 events

2023 - 30 events

- **16:** All drinks shall only be served in cans or plastic containers. There will be no glassware.
- **17:** A risk assessment and security operational plan (including numbers of SIA door supervisors) shall be undertaken in advance of each event. The risk assessment and security operational plan shall be available to the Licencing Authority upon request and provided to the Metropolitan Police 28 days prior to the event.
- **18:** No tickets shall be sold 'on the door' and must be purchased in advance of the start time of the event.
- **19:** Sale of alcohol to cease 30 minutes prior to the premises closing.
- **20:** The premises will have in place a policy relating to illegal drugs, which will include the requirements to consider vulnerability and safety of people who have taken drugs. The policy should adopt a zero tolerance to illegal drugs (controlled substances) and require any person found to be in possession or dealing illegal drugs to be ejected and permanently banned from future entry to the premises. There will be clear signage visible on queuing to enter the venue, and within the premises, including the toilet areas. The drugs policy should be clearly displayed on the venue's website and tickets.
- **21:** A Challenge 25 proof of age scheme, shall be operated at the premises.

- **22:** All persons entering or re-entering the premises shall be searched by an SIA trained member of staff and monitored by the premises CCTV system.

In addition Police would ask that the following condition is also agreed –

23: “No licensable activities shall take place under this premises licence if a senior officer of the Metropolitan Police (Inspector rank or above) has indicated in writing to the premises licence holder that due to a clash of events (of whatever description) being held under this premises licence and at Tottenham Hotspur Football Club’s Stadium, in his or her opinion the licensing objectives of crime and disorder, public safety or public nuisance are likely to be seriously undermined by licensable activities taking place under this premises licence over a specified period. No decision shall be made to veto, or limit, such an event or events under this condition unless the police have made reasonable efforts to consult with both the premises licence holder and representatives of Tottenham Hotspur Football Club in order to resolve the potential clash.”
