The Council has a responsibility to provide advice and support and additionally as a key partner, commissioning these services partly on behalf of the Safer and Stronger Communities Board is the most efficient way of ensuring best value and quality and adheres to the Council procurement policies. Additionally, the council has a safeguarding responsibility to provide advice and support to victims of domestic abuse.</p> <p>The resource will also ensure support is provided to those when they are seeking it and safety planning and risk reduction is carried out the earliest opportunity. To do nothing would be an opportunity lost.</p>
