## **BACKGROUND**

1. Breakdown of offences committed within parks situated within Enfield.

01 January 2019 until 31 August 2019

1.1 This report details the breakdown of crimes recorded within parks and green spaces in the borough of Enfield from 01 Jan – 31 Aug 2019. The national crime recording standards are used in order to ensure accurate recording of offences whereby a victim has confirmed that a crime has occurred. Throughout the research conducted, I have identified that there has been a variety of offences committed and these offences include:

Offences against the persons (assaults)

Thefts including robbery

Possession of drugs

Weapons

**Dangerous Dogs** 

Sexual Offences

Criminal Damage

- **1.2** The data is broken down by park location and the number of crimes committed within the review period
- **1.3** These offences have been identified through investigations that have taken place in order to establish any opportunities to identify the suspects involved.
- **1.4** The data has established that the majority of the offenders in the crimes committed are male.
- **1.5** There has been 168 recorded crimes that have taken place within the parks.
- 1.6 There is an increase in crime within the month of July whereby 43 crimes were recorded within parks on the borough. This is believed to be linked to the increase in warm weather and events taking place.

1.7 Officers from the partnership and prevention hub have identified a repeat offender committing crime within Pymmes Park responsible for the majority of crime committed. Officers are now serving a community protection notice on this individual which will prevent him from entering the park in order to reduce the crime in this specific park.
