<p><b>AGREED:</b> that the following decision will come into effect on Wednesday 23 October 2019, subject to not being called in:</p> <p>2.1 That the Portfolio holder approve Enfield’s first Housing Delivery Action Plan (attached at Appendix 1)</p> <p>2.2 Delegate to Executive Director of Place any minor alterations to the Plan prior to publication.</p>							
<b>ALTERNATIVE OPTIONS CONSIDERED</b>							
<p>The alternative is not to adopt the Housing Action Plan. The risk with this option is that the Council will find it harder to demonstrate its proactive approach towards housing delivery and stepping up delivery to the new London Plan target of 1,876. This option is not recommended as proactive measures are required to ensure positive Housing Delivery test (HDT) results.</p>							
<b>REASONS FOR RECOMMENDATIONS</b>							
<p>The results of the HDT require the Council to produce a HAP to identify the challenges and identify actions to help address under-delivery in the borough. The need to deliver more and better homes in the borough is a corporate priority and the Action Plan will allow the Council to monitor its performance across key service areas responsible for housing delivery.</p>
