- 1. To note the initial position of forecast cost pressures of £68.086m; less current grant funding allocation of £17.9m, and capital financing savings of £2m and reserves allocation of £3m; current estimated shortfall in funding of £45.186m.
- 2. To note that officers will be reviewing actual expenditure, income shortfall and the impact on savings programmes in order to update the forecasts on a continuous basis given the ever changing nature of the crisis with regular reports to senior management and Cabinet.
- 3. As a responsible Council, to note that services are working to identify mitigating actions to help address the challenging financial position, including scenario planning in the event of the Government failing to fully fund the Council's Covid-19costs.
- 4. To refer this report to the Overview and Scrutiny Committee for their consideration and scrutiny.
