<p><b>AGREED:</b> subject to not being called in: That the Executive Director - People:</p> <ol style="list-style-type: none"> <li>Approves the contract award to "Contractor A" for the procurement and installation of a temporary mobile classroom and associated works for Oaktree School. <b>ALTERNATIVE OPTIONS CONSIDERED</b>							
<ol style="list-style-type: none"> <li>To do nothing. This would result in a school not having sufficient places for new pupils who are to start school at the beginning of the autumn term 2020. It is the council's legal obligations to provide enough school places, not to do so could result in court action and damage to the council's reputation.</li> <li>There are no other options that will address providing additional teaching accommodation by the beginning of the autumn term.</li> </ol>							

<b>REASONS FOR RECOMMENDATIONS</b>

CMFM and Stace The Borough's Quantity Surveyors have advised that the quotation from Contractor "A" is compliant does not exceed the CCS framework alliance contract prices and is the most economically advantageous tender.</li><li>2. Works will ensure that "the school" have sufficient pupil places during 2020/21.</li></ol>
