DECISION

AGREED subject to no call in being received:

- 1. That approval be given to extend the current SEND Information, Advice & Support Service (IASS) contract between the Council and Every Parent & Child (EPC) for up to one year.
- 2. The current contract delivers a statutory Information, Advice and Support Service for children and young people aged 0-25 years, and their parents/carers. The contract started on 01.09.17 and is due to end on 31.08.20. Following advice from the Council's Procurement and Commissioning Hub, it is proposed that the contract be extended by a term of six months + six months. This will ensure continuity of the service for the children, young people and their families using it, whilst a formal retendering exercise takes place.

ALTERNATIVE OPTIONS CONSIDERED

1. This service must be provided independently of the Council. Tendering the service at this time is considered counterproductive, as the effect of the current pandemic would limit the market.

REASONS FOR RECOMMENDATIONS

Restrictions linked to COVID-19 have prevented an appropriate tender exercise from taking place. The contract extension will allow
for the necessary processes to be followed, whilst also ensuring that the opportunity to tender is accessible to all relevant interested
organisations.

DECISION

AGREED subject to no call in being received:

That the Deputy Leader of the Council agrees that

- 1. The design shown at Appendix A is implemented on a trial basis and the necessary experimental traffic orders made.
- 2.A formal consultation, to follow the previous engagement, is launched shortly after implementation to gather feedback on how the trial is working in practice.
- 3. That delegated authority be given to the Director of Environment & Operational Services to make any appropriate amendments to the trial following feedback and monitoring.
- 4. Following the trial period, a further report for the Deputy Leader is produced to determine whether the trial is made permanent or removed.

ALTERNATIVE OPTIONS CONSIDERED

1. Do Nothing. This is not recommended as this project is a key part of delivering climate change and health & wellbeing objectives.

REASONS FOR RECOMMENDATIONS

- 1. These proposals, which are described at Appendix A, will enable the implementation of a trial of the Fox Lane Quieter Neighbourhood.
- 2. Through this trial, further feedback can be collected as part of a formal consultation process. Additional data can also be collected to determine how the proposals are meeting the design objectives.
- 3. As part of the national response to the Covid-19 pandemic, the Government are encouraging Low Traffic Neighbourhood projects like this proposal to be accelerated. These projects can help lead to a green recovery, enabling more people to walk and cycle is more important as capacity on public transport is suppressed owing to social distancing.
- 4. The proposals will also assist in reducing vehicle speeds, responding to the significant increases that have been identified by the Metropolitan Police across London.
