AGREED: subject to not being called in:

- 1. To approve the allocation of £40.35m from the HRA to fund the development of 150 residential units for the Upton & Raynham scheme as per paragraphs 3-7 of Appendix 3 of the report (containing exempt information). The 12th February 2020 Cabinet report approved an overall budget envelope for the development programme. Each proposed scheme will require a report to approve the budget and scheme. A total budget of £43.5m from the HRA capital programme was identified in the 30-year Business Plan (KD 4969) which Cabinet agreed on 28th January 2020, to fund the development, land purchases and private treaty negotiations associated with the scheme.
- 2. To note that the 150 residential units and 2 commercial units that the scheme will provide represents a reduction from the 174 units that the £43.5m allocation, within the HRA Business Plan, was originally intended to provide.
- 3. To delegate authority to the Director of Housing and Regeneration in consultation with the Executive Director for Resources, for the award of construction work contracts for the demolition and redevelopment of the site, project management and procurement arrangements including operational resourcing, design teams, and appointments for all pre and post contract construction services and the potential submission of a revised planning application.

- 1. To note the significant impact of Covid-19 on the Council's financial position:
 - a) excluding the impact of Covid-19; after the identification of £7.313m savings and income generation being brought to Cabinet for approval in this report, plus a further £2.690m to be considered at December Cabinet the updated budget gap for 2021/22 is £1.715m.
 - b) including the impact of Covid19; the updated budget gap for 2021/22 is £18.117m.
- 2. To note the updated financial position for the medium term.
- 3. To note the early savings of £6.718m and income generation proposals of £0.595m for 2020/21 summarised in paragraphs 49 to 55 of the report and set out in detail in Appendix E of the report.
- 4. To note the refreshed prior year savings in the MTFP in February summarised in paragraphs 46 to 48 of the report and set out in Appendix D of the report.
- 5. There are a number of Covid-19 related financial risks that it is difficult to quantify for the 2021/22 budget and beyond. The timing of the financial settlement means that the Council is faced with needing to make savings to cover unknown or potential risks with unknown funding levels. In this context, Cabinet noted these following risks which are set out in paragraph 40 of the report which have not been quantified in the 2021/22 budget.
- 6. To instruct officers to continue to lobby the Ministry of Housing, Communities and Local Government (MHCLG) for:
- a. Full recompense for all costs borne in responding to the Covid-19 Pandemic;
- b. For an announcement on the 2021/22 settlement for local government at the earliest possible opportunity;
- c. Multi year settlements;
- d. To bring forward Fair Funding and the Business Rate Reset at the earliest opportunity; and
- e. Reform adult social care funding.

DECISION

AGREED subject to no call in being received:

- 1. To approve 21 providers and appoint them to a Framework to provide the 16+ Semi-Independent Living Accommodation Service for Enfield Looked After Children and/or Adolescent & Leaving Care Service Clients aged 16-24. List of organisations is shown within the table provided at the end of this report.
- 2. To authorise entry into all required call-off contract with the respective providers appointed to the Framework Agreement for a duration of 3 years (36 months) and to note that providers may not be used if there is no sufficient demand for the Lots they applied for and can be removed from the Framework during this period if they either (i) cannot fulfil the requirements, (ii) fail to meet the required service standards or (iii) they request to be removed.
- 3. Upon entry into the various Framework Agreements, to authorise the Council to call-off services (in accordance with the Framework rules) on an as and when basis from the respective providers and to enter into subsequent call-off contracts with such providers.

ALTERNATIVE OPTIONS CONSIDERED

- . 1. There are no alternative options to tendering externally, as the Council is unable to provide such an extensive specialist service.
- 2. Providing Accommodation and Support is an obligation under the Leaving Care Act 2000 for those 16 24 year olds, leaving or preparing to leave care and also for those 16 and 17 year olds who are 'looked after children' under section 20 or section 31 Children Act 1989, it is therefore not viable to have no service to all.
- 3. Corporate Procurement have been fully involved in the process and have agree that the Select List model would be best suited to our requirements.

REASONS FOR RECOMMENDATIONS

1. The previous framework has proved to be successful in securing good quality independent supported accommodation services for Young People aged 16 - 24. The proposed Framework will enable us to continue the work already undertaken through the previous framework while allowing us the flexibility to procure from new or specialised providers during the term of the new Framework. The previous framework lapsed on 31st December 2019 and there has been some delay in completing the new tender due to the Coronavirus impacting on all stakeholders.
