**Subject: Purchasing of Equipment – Yorkshire Purchasing Organisation**

### **Purpose of Report**

1. Following market testing, it has been identified that the purchasing of equipment should be made through a purchasing framework in line with the Council's Contract Procedure Rules. The Council spends £1.1 million per annum on community equipment.

The benefit of joining a framework is assured quality and value for money, price and quality matching are key components of a framework There is no guarantee of business, so the Council is not tied into an arrangement which does not work for it.

# Proposal(s)

That the Council participates in the Framework for ['Health and Social Care Equipment, Service and Maintenance – 766'] managed by the Yorkshire Purchasing Organisation (YPO) and, in order to do so, signs an Access Agreement and call-off contracts with individual suppliers on the Framework.

## Reason for Proposal(s)

 Currently the Integrated Community Equipment service does a lot of benchmarking and spot purchase of equipment. While this delivers good value for money, it can be time consuming and labour intensive. The YPO framework operates nationally to deliver economies of scale through mass purchasing.

The framework itself does not require the Council to guarantee a level of business. If the Council can secure equipment of comparable quality at a lower price, then it is free to do so.

# Background

3. YPO was formed as the Yorkshire Purchasing Organisation in 1974 as a joint committee of local authorities, and grew through the 1970s and 80s as schools gained power of their own budgets under the Local Management of Schools provisions of the Education Reform Act 1988. The organisation is unsubsidised and budgets to make a small surplus each year, with profits returned to member authorities and customers.

YPO supplies products and services to a wide range of customers including schools, local authorities, charities, emergency services, public sector and other businesses such as nurseries and care homes. They are 100% publicly owned, by 13 local authorities, which means the profits they make are returned to the public sector customers, delivering even better value for money. They have a large choice available from leading UK suppliers. It claims to be the 'largest formally constituted public sector buying organisation in the UK.

Integrated Community Equipment Service (ICES) procures equipment on behalf of social care and health to value of over one million pounds a year. This includes a range of equipment from hoists, specialised beds and so forth. The service needs to be able to deliver equipment in a timely manner to support discharges from hospital and support service users living in the community.

Currently the service does a lot of benchmarking and spot purchase of equipment. While this delivers good value for money, it can be time consuming and labour intensive. The YPO framework operates nationally to deliver economies of scale through mass purchasing.

The framework itself does not require the Council to guarantee a level of business. If the Council is able to secure equipment of comparable quality at a lower price, then it is free to do so.

#### **Main Considerations for the Council**

4. Given the fact the Council procures equipment on behalf of social care and health to value of over one million pounds a year, it would be prudent to join the YPO framework to provide the assurance we are purchasing equipment of assured quality and value for money. ICES will continue to try and source locally all types of equipment to support the local community. Where this is not possible, the service will keep a clear record of the type of equipment being procured, whether it was available or not and the difference in cost. This information will used to look at whether we can work with potential local suppliers to provide the equipment we require.

# **Financial Implications**

Currently the Council spends approximately £1.1m per year for the procurement of Integrated Community Equipment Service, which is from spot purchasing. The price and quality of different suppliers is compared before placing an order. By joining the Yorkshire Purchasing Organisation Framework (YPO), the Council may be able to obtain lower prices for the same or similar equipment. The Council however is still free to procure community equipment from other suppliers to obtain best value. It is currently not possible to estimate the potential savings of using YPO, however this will be continuously monitored.

# **Legal Implications**

The Council has duties under the Care Act 2014 to provide care and support services to adults who have been assessed as being eligible under the Act. Section 1 of the Local Government (Contracts) Act 1997 provides that every statutory provision that confers a function on the Council shall also confer a power on the Council to enter into contract with a third party to make available the assets or services or both in relation to the discharge of such function.

The procurement of the equipment pursuant to this report must be carried out in accordance with the Council's Constitution, in particular the Contract Procedure Rules ("CPRs") and, where applicable, the Public Contracts Regulations 2015.

The use of a framework is a compliant procurement route provided the purchase orders are placed in accordance with its terms. A due diligence exercise must be carried out by the Procurement and Commissioning Hub prior to calling off from a framework and the Council must be clearly identified as a contracting authority able to use the framework when the framework was set up.

The contract documentation entered into pursuant to the framework must be in a form approved by Legal Serviceson behalf of the Director of Law and Governance.
