17. Good homes in well-connected neighbourhoods

The new contract arrangements will maintain continuity of the waste collection service for the benefit of all Enfield residents. The ability to maintain a high standard of waste collection to households and preserve the public realm will help continue and enhance the position of LBE as a place to invest and as a great place to live.

18. Sustain strong and healthy communities

The new contract arrangements with the NLWA can contribute positively to our strategic goals of making LBE a healthier and greener place by supporting services that can allow people to take greater responsibility for how they manage their waste and encourage recycling, composting and assist with meeting our ambitions for a clean green environment as stated in our Corporate Plan.

19. Build our local economy to create a thriving place

The new contract arrangements support waste collection services to residents which provides local employment opportunities and delivers waste collection to local businesses. The contract should support the delivery of other aspects of environmental works with greater confidence as we know a fundamental tenet of how we manage the environment has been secured. This should benefit our ambitions as expressed in our Corporate Plan and our ambition to preserve heritage, maintain the quality of our parks and green space and contribute to the delivery of an Enfield that is a place to enjoy from childhood to old age.

Climate Action and Climate Conscious

20. Whilst waste has a relatively small impact on carbon emissions, it is a major environmental concern so any improvement in the processing approach will be beneficial.

- 21. LBE currently collects around 20,000 tonnes of dry mixed recycling, 7,900 tonnes of food recycling and 6,700 tonnes of garden recycling.

Soft Market Testing

- 23. A Prior Information Notice (PIN) was placed on London Tenders Portal on the 10th November 2022 inviting potential suppliers to participate in Soft Market Testing (SMT) exercise.

The process consisted of suppliers expressing an interest, after which interested parties were sent a questionnaire to complete concerning Processing, Bulking and Haulage of Dry Mixed Recycling, Garden Waste and Food Waste. A deadline of 5:00pm on Thursday 24th November 2022 for completed responses was set, and no requests to extend this date were received.

Legal Implications

80. The NLWA is established as a statutory joint waste disposal authority under Schedule 1 of the Waste Regulation and Disposal (Authorities) Order 1985. Schedule 1 lists Enfield as one of seven Constituent Councils of the NLWA.

- 81. The Council has a duty to deliver for disposal all waste which is collected by the Council to places that the NLWA directs under section 48(1) of the Environmental Protection Act 1990 (the EPA). This duty does not apply to household waste or commercial waste which the Council has made arrangements for the recycling of under section 48(2) of the EPA. Accordingly, section 48(2) EPA gives the Council, as a waste collection authority, the power to make arrangements for the recycling of household waste or commercial waste in its area.
- 82. In addition, the Council has the power under s.1(1) Localism Act (2011) to do anything individuals generally may do providing it is not prohibited by legislation and subject to Public Law principles. Under s.111 Local Government Act (1972) local authorities may do anything, including incurring expenditure or borrowing which is calculated to facilitate or is conducive or incidental to the discharge of their functions.
- 83. Section 101 of the Local Government Act 1972 (LGA 1972) provides that, subject to any express provision contained in the LGA 1972 or any Act passed after it, a local authority may arrange for the discharge of any of its functions by, among others, any other local authority (except for executive functions).
