**Contracts**

Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority

- a) Under which goods or services are provided or works are to be executed; and
- b) Which has not been fully discharged

**Land**

Any beneficial interest in land which within the area of the relevant authority. Beneficial interest could include land or property which you own, or have a right to occupy (e.g. a tenancy) or receive an income from. This may include your home.

**Corporate Tenancies**

Any tenancy where (to your knowledge)

- (a) The landlord is the relevant authority; and
- (b) The tenant is a body in which the relevant person has a beneficial interest

Any beneficial interest in securities of a body where

- (a) The body (to your knowledge) has a place of business or land in the area of the relevant authority; and
- (b) Either
  - (i) The total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
  - (ii) If the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class
